2010 Club Registration Procedures

To confirm your club's protection offered by the National Risk Protection Programme ("The Programme"), please complete the steps below:

STEP 1: REGISTER YOUR CLUB

All clubs are required to re-register annually for the new policy period of the Programme.

Club and team details must be recorded on the JLT Sport web site.

Please use the following instructions as a guide when registering your club:

1. Type www.jltsport.com.au in your Internet Explorer address field and press ENTER, then select the AFL link under "JLT Sport Programmes"





OR

Type www.jltsport.com.au/afl in your Internet Explorer address field and press ENTER, this will take you directly to the Programme's web site.




2. Select "Club Registration" from the Menu Options along the top of your screen.




3. Type your club name, or part of your club name, into the "Club" field below. Click "Search"; or Select the State and Association that your club is affiliated with from the drop down menus. Click "Search". Please note – VCFL clubs need to select 'Victorian Country Football League'



4. Find your Club from the list that appears. Click "Please Register".



5. If your club has already completed Registration, it will say 'Registered'. For privacy reasons, you cannot view this information. If you have a query regarding your clubs details or you need to update any information please contact JLT Sport directly on 1300 130 373.



Clubs who have already completed Registration will also have the option to 'Repeat' the Risk Management Training or 'Download' the club's Certificate of Currency.

These options will only appear if you have already registered your club for Season 2010.

6. When you have reached the main registration page, you will be required to enter information into each field. Please note, all fields marked with an asterisk (*) are mandatory fields and must be completed. When all fields are completed click "Proceed to Risk Management".



STEP 2: RISK MANAGEMENT TRAINING MODULE

In order to complete your club's registration for The Programme, you must complete the compulsory Risk Management Training Module.

Please use the following instructions as a guide to complete the Risk Management Training Module:

1. Read through the Risk Management Training Module information carefully. The information is separated into 5 different categories.




2. Please proceed through each section of the training module by clicking "Next" at the end of each section.



3. At the end of the Risk Management Information you will be asked to complete the compulsory Risk Management Questionnaire. The questionnaire is made up of 10 multiple choice questions.



4. When you have completed the Risk Management Questionnaire please continue to the results page by clicking "Proceed".




5. The results page will confirm your results. If you scored less than 50% you will be required to resubmit the Questionnaire.



6. If you scored more than 50%, CONGRATULATIONS you have successfully completed your club's registration for Season 2010.



7. You will now be able to access your club's 2009/2010 Certificate of Currency by clicking "Continue to Certificate of Currency".
