PRESIDENT'S REPORT

After a successful 2009 season, the Storm approached the 2010 season with a degree of anticipation for both the football and netball sides.

With Clint and Nic again reappointed as coaches of the seniors and reserves football teams, senior and reserves football in 2010 was about building on the solid base that was laid during our inaugural season. At one stage during the season our senior and reserves sides were right in the mix of making finals in our short existence, with the Reserves managing to win five consecutive games, whilst the seniors were able to string a hat-trick of wins together. Unfortunately both sides suffered losses towards the end of the home and away season which were critical to the final make up of the top five ladder positions. Whilst the seniors and reserves were bitterly disappointed in their final ladder positions, players from both grades can hold their head up high, as they represented the club throughout the way in a professional and competitive manner, in which opposition teams are now respecting. With the seniors posting a credible 6 wins for their second season of competition, highlights the fact that the club is moving in the right direction.

During the pre-season he club welcomed Glen Cowling to the position of coach of the Under 18 footballers. With our first crop of under 16's coming through to the under 18 ranks, it was pleasing to see our Under 18 side were the stand out for the football side, with the boys making the preliminary final, and for the first time we had a league award winner with Lachlan Bonney winning the league goal kicking.

The offseason also saw a change to key personnel in netball. Jody Warfe was appointed senior netball coach, taking charge of the A, A Res and B Grade teams whilst the club welcomed Steve Tyzer as coach of the Under 17 side. Our netballers again displayed great competitiveness with the A Reserve and B grades making the finals. Whilst the B Grade made the first semi, our A Reserve side displayed some excellent form, making the grand final after an upset win against netball powerhouse Sandhurst. Our A Reserve were unable to secure the club's first BFNL premiership falling short to Kangaroo Flat at the last hurdle.

All in all, the footballers and netballers certainly produced some excellent results for the season and I look forward to continued improvement in the 2011 season.

Both Cameron Hall and Kristen Wilson were named best and fairest winners in the Senior football and A Grade netball respectively for their second consecutive season. To our other best & fairest winners Dale Cameron (Reserves), Lisa Evans (A Reserve), Collene Johns (B Grade), Daniel Hamilton (U18's) and Jarni Hansen (U17's) I congratulate you in winning these awards, along with all our other award winners.

VALE—PETER CRAPPER

During the 2010 season, the Strathfieldsaye Football and Netball Club fraternity mourned the sudden passing of Peter Crapper.

Affectionately known as "Snake" to close friends and relatives, Peter passed away suddenly on Thursday 22nd July. Peter was an instrumental member to the formation of the Strathfieldsaye Football & Netball Club.

Pete's input into the formation of the Strath Storm can be traced back to 2001 when he was an inaugural member of a working party that looked into the improving facilities in Strathfieldsaye.

The working party was the impetus for the development of the Strathfieldsaye Recreation Reserve and complex at Tannery Lane, home of the Strath Storm. Leading up to the development of the Senior and Netball Club, Peter chaired separate discussions between the Strathfieldsaye Junior Football Club and Mt Pleasant, Sandhurst and Sth Bendigo football clubs when those clubs were considering amalgamating with the Strathfieldsaye Junior football Club.

Club President Ray Patterson paid tribute to Peter's dedication to the club. "If you ever needed a hand, Pete was always there and he and his wife Kaye were instrumental for their work in the canteen". "There was no job too big or small for Pete...he just embodied everything about a football club. He was one of those blokes who didn't want the pats on the back, he just got in and got the job done. He was really an unsung hero."

As well as his work with the Storm, Peter was a life member of the Strathfieldsaye Junior Football Club where he was a long time committee member.

In addition to this, Peter was also a board member on the successful Strathfieldsaye & District Community Enterprise. A well respected Strathfieldsaye community member, Peter will be sorely missed by the community that he loved.

Peter is survived by wife Kaye, sons Rhys and Liam, and daughter Megan—all have been involved with the Strath Storm. The committee, members, players and supporters of the Strathfieldsaye FNC extends its deepest sympathy to Kaye, Rhys, Liam and Megan.

FOOTBALL OPERATIONS

The Storm started the year in a positive frame of mind, having had a reasonable inaugural season. Everyone was keen to build on what was achieved in season 2009. In season 2010 we welcomed the following recruits coming to the club in Cam Ross, Ben Sullivan, Matt Rice, Marc Millard and Brodie Rogers - things were looking up.

However an interrupted pre-season meant a sluggish start to the season was probable. As it turned out we did start slow and also suffered a couple of losses to perennial finalists Gisborne and South Bendigo in games that we should have won. Add to that long term injuries, to some key players and suddenly we were back in the pack at the lower part of the ladder.

The mid point of the season saw us hit our straps with three consecutive wins for the first time in the seniors, and suddenly we were knocking on the door of the top five. With the Reserves sitting in the five and the U18's cemented well in the top three, the club was looking for a strong finish to the season. This optimism was shortly lived however, as we finished playing against the top teams and both the Seniors and Reserves fell just short of their first finals appearance. It was left to the U18's to fly the flag in the finals, and they did so with great success, reaching the Preliminary final. If a little luck fell their way in the preliminary final, they may well have played off in the big one.

In all it was a successful season with the senior group recording six wins which was an improvement on our first season. Our reserves also improved on their inaugural season, recording 8 wins in 2010. If we continue to improve at that rate, finals are not out of the question in 2011 for both the seniors and reserves. The completion of the season saw the premature retirement of Ryan Pedrotti as Assistant Coach and player. The club wishes Ryan and Suzie all the best for the future and we thank them for their contribution. 2011 will also see a change of Senior Coach. Clint Whitsed will remain at the club in a playing capacity which will be invaluable to our young group. Whits has done a fantastic job for us in our first two years and the seniors would not be where it is without his contribution. The club would like to thank Clint and his wife Haidee for their dedication and support to the club. All at Strath Storm hope to continue to see you both around the club in the future.

As soon as the 2010 season had concluded, the Storm wasted no time in appointing a new coach for 2011. After a thorough selection process, prominent and respected coach Darryl Wilson was appointed to lead the team through the next phase of our short history. The appointment has been received well by the players and community and the future looks bright for next season and beyond. See you in the preseason!

I would like to take this opportunity to thank all of the team managers, runners, time keepers, trainers and support crew for all of your assistance to the three grades of football during the season. To the running of messages in pouring rain to the strapping of the ankles and shoulders pre game, and the icing of injuries post game - the boys certainly appreciate all of your efforts.

TREASURER'S REPORT

As treasurer of the Strathfieldsaye Football & Netball Club, I am pleased to report to members that the club has again successfully recorded an operating profit of \$3,426 for the year ending 30 September 2010. Whilst the result is a modest result in dollar terms, it is pleasing to note that the club is self sufficient in only its second year of full operation.

As shown in enclosed financial report, the club was able to generate total revenue of \$252,356 for the financial year. Members will note in the financials, that our gameday revenue for 2010 amounted to \$68,615, compared to 2009 level of \$97,669. This decrease in revenue is primarily due to the abnormal patronage that was experienced in our historical round 1 match in 2009, whereby approximately 3,000 patrons witnessed our very first match. This strong patronage in round 1 2009, resulted in abnormally higher gameday revenues being received in 2009. Gameday revenue in 2010 reflects a more accurate year of gameday operation. Growth in other revenue of clubs operations which includes memberships, sponsorship and functions increased by approximately 3% to \$183,741.

Total club expenditure of \$248,930 in 2010, decreased by approximately \$22,500, when compared to the previous year. This decrease is partly attributed to the lower overhead costs and gameday expenses that were required in our second season of competition. Savings by the club were achieved in all three expense categories being: Administration, Gameday and Marketing and Sponsorship.

Included in the club's administration expenditure of \$76,672, is capital contributions totalling \$13,700. Members would have noticed during the early parts of the season, new aluminium seating that was installed around the main football oval, netball courts and along the grandstand. This seating was fully contributed by the football and netball club for the benefit of our members and supporters. In addition the club has supplied a fully functional audio and visual entertainment system in the social dining room, as well as further contributing towards the completion of the storage sheds that are located next to the cricket nets. Once again the Strathfieldsaye Football & Netball Club Inc. is grateful in the financial support that it has received during the year from the Strathfieldsaye & District Community Enterprise, that has enabled the club to provide additional infrastructure at the Strathfieldsaye Recreation Reserve. The Strathfieldsaye Football & Netball Club appreciates the continued support provided by the Strathfieldsaye & Districts Community Enterprise committee.

Once again the club was able to generate strong sponsorship revenue for the 2009/10 financial year. This remarkable feat was tirelessly co-ordinated through our Sponsorship co-ordinator Mick Cumming. I would like to thank Mick for his efforts during the season for his combined roles, which included the successful bar operations for the club as well as servicing our sponsors. The club conducted a successful "sponsors day" during our home match against Maryborough which was well attended by our sponsors. This year the club was able to secure our first ever football playing apparel sponsors in Red Rooster Bendigo. This three year arrangement was only made possible through our strong relationship with local Red Rooster franchisee's Corey and Natasha Prendergast. To our sponsors I personally would like to thank the wiliness of your organisation to financially support our newly established club, with special mention to our premier partner in Strathfieldsaye IGA.

Whilst a downturn in membership was anticipated in our second season of operation, the club was fortunate in securing a solid membership base in 2010. The strong result was achieved through the tremendous work of Carmel Cumming. At season's end, the Strathfieldsaye Football & Netball Club had in excess of 350 members—making the Club still one of the strongest Not for Profit sporting organisations in Central Victoria. To Carmel, I thank you for continuation in providing a high level of professional and service to our members. To our members, I thank you for your continued financial contribution to the club in season 2010. The Club's Membership sub committee will again look at ways of improving our membership packages for season 2011. in which I encourage all of you to remain members and to enjoy the extended benefits on offer in season 2011.

In closing this treasurer's report, I wish to thank my fellow executives and committee members for their support and assistance provided to me during the 2009/10 year. It is with a tinge of sadness that I wish to advise members that due to current work commitments, I will stepping down as Club treasurer at tonight's AGM.

I would to take this opportunity to thank the many Storm members and supporters who have believed in the club over the past 3 years. It has been an honour and a privilege to have been given the opportunity to share this incredible journey with you!

NOTES TO THE FINANCIAL STATEMENTS FOR THE YEAR ENDED 30 SEPTEMBER 2010

Note 1: Statement of Significant Accounting Policies

Strathfieldsaye Football & Netball Club Inc. is an Association incorporated in Victoria under the Associations Incorporation Act 1981. The financial report covers Strathfieldsaye Football & Netball Club Inc. as an individual entity.

The financial report is a general purpose financial report that has been prepared in accordance with Accounting Standards, Australian Accounting Interpretations, and the Associations Incorporation Act Victoria.

The accounting policies have been consistently applied, unless otherwise stated.

Australian Accounting Standards set out accounting policies that the AASB has concluded would result in a financial report containing relevant and reliable information about transactions, events and conditions to which they apply. Compliance with Australian Accounting Standards ensures that the financial statements and notes also comply with International Financial Reporting Standards. Material accounting policies adopted in the preparation of this financial report are presented below and have been consistently applied unless otherwise stated.

The financial report has been prepared on a cash basis and is based on historical costs, modified where applicable by the measurement at fair value of selected non-current assets, financial assets and financial liabilities.

a. Income Tax

Strathfieldsaye Football & Netball Club is exempt from income tax under Section 50-45 of the Income Tax Assessment Act 1997.

b. Inventories

Inventories are measured at the lower of cost and net realisable value. Costs are assigned on the basis of weighted average costs.

c. Cash and Cash Equivalents

Cash and cash equivalents include cash on hand, deposits held at-call with banks, other short-term highly liquid investments with original maturities of three months or less, and bank overdrafts.

d. Comparative Figures

When required by Accounting Standards, comparative figures have been adjusted to conform to changes in presentation for the current financial year.

e. The financial report was authorised for issue on 19th November 2010.


