The Club Presidents will deal with higher level issues such as the structure of the competition and Constitutional matters. Feedback from Presidents. Due to the minimal notice given to Club Presidents about attending the Board Meeting there was no feedback about the Boards progress. Status of Player and Coach Development. 	
		RT advised that a sub-committee is to be set-up for both coach and player development. Grass roots coaches required for this committee, not only elite coaches. Minimal documentation exists in the way of development programs. Clear pathways to be created for development with structured interaction between BNT and DBA. 6. Status of Cas Club & Infrastructure, specifically Canteen, lead RB. RB advised that Cas Club sponsorship can be increased by DBA members using the club. Every time a DBA member swipes in to the Cas Club it attracts more funds for the Association. RB & LS to investigate whether Cas Club membership cards can be made up on sign on day. RB advised Club Presidents that the canteen progress is slow as contractors are doing work at cost or voluntarily to reduce costs. 	 Status of Governance, lead AC. AC informed Club Presidents that the Constitution was being reviewed in conjunction with BA. A Special General Meeting will be held to ratify changes to Constitution. One change identified was that players would be members of their clubs and not members of DBA. Players would still be registered players of the DBA. Individual teams may nominate and pay an affiliation fee if they wish to have voting rights at the AGM. AC has arranged for SAFE NT who are responsible for the issue of Ochre Cards (Adults working with children) to come to DBA Sign-up day and take photographs and details of coaches etc to enable supply by March 2011. Status of Media/Communications/Sponsorship, lead DD. DD reported that current media commitments on the radio were going well with Jason Ivinson doing the reporting. There are new Sports people in place at the NT News and now at Channel Nine who DBA are in contact with. DBA Website has been updated with a new structure – more to come. DD has been in touch with sponsors. John Culbertson advised that we should get in touch with McDonalds Corporate as they are big sponsors of Junior Basketball down south.
