2. VENUE AND TIME OF PLAY

Western Australian Basketball Centre, 106 Stephenson Avenue, Mt Claremont WA 6018

All Associations should expect play to commence at approximately 7.30am-8.00am on Saturday and Sunday. Times are approximate depending on team nominations. Presentations will take place at approximately 1.30pm on Sunday.

3. ELIGIBILITY AND PLAYER REGISTRATION

Carnival is open to all affiliated Associations which are fully financial.
All BWA Registration and Affiliation Fees must be paid prior to the Championships.

Associations will be required to register the name, date of birth and address of each individual player on the Sporting Pulse website <http://reg.sportingpulse.com> prior to 5.00pm on the Wednesday before the competition. Information regarding the process will be sent to team contacts when team nominations are received.

All coaches and managers will be required to have a Working with Children Card. WA Legislation makes this mandatory. The coach and manager must be in possession of the card at all times during the Championships.

4. GRADES

Players must be Under Age at 31st December 2012.

Initial divisions will be posted early in December and open for comment via email for a period of two weeks. Comments must be made in writing with supporting evidence. After this time division placing will close and the Community Basketball Administrator will have sole discretion.

5. FEES

NOMINATION \$150 PER TEAM (Inc gst)

Nominations close at 5.00pm Wednesday 14 December 2011.

An early-bird registration discount of \$100 is available to all teams who register, provide team details and pay prior to 5.00pm on Friday 9 December 2011.

Each Affiliated association is able to nominate at least one team per age division. Additional Teams will be placed on a waiting list and entered into the Competition at the discretion of the BWA Country Commission.

FAILURE TO PAY NOMINATION FEE, AND PROVIDE ALL INFORMATION WILL RESULT IN TEAMS BEING WITHDRAWN FROM THE COMPETITION.

6. PERTH CONTACT

Associations must advise the Perth address, telephone number and name of the Team Manager whilst participating in the championships, as per Championship Rules. Please refer enclosed team nomination form.

7. DUTIES

a) Bench Personnel

A representative from each team must be present on the bench during the full term of play. Failure to fulfil this duty will result in a \$25 fine per missing bench personnel per game.

b) Referees

Associations are reminded that this is a Country Championship and therefore must use Country based officials. Persons who umpire in your local competition should be encouraged to attend. If not you will be fined \$200 per offence.

Teams will be required to supply one referee of a suitable standard for all games in which they participate. Non appearance of any nominated referee at the time and the court rostered may result in the team concerned being eliminated from the competition. A fine of \$75 per offence will be levied.

The name of the referee must be supplied for each nominated team and submissions received without a named referee will be subject to rejection.

Referee Evaluators will be available during the championships for referees requiring on-court assessments, evaluations or assistance.

Referees Dress Code

It is the responsibility of the Associations/teams to ensure referees are attired correctly. Basketball WA will provide Green shirts for all referees.

Preferred dress is black pants/shorts and shirt provided by BWA.

Minimum dress is black trousers/slacks and shirt provided by BWA.

Teams may be fined for referees not in correct attire.

8. BASKETBALLS

Teams are required to supply their own basketballs during the Championships. Ball sizes to be based on Basketball Australia rules as follows.

73cm (29") - Size 6 will be used for Under 13, 14 girls and boys

73cm (29") - Size 6 will be used for Under 15, 16, 18 girls.

75cm (30") - Size 7 will be used for Under 15, 16, 18 boys.

Minimum Standard Basketball: Molten Official GF

9. MOUTH GUARDS

All players will be required to wear mouthguards. If a player is not wearing a mouthguard, that player will not participate, and will leave the court immediately.

10. DOOR CHARGES

The following represents the daily entry charge

Entry fee	\$6.00 per day
Family Pass	\$20.00 (Limit of 5 persons per ticket; 2 adults and 3 children)

11. TROPHIES

Will be presented as follows:

- a) Individual
 - Pennants or medallions for members of all premiership teams
 - All Star team selected from each division in each age group
- b) Team
 - Premier and runner up trophies in each division.

12. WITHDRAWALS

Teams withdrawing must advise within the specified time as set out in BWA Country Championship Rules.

Fines apply for late withdrawals. There will be no refund of nomination payments.

13. ENCLOSURES

14. FORMS

All forms must be completed and accompanied with a cheque to cover the nomination fees.
