## **Terms and Conditions of Participation**

I declare that I have read and agree to be bound by the conditions of registration below and that the details provided on the registration form are, to the best of my knowledge true and correct.

#### **Definitions:**

For the purpose of these Terms and Conditions the following words are defined as follows:

Australian Football Bodies mean all bodies in Australia that are responsible for administering the game of Australian Football including those at the grassroots level and the national level;

Club means the club for which the player is registering to play;

League means the League in which the Club is a member;

Player means the person who has registered on this form or the person, on whose behalf, a parent or guardian is registering.

#### Rules, Regulations and Policies

By agreeing to these Terms of Participation the Player:

- a) agrees to be bound by the Rules, Regulations and Policies of the Club, the League and the Laws of Australian Football, as they are presently constituted and as amended from time to time including the AFL de-registration policy.
- b) Acknowledges that his or her failure to adhere to the Rules, Regulations and Policies of either of the Club or League or the Laws of Australian Football, may result in him or her being de-registered.
- c) Acknowledges that he or she may inspect copies of the Rules, Regulations, Policies and Laws of Australian Football upon request to any of the relevant Australian Football Bodies.

## **Assumption of Risk**

By agreeing to the conditions set out in this Registration Application, the Player acknowledges and agrees that:

- a) Australian Football is a body contact sport in which physical injury may occur from time to time;
- b) He or she is none the less desirous of playing Australian Football for the Club; and
- c) He or she takes upon himself or herself the risk (both physical and legal) of injury arising in the course of training for and participating in the game of Australian Football.

### Limitation of Liability and Release

The player acknowledges and agrees that:

- a) By accepting to bear the inherent risks of playing Australian Football, he or she will not bring any claim or proceeding against the Australian Football Bodies for any damage, loss or injury whatsoever that he or she may suffer from participation game.
- b) The Australian Football Bodies' liability to you is limited to your Club or League supplying or resupplying any services to which you are entitled in accordance with the terms of this Agreement.
- c) You understand that as a registered player participating in an AFL Football competition you may be entitled to certain Sports Injury Insurance benefits subject to your Australian Football Bodies' level of cover.

#### **Photographs**

You consent to your Club and League using your name or image (including photograph) in any form or medium for general marketing and promotional activities.

## Registration of Players Under 18 Years of Age

Where the Player is under 18 years of age, by completing this Registration Application, the Parent or Guardian of the Player:

- a) Acknowledges that he or she has read and explained the contents of this Registration Application to the Player.
- b) He or she consents to the Player playing subject to the Terms and Conditions in this Registration Application.
- c) Declares that the statements made in the Registration Application are to the best of his or her knowledge and belief true and correct.
