- 6.1. SANFL Level 1 Coaches Course, information emailed to clubs, courses being held on the Eyre Peninsula starting from 31 March in Port Lincoln. Level 1 is a requirement needed to coach in any SANFL Affiliated league, all club coaches must be at least Level 1 accredited before starting to coach in their 2nd year.

7. Presidents Report

MAC/SAPOL Safe Driving Seminar

Held a meeting with Andrew Taheny. The Safe Driving Seminars are run on a 3 year cycle. Each year, 2 clubs hold a seminar and there must be at least 25 people in attendance. This year, Central Eyre will hold the seminar on Thursday 19 June. (Booking form provided to Central Eyre which needs to be filled out and emailed to Jan Day). Wirrulla will hold the 2nd seminar, dates are yet to be worked out.

Mortlock Shield

Attended the 2014 Annual General Meeting on Sunday 16 March. Discussion held regarding covering the costs of accommodation, meals and transport. We usually receive approximately \$3,000 back. Life membership of the Mortlock Shield was awarded to Ryan Dubois. Program has been revised to accommodate Kangaroo Island. Revised program has been emailed to clubs. Port Lincoln Umpires Committee requested that each league supply a field, goal and boundary umpire for this year's championships. The motion to supply the umpires from each league lapsed, it was decided that each league will need to discuss options of supplying umpires and then speak with the Regional Umpiring Manager.

Umpires

All umpires require accreditation, there is a 40 minute online accreditation available. Peter to provide link for accreditation. Umpires kits are available through the website for \$35.

8. General Business

8.1. Football Budget

Request received from Western Zone who sponsor Junior football to place advert in the Football Budget, Peter will provide more information about advert.

8.2 MWFL By Laws

The following proposed By Law changes were raised at the AGM of 2012 as a result of a memo sent from Peter Cock. The suggestion was circulated ready for adoption, but no resolution could be located.

1. Colts Overage Qualifications and Playing Conditions

Currently

21 JUNIOR LEAGUE PLAYING QUALIFICATIONS

- (a) All members of the "colts" team shall be under the age of 16 on the first day of January in each season.
- (b) All Junior teams shall come under the jurisdiction of the League as a sub-committee known as the Mid West Colts League.
- (c) All members of "mini colts" teams shall be under the age of 12 on the first day of January in each season.

Propose to amend clause to the following:-

21 JUNIOR LEAGUE PLAYING QUALIFICATIONS

- (a) All members of the "colts" team shall be under the age of 16 on the first day of January in each season.
- (b) All members of "mini colts" teams shall be under the age of 12 on the first day of January in each season.

All Junior League teams shall come under the jurisdiction of the League.

21 (1) Special Exemption for Over age Players (under 16 only)

It is recognized that in some instances, players may not be considered ready to proceed to play senior football (physical size, experience and general ability). To retain these players in the game, the MWFL may grant eligibility to play as an over age player in the under 16 competition.

Application for the granting of an "over age" exemption to allow a player must be made by the players club in writing for assessment by the MWFL.

Qualification for over age players shall be as follows:-

- Players may only be in their first year out of Colts competition, in that they must be under the age of 17 as at 1 January in the year to be played;
- Reasons for over age status sought must be stated in the application;

The purpose of this rule is to retain players within the game, with the hope that they will be able to progress to play senior football in future. This is not to be used as a measure to strengthen a Colts side. The MWFL shall retain the power to revoke an over age exemption at any time should it be considered that the over age player should more appropriately play senior football.

- 21 (2) Over Age Players Playing Conditions
 - Players must wear a yellow arm band when playing in the under 16 competition;
 - Players shall be ineligible to receive votes in the League Best and Fairest medals in the colts competition;
 - The Team Manager must mark "over age" against the players name on the team sheet submitted on match days

21 (3) Over Age Players – Special Conditions

An over age player shall have the eligible over age status automatically revoked as follows:-

- The player is sent off with either a yellow or red card during any match;
- The player is reported and found guilty of any offense;
- The player plays a game of A grade football;
- The player plays 3 games of B grade football

The over age player shall be eligible to play finals whilst over age qualification is retained.

21 (4) Over Age Players – Review

The MWFL shall conduct a review of all players with over age status at the completion of round one to determine whether the over age status is appropriate. The over age status may be revoked at any time by the MWFL.

2. Colts Playing Conditions

<u>Currently</u>

There is no current By Law pertaining to special playing conditions of the Colts games. A 10 goal rule has been trialed by the MWFL Colts Committee, and therefore has been recommended for adoption.

Proposed

Re number clauses and insert as clause 22

- 22 COLTS COMPETITION CONDITIONS (Under 16 matches)
 - Minor rounds games shall be four (4) quarters each 20 minutes duration with no provision for time on except in special circumstances as directed by the Central Umpire (major injury or disruption);

- (b) Major Round (finals) matches shall be the first two quarters of 20 minutes duration, and the second two quarters of 20 minutes plus time on duration; <u>Minor Round Matches Only</u>
- (c) If at half time or three quarter time there is a 60 point or higher margin in the game, the match should be discontinued and teams evened up at that point. This may be by merging teams or removing players from the ground at the coach's discretion. At this point:-
 - Central Umpires are to award Lockwood medal votes
 - League Recorder is to award Premiership Points and Percentage

Note: This rule applies only to minor round matches, not finals matches

Colts coaches are encouraged to communicate with opposition coaches to ensure that matches are as even as possible after the application of these rules.

Amend clause 21 as proposed and insert clause 22 as proposed into MWFL By Laws.
