2008 has proven yet again to be a successful year both on and off the field.

At the beginning of the season we budgeted to be able to commit an amount of \$50,000 toward the refurbishment of the sports & social club, understanding that the amount of work needed to be undertaken would require more funds than what had been allocated.

I am pleased to report that, (subject to committee approval) we have sufficient funds to be able to commit a total of \$ 62,500 toward the refurbishment still allowing \$ 10,000 to be retained in to next year to cover operational expenditure.

An outstanding result to all concerned.

Whilst it is difficult to single out exemplary efforts as there are so many, special mention should be made to the efforts of Jo and Alby Charity and all of the people involved in the canteen, the result of the canteen being almost double that of last season.

To Peter Steele for his work on the 100 club - as usual the effort and accuracy of his books was outstanding.

The amount of funds brought in from the downhill together with the barbecue monies obtained through the sterling efforts of Dean Richardson have exceeded all expectations.

Finally the work of Neil Lang, Derek and all of their support people has resulted in a stellar result from the bar. Whilst the figures don't truly reflect the magnitude of these guys efforts (for reasons that Gerry will explain) the contribution to the overall financial viability of the club by the bar is the best on record.

Finally if the club would have me, it would give me great pleasure to stand again as treasurer, as it will enable me to become the longest serving treasurer in so doing I will be able to sit beside the club's longest serving secretary and with an extra-ordinary president. In so doing we may retain what hopefully the membership considers, to be a stable and competent executive.
