Changes to By-Laws relating to the adopted minute items 3.5 and 10.5 from the 23 February 2015 meeting:

### **Currently:**

24. TEAM FORMS AND NINETEENTH AND TWENTIETH MEN.

- (a) In every match a list of 20 players, with their respective numbers, shall be exchanged by Officials of the opposing Clubs and only the players mentioned in such list shall be qualified to play. A copy of each list shall be handed to the Field Umpire, League Secretary and Club Officials before the start of the match, to be kept by them when necessary for identification purposes when a charge is laid.
- (b) The 19th and 20th men must be on the ground in uniform to play and must remain so ready until the conclusion of the match and must be identified on the team sheet.
- (c) The 19th and 20th men shall be available for use at the discretion of his captain and or coach, as a substitute player at any time during the match providing that, if either player is used an interchange the opposition bench is notified and the players concerned make their entrance and departure from the playing area through the designated area, otherwise they will not be permitted to take any further part in that particular game.
- (d) The A Grade team may consist of 21 players with the one (1) player being under sixteen (16).in terms of the qualification for "Colts" in By Law 21

### That the By Laws be amended to:

24. TEAM FORMS, PLAYING CONDITIONS AND INTERCHANGE.

- (a) In every match a list of 20 players, with their respective numbers, shall be exchanged by Officials of the opposing Clubs and only the players mentioned in such list shall be qualified to play. A copy of each list shall be handed to the Field Umpire, League Secretary and Club Officials before the start of the match, to be kept by them when necessary for identification purposes when a charge is laid.
- (b) The A and B Grade team may consist of 21 players with the one (1) player being under sixteen (16).in terms of the qualification for "Colts" in By Law 21
- (c) All named interchange players must be at the ground in uniform to play and must remain so ready until the conclusion of the match and must be identified on the team sheet.
- (d) The interchange players shall be available for use at the discretion of the coach (or delegate) and/or captain as a substitute player at any time during the match providing that, if either player is used an interchange the players concerned make their entrance and departure from the playing area through the designated area in view of the opposition. Failure to use the designated entrance and departure area shall mean that the player will not be permitted to take any further part in that particular game.
- (e) In the event of a blood rule player interchange at the request of the field umpire when the match has been halted for this purpose, the field umpires shall instruct that the replacement player enter the playing arena simultaneously to the player exiting the oval to expedite resumption of play as soon as possible. The designated entrance and departure area should be used in all instances in terms of 24 (d);
- (f) **Should a club forfeit the B Grade match**, in the interests of providing a game to as many players as possible, the following special match conditions of playing numbers shall apply-:
  - 1. Upon agreement with coaches and captains of the competing clubs up to twenty five players may be used, of which at least one must be under sixteen (16) in terms of 24 (b);
  - 2. In the event that the player numbers are increased under this By Law, both sides shall play with the same number of players if it is agreed to exceed the twenty one (21) players allowed under By Law 24 (b);

- 3. The fact that this By Law has been enacted shall be noted on the team sheet and signed by both club Team Managers under advice to the Field Umpires and League.
- 4. This By Law shall not apply in finals matches.

3.4 Revisit By Law 2A(b) that was deleted as per MWFL Minute – AGM 3 November 2014 Item 3.1: That By-Law 2.A (b) be deleted:

2.A QUALIFICATIONS OF PLAYERS

(b) For the purposes of these regulations the district of each Club shall be the area within a radius of sixty kilometers of the home ground of the Club. Clubs using two (2) home grounds the sixty kilometers will be from a point midway between those two (2) grounds.

## **Currently:**

2. PLAYER REGISTRATION AND PERMIT TO PLAY

- (a) Club Secretaries shall register their respective players each season with the League Secretary 14 days prior to the season commencement.
- (b) A player seeking registration with a Club for the first time or not included on the preseason registration must sign the prescribed form provided by the League Secretary. He then remains a player of the Club for the subsequent seasons unless cleared by the said Club.
- (c) The Secretary of the League shall keep a register of the persons who have obtained registration and a permit to play.
- No permit shall be granted to a player whose clearance has not been lodged on or before the 30th June in any one season, except as provided for in the Affiliated Leagues Charter.
  Provided a clearance has been lodged prior to the 30th June in any one season, a permit may be granted up to and including the 27th of July in any one season)

# 2.A QUALIFICATIONS OF PLAYERS

- (a) Subject to By-Laws 2A (d) and (e), a player shall not be registered by a club nor be qualified to play for a team in any Football competition conducted by the League unless he is a bona fide resident in the district of the Club with which he desires to be registered or has been granted a permit by the Permit Committee to be registered with that Club.
- (b) For purposes of these Regulations a bona fide resident is a person who ordinarily or generally resides in premises situated in the district of a Club, which is owned or occupied by him, or is a full time student whose natural or adoptive parents ordinarily or generally reside in premises within such district.
- (c) Each Club is entitled to play no more than eight (8) registered player or players who reside outside the district of that Club on any one day in the A Grade.
  NOTE: B Grade is exempt from 2A (d).
- (d) A Club may, subject to it obtaining a permit from the Permit Committee, but not otherwise, register as a senior player or players of the Club, a number in excess of eight (8) persons who reside outside the district of that Club.
- (e) A Club and/or League Executive may apply to the Permit Committee and may have granted to a person enabling him to be registered as a player of another Club. An application for revocation of a permit must be in writing and must state the grounds upon which the Club and/or League Executive making the application seeks to have the permit revoked.
- (f) A registered player who has played at least two (2) games for his Club in that one season and is transferred in employment/resident beyond that Clubs boundary be allowed to continue to play for the Club until the end of that season. The player is not to be regarded as one of the eight (8) registered players outside the sixty (60) kilometre radius.
- (g) Any Club breach of this By-Law is to be fined \$500.00.

## That the By Laws be amended to:

## 2. PLAYER REGISTRATION AND PERMIT TO PLAY

- (a) A player shall not be registered by a club nor be qualified to play for a team in any Football competition conducted by the League unless the valid registration appears on the Leagues membership record. Either-:
  - (1) granted a permit by the Permit Committee to be registered with that Club;
  - (2) approved inward transfer or short term permit, having been consented to be any other club or league where the player was previously registered;
  - (3) first time player registered and accepted on the League membership database using the appropriate League stationery
  - (4) club players with registration brought forward from a previous season
- (b) Club Secretaries shall register their respective players each season with the League Secretary fourteen (14) days prior to the season commencement.
- (c) A player seeking registration with a Club for the first time or not included on the preseason registration must sign the prescribed form provided by the League Secretary. He then remains a player of the Club for the subsequent seasons unless cleared by the said Club.
- (d) The Secretary of the League shall keep a register of the persons who have obtained registration and a permit to play.
- (e) No permit shall be granted to a player whose clearance has not been lodged on or before the 30th June in any one season, except if provided for in the South Australian Affiliated Leagues Regulations as amended from time to time. Provided a clearance has been lodged prior to the 30th June in any one season, a permit may be granted to play for the club
- (f) Any Club breach of this By-Law is to be fined \$500.00, in addition to forfeiture of any matches played whilst in breach.
