



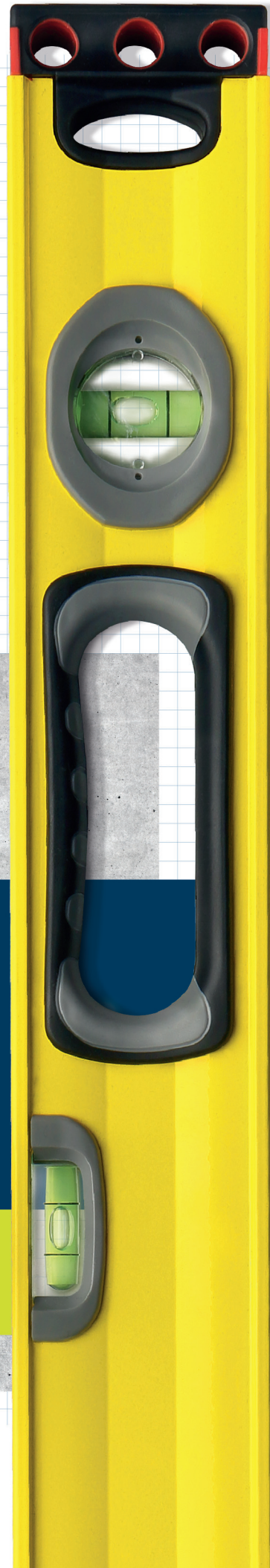

Certificate IV in Building and Construction (Building) CPC40110 is designed to meet the needs of builders and managers of small to medium-sized building businesses. The course covers common skills for the construction industry.

With experience you may also take on supervisory roles, such as construction project supervisor, planner, coordinator or manager.

### Enrolment checklist

- You are over 18 years of age
- You are currently working in the building and construction industry or you have recent experience in the building and construction industry
- You are competent in written and spoken English (language, literacy and numeracy will be assessed as part of the enrolment process)
- You are able to attend the scheduled classroom training sessions as per the timetable
- You will have access to a computer and the internet for the duration of the course

### How long will it take?

Course duration will depend on the individual course, your experience and schedule. You may also be asked to study or revise at home. Please contact us for the current range of course schedules.

### Is the course subsidised?

If you meet the eligibility criteria the cost of the course can be subsidised by State and Commonwealth Government funding. Contact us to find out if you qualify. If not you can still enrol as a full fee student. See our website for full details of fees, subsidies and charges.

### Future pathways

After completing Certificate IV in Building and Construction (Building) CPC40110 you may decide to further your training with a Diploma of Building and Construction (Building) CPC50210 or register with the Building Practitioners Board to become a licensed builder.

### Units

Participants need to complete 16 units of competency, consisting of 13 core units plus 3 elective units.
