## **STATE LEAGUE LOCAL REGULATIONS**

## 1 DEFINITIONS

MSL	Mens State League 2
FWW	Football Wagga Wagga
MSL Game	Includes all general competition rounds in the State League, any finals series games, FFA cup, trial games or any other competition or otherwise that the MSL team participates in.
MSL Player	A player registered to play with the Wagga City Wanderers MSL team
MSL Register/Registration	A fully paid registration with MyFootballClub

## 2 GENERAL

- a) These Regulations can be changed at a Football Wagga Wagga General Meeting prior to the commencement of the MSL Competitions each season, by way of a motion as per the procedures provided for in the Football Wagga Wagga Constitution.
- b) Where there is any conflict between the Regulations, Football Wagga Wagga may, at its absolute discretion, make a determination to remove the conflict. There is no right to appeal any determination made by Football Wagga Wagga.
- c) Nothing in these Regulations prevents Football Wagga Wagga from making a determination, if required, on issues arising during the administration of competitions not addressed by these rules. There is no right to appeal any such determination made by Football Wagga Wagga.
- d) These Regulations cannot be changed after the start of the MSL Competition each year.

## 3 REGULATIONS

- a) MSL Players must be registered with a FWW-affiliated club prior to the start of the MSL competition, or prior to the end of the first MSL registration period (whichever comes first) to be eligible to play in the MSL.
- b) An exemption to Clause 2a) may be granted by FWW where all FWW affiliated clubs have refused to register the MSL Player, or at the discretion of FWW.
- c) MSL Players must actively participate with a FWW affiliated club as:
  1. A Player, and/or
  2. A Coach, and/or
  3. A Club Administrator and/or
  4. Any other role as agreed upon by the FWW Affiliated Club.
- d) For any given MSL Game, MSL Players may, if selected, be nominated to play on the team sheet in the corresponding FWW competition fixture if:
  1. They were not selected in the MSL playing squad for that MSL game, or
  2. They were selected in the MSL playing squad, but have been given special permission by the MSL Head Coach to play in the FWW competition.
- e) The MSL Head Coach may, only under exceptionally circumstances, place limitations on MSL Players playing in the local FWW competition.
- f) Where the MSL has a bye round, the MSL Head Coach will determine whether any MSL Player is to be available for selection to play for a FWW affiliated club.
- g) MSL Players who are not available to play in an MSL Game (eg through injury, other commitments) may not play in the FWW competition, unless granted special permission by the MSL Head Coach.

- h) MSL players are only eligible to play for a team in the local FWW competition finals series if they have played the majority of games for that team during the season. In determining this, all games (MSL and local competitions) must be taken into consideration.

#### **4 PENALTIES**

The penalty for a breach of these conditions by a FWW club is forfeiture of the game in which the player was nominated to play.
