- 8 of 24 participating countries (33%) had more female medalists than male medalists
- Only 2 sports had more PGAs entered in the Women's event than in the Men's event

SPORTS PROGRAM REVIEW

1. Overview - Key Points



- Very successful 2015 Pacific Games
- Charter operating efficiently major changes not recommended
- Refinements still needed to keep up with changing face of sports internationally, attract the best athletes, and keep Games sustainable



 Must maintain an attractive sports program for the athletes, sponsors, media, general public and Governments who we need as hosts

A. Introduction



Article 23.6: Sports program and the compulsory sports must be assessed each four years after the major edition of the Pacific Games

Ten years since Apia Charter 2006 reforms reduced program from 33 sports in Samoa 2007 to 28 sports at Port Moresby 2015



2019 Pacific Games – reduced further to 26 sports in 2012 Sports Program Review following review of New Caledonia 2011 Games (27 sports)

Compulsory Sports generally performing well 12 compulsory in the 2007 Games 14 compulsory in the 2015 Games

2. PACIFIC GAMES SPORTS PROGRAM B. Size of the Games – Number of Sports



(i) Minimum 6 PGA entries

Remains the best measure of credible competition

24 sports reached this standard in 2011 and 2015
Not easy to reach nowadays with event calendar



NC2011 OC recommended 24 sports in 2012 SPR
2012 General Assembly lowered maximum from 28 to 26 for 2019 Pacific Games

Port Moresby 2015 OC recommended 20 sports
 16 compulsory and 4 optional (only 2 for teams)

 Maximum 24 sports recommended – hopefully the final reduction in the number of sports

B. Size of the Games – Number of Sports



(ii) Sustainability – Participant & Venues Numbers

- Design size of the sports program to target a maximum of 4,000 athletes and officials
- 24 sport program could achieve this target



- IOC and CGF set targets which send a message of sustainability for prospective hosts
- Especially in the requirements for new venues
- Biggest risk area in countdown to Pacific Games

B. Size of the Games – Number of Sports



(iii) Limits to Team Sport Program

Not recommending a limit on the number of team sports which can be chosen by the host PGA

Treat all sports equally

(iv) Quotas/Qualification Standards

 In place for Olympic & Commonwealth Games but Pacific Games is an athlete development event; many sports have weak rankings systems in region

Manage sustainability by reduction to 24 sports

Quota offered by FIBA Oceania Basketball: 8 Men's & 8 Women's teams for Tonga 2019; teams to qualify at 3 sub-regional tournaments Recommended as a trial

B. Size of the Games – Number of Sports



(v) Events Based Sport Program

IOC vision 2020 ; CGF Transformation 2022

 Allows more sports to be offered by reductions to event programs within existing program sports



Conseil des Jeux du Pacifique Emulate where possible but guard against imposing additional venue needs in Pacific Games

 That the Council retains its commitment to selecting sports rather than events as the basis for competition, but that the Council continues to promote flexible approaches within each sport's event schedule – e.g. Kayak into Va'a program

B. Size of the Games – Number of Sports



(vi) Games Programming recommendations

1. That the Council, via MOU agreements with each Oceania Federation, impose disciplines on each sport's technical requirements, scheduling, equipment needs and officials.



- 2. That the vast majority of sports be required to conclude within 5-6 days so as to enable athlete departures on Saturday evening of week one and reaffirm no Sunday play.
- > 3. That the General Assembly empowers future GOC's to provide a bed limit of 65% of a 'large' PGA's total delegation.

(i) Analysis by Number

 Best practice - maximise the compulsory list for more consistency between Games, stronger brand

Port Moresby GOC recommendation was for 16 out of 20 (80%) to be compulsory



Conseil des Jeux du Pacifique • Amend Article 23.6 to adjudge the compulsory program not only by PGA entries but also by:

"those sports capable of offering superior resource support to Games hosts, and/or those sports offering qualification pathways to international events especially Olympic sports; and/or a particular sport's anti-doping compliance".

- Most compulsory sports performing very well; justifying their status based on PGA entries

Also accord with the "most effective TV impact"

5 That all 14 compulsory sports retain their position in Article 23.1, with Boxing (governance) and Va'a (PGA entries) to be closely monitored.

- (iii) Candidates for Promotion
- Football Women: all compulsory sports would thus be compulsory for men and women
- Bodybuilding, Netball, Powerlifting, Shooting on watch list for review in the next cycle

- Sailing and Triathlon recommended for promotion
 - Olympic sports with good entries in 2011, 2015
 - Amend Sailing Regulation 5.13 to allow host to offer a minimum one instead of two disciplines
- Enables two-thirds of program to be compulsory (up from 53% now)
- Offers host PGAs a choice of 8 sports; one-third

D. Review of Sports with Low Event Entries



Not recommended to delete events with low entries

- Some Female events
- Some Lighter weight categories
- Some Longer Distance Events; Field Events





B. Review of Port Moresby 2015 Trial



- Successful
- Added to the quality of competitions in each sport
- Boosted media coverage and broadcast reach
- Pathway event for aspiring Rio 2016 athletes
- Generous support from ONOC and endorsement from IOC President
- Importance of invitation being issued to the NOC and for inclusion in the Pacific Games event rather than a separate Oceania championship

C. Basis for Future Invitations



- For 2019 Games cycle, focus on "extending the trial" as per MOU rather than membership
- Facilitate the further gradual inclusion by targeting approximately eight sports for 2019 cycle – same number as original 2013 Joint Committee proposal



Invitations in 2016 to allow adequate preparation

- Principles for Sports under consideration:
 - Olympic sports
 - Competitive gap not too large; aid development
 - Sports where Olympic Games/World Champ's qualification event can be organised and a duplicate Oceania event avoided

D. Proposed Invitations: 2017 & 2019



Same terms and conditions as 2015 invitation:

All relevant provisions of PGC Charter apply
GOC not unduly financially burdened



Continue with each of the sports trialled in 2015

 Due to short lead time, no new sport invitations for Vanuatu 2017 – just Rugby 7s, Weightlifting only



Conseil des Jeux du Pacifique Future invitations continue to be issued directly to the respective Australian and New Zealand NOCs under the same terms and conditions as Port Moresby – all relevant provisions of PGC Charter apply to the invited athletes.

 Future invitations are issued for the Pacific Games event itself rather than in a concurrent event



Rather than consider Council membership, extend the trial as foreshadowed in the ONOC-PGC MOU, to facilitate the further gradual inclusion of Australia and New Zealand by targeting approximately eight Olympic sports for the 2019 cycle, with invitations issued in 2016 to allow for adequate preparation time

F. Summary of Recommendations



Triathlon be the 8th and final sport for invitations unless Sailing is added to the 2019 program, in which case Triathlon would join Table Tennis (Para Events) as a reserve

4. FUTURE OF PACIFIC MINI GAMES

No consensus for major change to a Youth Games or to dissolve into three sub-regional Games



Recommendations:

Retain Pacific Mini Games and not fully convert the event to a Pacific Youth Games

That Article 24.5 of the Charter be amended :



Conseil des Jeux du Pacifique "As far as possible the events and disciplines to be included in each of the sports chosen are to be the same as for the Pacific Games however the Executive Board shall have the right to vary the program of events following consultation with the Sports Committee and the IF, <u>which may include</u> designating some events, or a percentage of entries in some events, for youth age athletes".

4. FUTURE OF PACIFIC MINI GAMES





Recommendation:

Subject to agreement by the Vanuatu PGA and facilitation by the respective Oceania Federations, endorse a trial at the 2017 Pacific Mini Games whereby Golf, Table Tennis and Tennis will be organised as Youth age competitions.

5. Athlete Eligibility & Entries

Athlete Eligibility



- No consensus to discard residency criteria or adopt IF eligibility rules across the board
- Article 26.1d(iii) discretionary power to use IF eligibility working well and sparingly (6 sports)



 Proposed amendment: Reduce timeframe for exercising this power from two years before Games to <u>15 months</u> before Games

 Provides additional flexibility for IFs to organise qualification/rankings event

5. Athlete Eligibility & Entries

Athlete Eligibility Cont'd



Retain 10 day "protest" window - Article 26.7

 PGC lacks resources to allow protests on eligibility all the way through the Games

Protocol 7 Penalty Fees for Withdrawals by Sport

- Abolish Penalty Fees regime it has not worked
- Implement up-front deposits to secure entries
- Forfeited if sport withdraws <u>or</u> deduct from per diem if the sport actually participates
- Proposed Amendments to Protocols 7.7 7.10

Pre-DRM – proposed Amendment to Protocol 7.11:

"A pre-DRM in person, or through the use of technology, shall occur within five days after the further confirmation of entries 30 days before the Games "

6. TECHNICAL OFFICIALS



- Capacity in host countries and across the Pacific remains a weakness in most sports
- Port Moresby GOC paid all I.T.O. travel costs
 Unsustainable for future hosts
- The Council to develop rigorous MOUs with each Oceania Federation to reduce a GOC's exposure to ITO travel costs



- Protocol 16.1.c.4.d address the division of ITO airfare costs: "Airfare costs will be divided between the OC and the International Federations as agreed with the Council"
- That a "technical officials committee" be created with input from ONOC and OSFO; improve technical officials' development



Oceania Federation Submissions



- Conservative approach to expanding events
- Maintain sustainability and affordability
- Only recommending the most meritorious proposals gender equity, social inclusion but requiring strong evidence of sufficient entries



- Rejected proposals to expand events in:
 - Bodybuilding more Women's events
 - Rugby League 9s Women's event
 - Surfing Stand-Up Paddling
 - Swimming Pará events

• Recommending the following new events:





- Basketball
 - Add 3x3 format as an option
 Regulation 7: four players per team and Regulation 9B: one official per team
 - That a future Games Organising Committee only be permitted to offer both formats if a quota operates in the 5-a-side format to control overall athlete numbers.
- Shooting

 Add Teams event to all ISSF events in Regulation 5.14 and remove cap of maximum 9 athletes in Regulation 6.14, so as to be consistent with DTL/CPSA events





- Para Sport (Athletics & Table Tennis)
 - Amend Regulations 5.2 (Athletics) and 5.19 (Table Tennis) to require athletes to be "internationally classified"
 - "Results in competitions comprising athletes with different classifications to have an agreed table for results calculation"

• Table Tennis

- Regulation 6.19 amended to add one extra male and female entry for Para events
- Offset by reduction in able-bodied entries from 5 men/5 women to 4 men/4 women

No change to Regulation 7 for composition of Mixed teams, but ensure rest day before mixed competition commences

8. ADJUSTMENTS TO TONGA 2019 PROGRAM

Reviewed all sports with less than 6 PGA entries in 2011 & 2015, including Hockey and Men's Cricket



Recommendations:

- I. That Tonga be relieved from its obligations to organise Baseball and Softball competitions:
 - Complete failure of Softball in Port Moresby
 - Likelihood Baseball will not get 6 PGA entries



2. That Tonga be encouraged to add the compulsory Women's Boxing and Rugby 7s disciplines to its program.

3. That if Women's Boxing and Rugby 7s are included, Shooting and Sailing (in that order) be approved for addition to 2019 program as requested by GOC and host PGA.

New Bid Protocol 1.7 for Ratification

- Compliance bond to ensure Host Contract respected and valuable time not lost after bid
- Set at \$100,000 for 2023 Games bidders

"The PGA of each candidate country shall when furnishing the Bid document pay a bond, in the amount to be determined by the Executive Board, to be released back immediately to an unsuccessful candidate country and to be released back to the successful candidate country at the end of the Games upon the achievement of all milestones outlined in the contract including the formation of the Organising Committee and Audit and Governance Authority."

should open 4 days (instead of 3 days) before the

Conseil des Jeux du Pacifique > per diem should not be discounted 50% for those residing outside the Village as all participants should be encouraged to stay there;

there must be a minimum 3 meals per day, each with a minimum 3 hour session.

Port Moresby GOC Proposal for Ratification

These changes are in line with amendments made in 2010 to change perceptions of the Games Relay away from an Olympic-style "torch" towards more Pacific-style solutions.
