- Delegates were encouraged to strongly advise their clubs to complete this survey

 - 2 round competition
 - General discussion was had
 - Points raised:
 - Some clubs felt the season was too long
 - Some clubs believe that this would deter some players as they would prefer to be playing more games and would possibly move elsewhere
 - Suggestions included possibility of split round where the top 4 clubs at end of previous season play each other
 - $\circ~$ Delegates asked to consider at club level AGM and then bring those discussions to MWFL AGM in Nov 16
 - 9 a side B Grade competition
 - General discussion was had
 - Points raised:
 - Some clubs struggling to field B grade every week
 - Many players in this grade playing to make up numbers, would prefer not to be playing
 - Western Districts suggested "Cap on number of registered players at a club" if too many, extras had to play for another member club

Tony Tree apologized and will forward a Presidents Report for the AGM in August 2016 Peter Cock thanked all clubs, players, officials, etc for their participation in Mortlock & Kinlough events

8. General Business

- 8.1 Club Top 15s List circularised to all clubs from A Buckham for consideration & adoption
 - As per email distributed 15/7/16, all MWFL clubs were to have sent through to Bucky their lists by yesterday, has this been completed?

• These lists need to be adopted at this meeting All lists as presented were accepted with very little discussion required

8.2 Tribunal Review

- What pre-determined penalties should be applicable where offence is by a non-player (runner, official, etc)
 - *"Current rules do not distinguish between playing/non-playing"*

Discussion was that delegates should take this back to clubs to be discussed at their AGMs Consensus was that "pre-determined penalties" should not apply to "non-playing offenders" and that should this occur it should be handled by the Tribunal as is the norm for most other leagues. Clubs will need to move for this to be minuted or inserted at MWFL AGM in Nov 2016 in readiness for 2017 season

8.3 Amendments for AGM?

- 8.4 Umpires A Buckham
 - "We have been down to 3 and more recently 4 panel umpires, which means that clubs are now providing umpires for their own home games. I have seen and also heard of abuse directed at these umpires, which is less tolerable than panel umpires given generally they have not had the opportunity of formal training and are less experienced, many have not even put their hand up to do it, rather have been seconded by their club. Matter needs to be raised for club discussion and thoughts, I am sure that we will have a report on our hands sooner or later, but better to be pro-active and have the matter on the table first. (See recent email to commence this discussion attached)"

All delegates were asked to emphasize, to their respective clubs, that they were expected to accept umpires decisions and to ensure respect AT ALL TIMES is shown.

I support Bucky's comments regarding supporters, players and officials attitude to umpires. On the whole our league is pretty good, however this is let down by a few that can't contain themselves. If we look back over the reports in recent years, a high proportion of reports relate to abuse of umpires. I have noticed that more and more of the younger senior players seem to think it is alright and acceptable to level abuse and derogatory comments at the umpires, not a good trend and one that needs to be monitored and controlled. Clubs need to take responsibility and set the standard for their club and the league and eliminate this antisocial and offensive behaviour from our game, before it does escalate into something bigger than we can handle.

Also – regarding Bucky. He would be well and truly eligible for MWFL life membership, consideration be given to awarding of this. Also, I suggest his record at Mortlock be investigated with the Mortlock committee, he has been a league official / delegate for approximately 10 years, and was a player for Mid-West and , I believe Port Lincoln.

I will be stepping out of the umpires coordinator role next year, suggest that it become part of the President role (it was how I got it!), for clubs consideration.
