## Mt Gravatt JAFC Youth Coaching Nominations for Season 2017

Applications are called from interested individuals who wish to nominate for the following coaching positions within the Mount Gravatt Junior Australian Football Club for the 2017 season:

- **Under 12 Age coach** – this position will be responsible for all under 12 teams and also coordination of any under 11 teams which the club may have during the 2017 season.
- **Under 13 – Female coach** – this position will be responsible for the development and training of all female teams entered into the under 13 competition. In addition, they may be expected to assist with the development of any under 11 players.
- **Under 14 age coach** – this coach will be responsible for the development and training of all under 14 teams.
- **Under 15 female coach** – this coach will be responsible for the training and development of all female players in the under 15 competition. The role may also include the oversight of the development of all female players associated with the club.
- **Under 16 age coach** – this coach will be responsible for the development and training of all under 16 teams entered into the competition by the club. In addition, they will be expected to liaise regularly with the Mt Gravatt AFC Development Officer (or similar position) to ensure the continued development of players within this cohort including allowing any opportunities to participate in Senior level football.

It is to be noted it is an expectation for the age coach to be responsible for the appointment of all assistant coaches within their respective age groups including the appointment of game day coaches.

## **2017 Coaches Agreement**

I (Name), ....., in applying for a coaching position with the Mount Gravatt Junior Australian Football Club (MGJAFC) for season 2017 acknowledge that, should I be appointed to a coaching position, I will abide by the following:

1. I will, in my role as a MGJAFC coach, respect the rights, dignity and worth of all individuals including refraining from any discriminatory practices on the basis of race, religion, ethnic background, or special ability/disability.
2. I will abide by and support the AFL Laws of the Game, the rules of the AFL Brisbane Juniors and the rules and Policies of the MGJAFC.
3. As a MGJAFC coach I am required to:
  - Maintain team discipline and instruct players to play within the rules
  - Instruct players to comply with the Codes of Conduct and / or behaviour for Players published by the Australian Sports Commission and AFL Queensland and all MGJAFC policies
  - Comply with the Codes of Conduct and / or behaviour Policy prescribed by AFL Queensland.
4. I am to follow all Coaching Guidelines and Policies as set down by the MGJAFC and committee from time to time;
5. I must attend and participate in all coaches meetings conducted by MGJAFC;
6. I am to provide a game day report in such form as may be approved by the committee at the conclusion of each game;
7. I understand the importance of refraining from the use of the offensive language and behaviour when addressing MGJAFC and opposition players, officials, parents and spectators or AFLBJ officials and umpires;
8. I am to communicate to parents and guardians of players in my charge the philosophy and objectives of both the club and myself;
9. I am to encourage parents and guardians of any children in my charge to approach me directly at reasonable times (not during scheduled games) to discuss any issues pertaining to the team or their child;
10. I will comply with all requirements of the MGJAFC and the club in relation to coaching level accreditations;
11. If I have not completed a current AFL Level 1 Coaches Course I undertake to complete such course as soon as one becomes available.
12. I will be liable for dismissal or penalty, at the sole discretion of the MGJAFC Committee if I am found at any time to be in breach of any of the requirements of this Agreement.
