DUTY OF CARE

- CHNC have a duty of care towards all members of the club, the following safeguards have been established to ensure this duty is fulfilled.
- When a player suffers an injury or has a medical condition that prevents them from participating fully on game day or at training, the player must:
 - advise CHNC in writing to chnc@iprimus.com.au, providing details of the injury & dates of unavailability
 - provide a medical certification to confirm ability to return to full training and match play
 - provide confirmation from diagnosing Doctor or treating specialist confirming ability to play in the event return to playing/training is earlier than originally stated

CODE OF CONDUCT

All players, parents and officials participating in the event sanctioned or controlled by CDNA are obliged to adhere to the NV Code of Conduct. This Code shall be read and adhered to in conjunction with the CDNA Rules, Regulations, Policies and Procedures relating to competing teams. For the purpose and definition the 'NV Code of Conduct' extends from representative's time of selection until the end of the season. This 'Code' also covers and includes any training period during the season/year.

- 1) The Code of Conduct has been implemented for all members associated with Chelsea Heights Netball Club and is enforceable from the time of appointment of Officials and selection of Players to a team, including parents.
- 2) Being selected to represent Chelsea Heights Netball Club brings with it particular responsibilities for Officials, Players and Spectators to conform to high standards of fair play and personal behaviour both on and off the court. Representatives shall remember their behaviour will be closely observed by many others as she/he represents Chelsea Heights Netball Club.
- 3) If there is a breach of the Code of Conduct, the Chelsea Heights Netball Club Officials are required to report to the Chelsea Heights Netball Club Committee who is empowered to impose disciplinary action, or if deemed necessary report breaches to CDNA for action.

CHELSEA HEIGHTS NETBALL CLUB MEMBERS ARE EXPECTED TO:

1. Participate because you enjoy it, not just to please parents and coaches.
2. Play by the rules.
3. Know the rules
4. Participate fairly and safely.
5. Abide by decisions, without argument or bad temper.
6. Captains have the right to approach an umpire during an interval, after the game for clarification of any rule.
7. Approach the umpire in a courteous and polite way.
8. Cooperate with your coach, and other players.
9. Verbal abuse of officials or other players, deliberately fouling or provoking an opponent and throwing/damaging equipment is not acceptable or permitted.
10. Treat all players as you would like to be treated.
11. Ensure that at all times your behaviour is fair.
12. Be a patient and enthusiastic supporter of fellow players.
13. Applaud all good play, by your own team and opponents.
14. Be a responsible team member.
15. Always be on time.
16. Encourage and assist all players.
17. Attend all training sessions.
18. Ensure you always bring the appropriate uniform and equipment to training and/or matches.
19. Do not engage in practises that affect sporting performance (alcohol, tobacco and drug use).
20. Respect and acknowledge the contribution of those who create the opportunity for you to play including volunteers (scorers, coaches, timekeepers, administrators and umpires).

I also understand that Netball is a limited contact sport and there is a risk of injury involved in playing netball.
