The 2018/19 Youths will be held in Hobart. The meeting agreed to ask 5th Fleet to nominate the host club to the ICCA as soon as possible so we can advise sailors.

1. National Website Media and class promotion

Peter Royle advised the meeting on the work contracted to DUS and recommended the marketing be developed in coming years.

2. Cadet Regatta Guide

Ben Kelsey has updated the Nationals Guide to include learnings from recent nationals. The review has included time on water, start times, races course configurations, modernising competitor communications with a view to the cadets being a family class and we want the whole family to enjoy the nationals, particularly the endurance of the younger kids must be considered. Guy asked that the "Guide" be an "Instruction". Ben will circulate this to the Fleets for comment in the next month. The Fleets will be asked to return any comments within a month and Ben will review and amend where appropriate prior to issuing to Metung for next Nationals.

3. Felicity Allison recommended that the Tillets team trophy winning state be selected based on the top 6 boats at the conclusion of the nationals, rather than a preselected team. The meeting agreed. Ben and Peter were asked to consult the Tillet family to ensure they agreed to the change.

4. Peter O'D suggested we consider shortening the Nationals by simplifying measurement, shortening race duration, and allowing back to back racing. This would save families accommodation expense and holiday balance/allowances. This recommendation was well received.

5. Michael Cooper has identified an opportunity to purchase the ex-Argentina worlds boats for a cheap price and having them delivered to Holland in time for the next worlds in July 2017. This was discussed along with a proposal by Power Drive Marine. No final decision was made, however the meeting was in favour of the ICCA committee reviewing the options and subject to suitable due diligence, investing in the boats with a view to chartering to the Australian Team for the next 3 years.

6. Tony Bull reported on the Argentinean proposal to change the Sail plan on the Cadets with a bigger roach. Michael Cooper reported that the international consensus is that the class should either:

a) drop the maximum age to 15 OR

b) Increase the power of the sails to make it adequately powerful for 100 kg combined crew weight.

Tony was of the view that any new sails would be better to be square head, fully battened and "Clear" like the 9er FX sails. It was agreed to get the sails up on the Power Drive Marine boat for all to see. The ICCA must determine the Australian position and report back to the ICC in July.
