

## Interstate Player Clearance Policy & Procedure

### Purpose:

The purpose of this policy and procedure is to provide guidelines and an official form for the clearance of registered players from Northern Territory Clubs and Associations to other States and Territories within Australia.

### Policy:

Clearances from Northern Territory Basketball Clubs and Associations are provided to ensure that NT registered players have no impediments to playing at other State and Territory Basketball Clubs and Associations, financial or otherwise.

### Procedures:

1. The attached form is to be used for the purpose of registered NT players transferring to play in other States and Territories within Australia only.
2. Clearances must be lodged with Basketball NT at least 5 working days prior to the date by which approval of the clearance is sought.
3. Requests for clearances within 5 working days MAY be considered on a case by case basis and may incur a \$100 fee for service to provide the clearance in the necessary timeframe.
4. An authorised representative of the Club will fill in the form with the player's name, Club name, Association name and the Club/Association the player is going to, to request clearance of the player.
5. Form is to be forwarded to the appropriate Association to be recommended by an authorised representative from that Association.
6. Form is forwarded to Basketball NT ([admin@nt.basketball.net.au](mailto:admin@nt.basketball.net.au)) to determine the suitability of the player for clearance, checking on any financial or other impediments.
7. Upon satisfaction of the suitability of the player for clearance, Basketball NT will approve or not approve the clearance.
8. Basketball NT will provide a copy of the form back to the Club & Association for their records
9. The player is provided a copy by the Club or Association in order to provide a copy to the Club /Association they are going to play for interstate.
10. A copy is retained by Basketball NT
11. A copy is provided to Basketball Australia by Basketball NT for their records
12. Where a database has been set up for such clearances, Basketball NT will enter this data.

**NOTE:** Other States and Territories shall provide clearances for their own players on an appropriately titled form that has their own Associations logo. The attached form is to be used for the purpose of NT players transferring to play in other States and Territories within Australian only.
