Items of correspondence 8.7, 8.6 & 8.8 (received after Agenda distributed) from General Business

- **8.7** General discussion was had by delegates with regard to issue raised in letter from Western Districts
  - Noted that all member clubs have "persons" that are members/supporters that fit into these "moulds" referenced in Western Districts Letter of Concern
    - Sling/spear tackle rough play tackle
      - Consensus of all delegates was that they believe the umpires already have the "power" to address this
  - Matt Cook tabled a document from the AFL, specifically defining "Dangerous Tackles", including sling and spear tackles.
  - MWFL Constitution in the section Independent Tribunal Procedures identifies "Intentionally, recklessly or negligently offences against umpires, players and other offences" or also could be defined as "Unduly rough play" - Noted by several clubs that these types of tackles are "rarely seen" in our games
  - MWFL office bearers, delegates and clubs NEED to support their umpires
  - Feedback from umpiring panel was that umpires did not feel confident to apply "Unduly Rough Play"
  - Some discussion was noted about having 3 umpires
  - Consideration was given to "defining what is Unduly Rough Play" see Tribunal Predetermined Penalties Guide

# Moved that

- Umpires address players prior to games ACTION (Umpires)

- Delegates to go back to their clubs and strongly communicate that excessively rough play/conduct will not be tolerated and games will be umpired accordingly, Umpires will be fully supported by the League and Clubs in these situations ACTION (Delegates)

Proposed: J Sampson 2<sup>nd</sup>: A Curtis CARRIED

Delegates to take this back to their clubs and advise them that the league umpires will be fully supported in their endeavor to enforce the current guidelines with regard to verbal abuse towards the umpires ACTION (Delegates)

#### 15. REPORTING OF INCIDENTS.

(a) The following conditions shall apply to a charge laid by the umpire in respect of a breach of the "Laws of the Game" by a player. All charges shall be dealt with in terms of the Tribunal Procedure or Pre-Determined Penalty Guides

(1) Each umpire who makes a charge shall fill in duplicate, copies in respect of each Club which has a player to be reported. Such copies shall set out the name of such player and particulars of the charge. Each umpire who makes a charge shall sign both copies and if he is a boundary or goal umpire shall hand both copies to the field umpire. The field umpire shall deliver one copy of each charge to the Secretary of this League so as to reach him no later than in the afternoon of the following Monday. The reporting umpire is to advise the League secretary verbally that a report has taken place by Sunday evening 8pm.

Each Club shall be responsible for the attendance of an official at the door of the umpire's room at the termination of the match to seek details of any reports arising from a match and where charges are made, the field umpire shall hand to the officials of the Club concerned, and the duplicate signed copy of such charges. In the case of non-attendance of an Official, the Club in default and any player concerned in a charge shall be deemed to have waived compliance with the provisions of this clause and the charge will be heard as if the Official received the copy of the charge.
