STATEMENT OF PURPOSE

SECTION A STATEMENT OF PURPOSES ASSOCIATIONS INCORPORATION ACT 1981 SECTION (5B)

- 1. The name of the proposed Incorporated Association is the Kyabram District Football Netball League Incorporated.
- 2. The purposes for which the Association is established are:
- 2.1 The promotion and propagation of the Australian National Game of Football and the game of Netball.
- 2.2 The organisation and carrying on of competitions in the games aforementioned between incorporated bodies which for the time being are members of the Association. Solely for the furthering of the purposes as set out above the Association shall have power:
 - a) To make rules and regulations and establish procedures for the orderly conduct and good management of the competition it conducts between its members, without prejudice to the generality of the foregoing, such powers shall include but not be limited to the making of rules in respect of the registration of players and club officials, admission and removal of members from that competition, discipline of members, players and officials, recognition of achievement of members, players and officials, the settlement of disputes in relation to all matters over which the Association has power.
 - b) To take over the funds and other assets and the liabilities of the present unincorporated body known as the Kyabram District Football & Netball League.
 - c) To indemnify any person for any loss or damage incurred as a result of having on behalf of the unincorporated association become liable to pay damages or otherwise.
 - d) To subscribe to, become a member of any co-operate with any other Association, Club or organisation whether incorporated or not, whose objects are altogether or in part similar to those of this Association provided that the Association shall not subscribe to or support with funds, any Club, Association or organisation which does not prohibit the distribution of its income among its members to an extent at least as great as that imposed on the Association under or by virtue of the Rules.
 - e) To buy, sell and deal in all kinds of articles, commodities and provisions, both liquid and solid, for the members of the Association or persons frequenting the Association's premises or the premises of any member Association.
 - f) To purchase, take on lease, or in exchange, hire, and otherwise acquire any lands, buildings, easements or property, real and personal, and any rights or privileges which may be requisite for the purposes of, or capable of being conveniently used in conjunction with, any of the objects of the Association; provided that in case the Association shall take or hold any property which may be subject to any trusts the Association shall only deal with the same in such manner as is allowed by law having regard to such trusts.
 - g) To enter into any arrangements with any Government or Authority that are incidental or conducive to the attainment of the objects and the exercise of the powers of the Association; to obtain from any such Government or Authority any rights, privileges and concessions which the Association might think it desirable to obtain; and to carry out, exercise, and comply with any such arrangements right, privileges and concessions.
 - h) To appoint, employ, remove or suspend such managers, clerks, secretaries, servants, workmen and other persons as may be necessary or convenient for the purposes of the Association.
 - i) To construct, improve, maintain, develop, work, manage, carry out, alter or control any houses, buildings, grounds, works or conveniences which may seem directly or indirectly to advance the Association's interests, and to contribute to, subsidise or otherwise assist and take part in the construction, improvement, maintenance, development, working, management, carrying out alteration, or control thereof.

STATEMENT OF PURPOSE

- j) To invest and deal with the money of the Association not immediately required in such a manner as may from time to time be thought fit.
- k) To take, or otherwise acquire and hold shares, debentures or other securities of any company or body corporate.
- To lend and advance money or give credit to any member; to guarantee and give guarantees or indemnities for the payment of money or the performances of contracts or obligations by any member, and otherwise to assist any member.
- m) To borrow or raise money either alone or jointly with any other person or legal entity in such manner as may be thought proper and whether upon fluctuating advance account or overdraft or otherwise to represent or secure any monies and further advances borrowed or to be borrowed alone or with others as aforesaid by notes secured or unsecured, debentures or debenture stock perpetual or otherwise, or by mortgage, charge, lien or other security upon the whole or any part of the Incorporated Association's property or assets present or future and purchase, redeem or pay off any such securities.
- n) To draw, make, accept, endorse, discount, execute and issue promissory notes, bills of exchange, bills of lading, and other negotiable or transferable instruments.
- o) To sell, improve, manage, develop, exchange, lease, dispose of, turn to account, or otherwise deal with all or any part of the property and rights of the Association.
- p) To take or hold mortgages, liens and charges, to secure payment of the purchase price or any unpaid balance of the purchase price of any part of the Association's property on whatever kind sold by the Association or any monies due to the Association or from purchasers or others.
- q) To take any gift of property whether subject to any special trust or not, for any one or more of the objects of the Association but subject always to the provision in clause f).
- r) To take such steps by personal or written appeals, public meetings or otherwise as may from time to time be deemed expedient for the purpose of procuring contributions to the funds of the association, in the shape of donations, annual subscriptions or otherwise.
- s) To print and publish any newspapers, books, periodicals or leaflets that the Association may think desirable for the promotion of its objects.
- t) To amalgamate with one or more Incorporated Associations having objects altogether or in part similar to those of the Association and which shall prohibit the distribution of its or their income and property among its or their members to an extent at least as great as that imposed upon the Association under or by virtue of the Rules.
- To purchase or otherwise acquire or undertake all or any part of the property, assets, liabilities and engagements of any one or more of the Incorporated Associations with which the Association is authorised to amalgamate.
- v) To transfer any property, assets, liabilities and engagements of the Association to any one or more of the Incorporated Associations with which the Association is authorised to amalgamate.
- w) To make donations for patriotic, charitable or community purposes.
- x) To transact any lawful business in aid of the Commonwealth of Australia in the prosecution of any in which the Commonwealth is engaged.
- y) To do all such things as are incidental or conducive to the attainment of the objects and the exercise of the powers of the Association. This is the annexure of five (5) pages marked Section A referred to in
