RULES

PART 1—PRELIMINARY

1. Name

The name of the incorporated association is "Nhill & District Sporting Club Incorporated".

2. Purposes

The purposes of the association are—

- 2.1 To promote sport, including but not limited to AFL football, netball, hockey and cricket, and to organise teams to engage in competition or other matches with the Wimmera Football League, West Wimmera Cricket Association, Wimmera Netball Association, Wimmera Hockey Association or such other Leagues or Associations as the Committee may from time to time by resolution determine to join and subscribe to.
- 2.2 To promote sporting activity in the Nhill and District community.
- 2.3 To subscribe to, become a member of and co-operate with any other association, club or organisation, whether incorporated or not, whose objects are altogether or in part similar to those of this Association.
- 2.4 To acquire, take on, lease, hold, exchange, dispose of, and deal in all kinds of real and personal property and any rights or privileges which the Association may deem fit for all or any of the purposes herein.
- 2.5 To do all such acts, matters and things deemed by the Association to be conducive to, incidental or conveniently done in connection with all or any purposes herein.

3. Financial year

The financial year of the Association is each period of 12 months ending on 30 September.

4. Definitions

In these Rules—

absolute majority, of the Committee, means a majority of the committee members currently holding office and entitled to vote at the time (as distinct from a majority of committee members present at a committee meeting);

associate member means a member referred to in rule 14.1;

Chairperson, of a general meeting or committee meeting, means the person chairing the meeting as required under rule 46;

Committee means the Committee having management of the business of the Association;

committee meeting means a meeting of the Committee held in accordance with these Rules;

committee member means a member of the Committee elected or appointed under —
Division 3 of Part 5;

disciplinary appeal meeting means a meeting of the members of the Association convened under rule 25.3;

disciplinary meeting means a meeting of the Committee convened for the purposes of rule 24;

disciplinary subcommittee means the subcommittee appointed under rule 22;

executive means the President, Senior Vice-President, Junior Vice-President, Secretary and Treasurer appointed under Division 2 of Part 5;

financial year means the 12 month period specified in rule 3;

general meeting means a general meeting of the members of the Association convened in accordance with Part 4 and includes an annual general meeting, a special general meeting and a disciplinary appeal meeting;

member means a member of the Association;

member entitled to vote means a member who under rule 13.2 is entitled to vote at a general meeting;

special resolution means a resolution that requires not less than three-quarters of the members voting in person at a general meeting, to vote in favour of the resolution;

the Act means the **Associations Incorporation Reform Act 2012** and includes any regulations made under that Act;

the Registrar means the Registrar of Incorporated Associations.

PART 2—POWERS OF ASSOCIATION

5. Powers of Association

5.1 Subject to the Act, the Association has power to do all things incidental or conducive to achieve its purposes.

5.2 Without limiting subrule 5.1, the Association may—

5.2.1 acquire, hold and dispose of real or personal property;

5.2.2 open and operate accounts with financial institutions;

5.2.3 invest its money in any security in which trust monies may lawfully be invested;

5.2.4 raise and borrow money on any terms and in any manner as it thinks fit;

5.2.5 secure the repayment of money raised or borrowed, or the payment of a debt or liability;

5.2.6 appoint agents to transact business on its behalf;

5.2.7 enter into any other contract it considers necessary or desirable.

5.3 The Association may only exercise its powers and use its income and assets (including any surplus) for its purposes.

6. Not for profit organisation

6.1 The Association must not distribute any surplus, income or assets directly or indirectly to its members.

6.2 Subrule 6.1 does not prevent the Association from paying a member—

6.2.1 reimbursement for expenses properly incurred by the member; or

6.2.2 for goods or services provided by the member—

if this is done in good faith on terms no more favourable than if the member was not a member.

PART 3—MEMBERS, DISCIPLINARY PROCEDURES AND GRIEVANCES

Division 1—Membership

7. Minimum number of members

The Association must have at least 5 members.

8. Who is eligible to be a member

Any person who supports the purposes of the Association is eligible for membership.

9. Application for membership

9.1 To apply to become a member of the Association, a person must submit a written application to a committee member stating that the person—

9.1.1 wishes to become a member of the Association; and

9.1.2 supports the purposes of the Association; and

9.1.3 agrees to comply with these Rules.

9.2 The application—

9.2.1 must be signed by the applicant; and

9.2.2 may be accompanied by the joining fee.

10. Consideration of application

10.1 As soon as practicable after an application for membership is received, the Committee must decide by resolution whether to accept or reject the application.

10.2 The Committee must notify the applicant in writing of its decision as soon as practicable after the decision is made.

10.3 If the Committee rejects the application, it must return any money accompanying the application to the applicant.

10.4 No reason need be given for the rejection of an application.

11. New membership

11.1 If an application for membership is approved by the Committee—

11.1.1 the resolution to accept the membership must be recorded in the minutes of the committee meeting; and

11.1.2 the Secretary must, as soon as practicable, enter the name and address of the new member, and the date of becoming a member, in the register of members.

11.2 A person becomes a member of the Association and, subject to rule 13.2, is entitled to exercise his or her rights of membership from the date, whichever is the later, on which—

11.2.1 the Committee approves the person's membership; or

11.2.2 the person pays the joining fee.

12. Annual subscription and fee on joining

12.1 At each annual general meeting, the Association must determine—

12.1.1 the amount of the annual subscription (if any) for the following financial year; and

12.1.2 the date for payment of the annual subscription.

- 12.2 The Association may determine that a lower annual subscription is payable by associate members.
- 12.3 The Association may determine that any new member who joins after the start of a financial year must, for that financial year, pay a fee equal to—
- 12.3.1 the full annual subscription; or
- 12.3.2 a pro rata annual subscription based on the remaining part of the financial year; or
- 12.3.3 a fixed amount determined from time to time by the Association.
- 12.4 The rights of a member (including the right to vote) who has not paid the annual subscription by the due date are suspended until the subscription is paid.
- 12.5 Each member over the age of eighteen years shall upon payment of the annual subscription be issued with a numbered membership ticket.

13. General rights of members

- 13.1 A member of the Association who is entitled to vote has the right—
- 13.1.1 to receive notice of general meetings and of proposed special resolutions in the manner and time prescribed by these Rules; and
- 13.1.2 to submit items of business for consideration at a general meeting; and
- 13.1.3 to attend and be heard at general meetings; and
- 13.1.4 to vote at a general meeting; and
- 13.1.5 to have access to the minutes of general meetings and other documents of the Association as provided under rule 75; and
- 13.1.6 to inspect the register of members.
- 13.2 A member is entitled to vote if—
- 13.2.1 the member is a member other than an associate member;
- 13.2.2 more than ten business days have passed since he or she became a member of the Association; and
- 13.2.3 the member's membership rights are not suspended for any reason.

14. Associate members

- 14.1 Associate members of the Association include—
- 14.1.1 any members under the age of 18 years;
- 14.1.2 any other category of member as determined by special resolution at a general meeting.
- 14.2 An associate member must not vote but may have other rights as determined by the Committee or by resolution at a general meeting.

15. Rights not transferable

- 15.1 The rights of a member are not transferable and end when membership ceases.

16. Ceasing membership

- 16.1 The membership of a person ceases on resignation, expulsion or death.
- 16.2 If a person ceases to be a member of the Association, the Secretary must, as soon as practicable, enter the date the person ceased to be a member in the register of members.

17. Resigning as a member

- 17.1 A member may resign by notice in writing given to the Association.
- 17.2 A member is taken to have resigned if—
 - 17.2.1 the member's annual subscription is more than twelve months in arrears; or
 - 17.2.2 where no annual subscription is payable—
 - 17.2.2.1 the Secretary has made a written request to the member to confirm that he or she wishes to remain a member; and
 - 17.2.2.2 the member has not, within three months after receiving that request, confirmed in writing that he or she wishes to remain a member.

18. Register of members

- 18.1 The Secretary must keep and maintain a register of members that includes—
 - 18.1.1 for each current member—
 - 18.1.1.1 the member's name;
 - 18.1.1.2 the address for notice last given by the member;
 - 18.1.1.3 the date of becoming a member;
 - 18.1.1.4 if the member is an associate member, a note to that effect;
 - 18.1.1.5 member number;
 - 18.1.1.6 any other information determined by the Committee; and
 - 18.1.2 for each former member, the date of ceasing to be a member.
- 18.2 Any member may, at a reasonable time and free of charge, inspect the register of members.

19. Honorary Members

- 19.1 When any recognised sporting club is visiting the club all members of that visiting club and associated officials shall be deemed to be honorary members for that day. A list of visiting players, officials and umpires must be supplied to facilitate this membership and such list be kept with the register of members for the duration of their stay. Persons with this level of club membership shall have no voting rights and cannot stand for office.

20. Life Members

- 20.1 The Committee may by a two-thirds majority of its members present and voting elect any member who:
 - 20.1.1 in its opinion has rendered outstanding services to the Club, as an “Honorary Club Life Member” of the Association, provided that the member has served a minimum of fifteen years including time in a leadership role;
 - 20.1.2 has played a minimum of 200 open age games in any one sport with the Club, as an “Honorary Player Life Member” of the Association.

Division 2—Disciplinary action

21. Grounds for taking disciplinary action

- 21.1 The Association may take disciplinary action against a member in accordance with this Division if it is determined that the member—
 - 21.1.1 has failed to comply with these Rules; or

21.1.2 refuses to support the purposes of the Association; or

21.1.3 has engaged in conduct prejudicial to the Association.

22. Disciplinary subcommittee

22.1 If the Committee is satisfied that there are sufficient grounds for taking disciplinary action against a member, the Committee must appoint a disciplinary subcommittee to hear the matter and determine what action, if any, to take against the member.

22.2 The members of the disciplinary subcommittee—

22.2.1 may be Committee members, members of the Association or anyone else; but

22.2.2 must not be biased against, or in favour of, the member concerned.

23. Notice to member

23.1 Before disciplinary action is taken against a member, the Secretary must give written notice to the member—

23.1.1 stating that the Association proposes to take disciplinary action against the member; and

23.1.2 stating the grounds for the proposed disciplinary action; and

23.1.3 specifying the date, place and time of the meeting at which the disciplinary subcommittee intends to consider the disciplinary action (the disciplinary meeting); and

23.1.4 advising the member that he or she may do one or both of the following—

23.1.4.1 attend the disciplinary meeting and address the disciplinary subcommittee at that meeting;

23.1.4.2 give a written statement to the disciplinary subcommittee at any time before the disciplinary meeting; and

23.1.5 setting out the member's appeal rights under rule 25.

23.2 The notice must be given no earlier than twenty-eight days, and no later than fourteen days, before the disciplinary meeting is held.

24. Decision of subcommittee

24.1 At the disciplinary meeting, the disciplinary subcommittee must—

24.1.1 give the member an opportunity to be heard; and

24.1.2 consider any written statement submitted by the member.

24.2 After complying with subrule 1), the disciplinary subcommittee may—

24.2.1 take no further action against the member; or

24.2.2 subject to subrule 3)—

24.2.2.1 reprimand the member; or

24.2.2.2 suspend the membership rights of the member for a specified period; or

24.2.2.3 expel the member from the Association.

24.3 The disciplinary subcommittee may not fine the member.

24.4 The suspension of membership rights or the expulsion of a member by the disciplinary subcommittee under this rule takes effect immediately after the vote is passed.

25. Appeal rights

- 25.1 A person whose membership rights have been suspended or who has been expelled from the Association under rule 24 may give notice to the effect that he or she wishes to appeal against the suspension or expulsion.
- 25.2 The notice must be in writing and given—
- 25.2.1 to the disciplinary subcommittee immediately after the vote to suspend or expel the person is taken; or
- 25.2.2 to the Secretary not later than 48 hours after the vote.
- 25.3 If a person has given notice under subrule 25.2, a disciplinary appeal meeting must be convened by the Committee as soon as practicable, but in any event not later than 21 days, after the notice is received.
- 25.4 Notice of the disciplinary appeal meeting must be given to each member of the Association who is entitled to vote as soon as practicable and must—
- 25.4.1 specify the date, time and place of the meeting; and
- 25.4.2 state—
- 25.4.2.1 the name of the person against whom the disciplinary action has been taken; and
- 25.4.2.2 the grounds for taking that action; and
- 25.4.2.3 that at the disciplinary appeal meeting the members present must vote on whether the decision to suspend or expel the person should be upheld or revoked.

26. Conduct of disciplinary appeal meeting

- 26.1 At a disciplinary appeal meeting—
- 26.1.1 no business other than the question of the appeal may be conducted; and
- 26.1.2 the Committee must state the grounds for suspending or expelling the member and the reasons for taking that action; and
- 26.1.3 the person whose membership has been suspended or who has been expelled must be given an opportunity to be heard.
- 26.2 After complying with subrule 26.1, the members present and entitled to vote at the meeting must vote by secret ballot on the question of whether the decision to suspend or expel the person should be upheld or revoked.
- 26.3 A member may not vote by proxy at the meeting.
- 26.4 The decision is upheld if not less than three quarters of the members voting at the meeting vote in favour of the decision.

Division 3—Grievance procedure

27. Application

- 27.1 The grievance procedure set out in this Division applies to disputes under these Rules between—
- 27.1.1 a member and another member;
- 27.1.2 a member and the Committee;

27.1.3 a member and the Association.

27.2 A member must not initiate a grievance procedure in relation to a matter that is the subject of a disciplinary procedure until the disciplinary procedure has been completed.

28. Parties must attempt to resolve the dispute

28.1 The parties to a dispute must attempt to resolve the dispute between themselves within fourteen days of the dispute coming to the attention of each party.

29. Appointment of mediator

29.1 If the parties to a dispute are unable to resolve the dispute between themselves within the time required by rule 28, the parties must within ten days—

29.1.1 notify the Committee of the dispute; and

29.1.2 agree to or request the appointment of a mediator; and

29.1.3 attempt in good faith to settle the dispute by mediation.

29.2 The mediator must be—

29.2.1 a person chosen by agreement between the parties; or

29.2.2 in the absence of agreement—

29.2.2.1 if the dispute is between a member and another member—a person appointed by the Committee; or

29.2.2.2 if the dispute is between a member and the Committee or the Association—a person appointed or employed by the Dispute Settlement Centre of Victoria.

29.3 A mediator appointed by the Committee may be a member or former member of the Association but in any case must not be a person who—

29.3.1 has a personal interest in the dispute; or

29.3.2 is biased in favour of or against any party.

30. Mediation process

30.1 The mediator to the dispute, in conducting the mediation, must—

30.1.1 give each party every opportunity to be heard; and

30.1.2 allow due consideration by all parties of any written statement submitted by any party; and

30.1.3 ensure that natural justice is accorded to the parties throughout the mediation process.

30.2 The mediator must not determine the dispute.

31. Failure to resolve dispute by mediation

31.1 If the mediation process does not resolve the dispute, the parties may seek to resolve the dispute in accordance with the Act or otherwise at law.

PART 4—GENERAL MEETINGS OF THE ASSOCIATION

32. Annual general meetings

32.1 The Committee must convene an annual general meeting of the Association to be held within two months after the end of each financial year.

- 32.2 Despite subrule 32.1, the Association may hold its first annual general meeting at any time within eighteen months after its incorporation.
- 32.3 The Committee may determine the date, time and place of the annual general meeting.
- 32.4 The ordinary business of the annual general meeting is as follows—
- 32.4.1 to confirm the minutes of the previous annual general meeting and of any special general meeting held since then;
- 32.4.2 to receive and consider—
- 32.4.2.1 the annual report of the Committee on the activities of the Association during the preceding financial year; and
- 32.4.2.2 the financial statements of the Association for the preceding financial year submitted by the Committee in accordance with Part 7 of the Act;
- 32.4.3 to elect the members of the Committee;
- 32.4.4 to confirm or vary the amounts (if any) of the annual subscription and joining fee.
- 32.4.5 to appoint an auditor for the forthcoming year.
- 32.5 The annual general meeting may also conduct any other business of which notice has been given in accordance with these Rules.

33. Special general meetings

- 33.1 Any general meeting of the Association, other than an annual general meeting or a disciplinary appeal meeting, is a special general meeting.
- 33.2 The Committee may convene a special general meeting whenever it thinks fit.
- 33.3 No business other than that set out in the notice under rule 35 may be conducted at the meeting.

34. Special general meeting held at request of members

- 34.1 The Committee must convene a special general meeting if a request to do so is made in accordance with subrule 34.2 by at least 10% of the total number of members.
- 34.2 A request for a special general meeting must—
- 34.2.1 be in writing; and
- 34.2.2 state the business to be considered at the meeting and any resolutions to be proposed; and
- 34.2.3 include the names and signatures of the members requesting the meeting; and
- 34.2.4 be given to the Secretary.
- 34.3 If the Committee does not convene a special general meeting within one month after the date on which the request is made, the members making the request (or any of them) may convene the special general meeting.
- 34.4 A special general meeting convened by members under subrule 34.3 —
- 34.4.1 must be held within three months after the date on which the original request was made; and
- 34.4.2 may only consider the business stated in that request.
- 34.5 The Association must reimburse all reasonable expenses incurred by the members convening a special general meeting under subrule 34.3.

35. Notice of general meetings

- 35.1 The Secretary (or, in the case of a special general meeting convened under rule 34.3, the members convening the meeting) must give to each member of the Association —
 - 35.1.1 at least twenty-one days' notice of a general meeting if a special resolution is to be proposed at the meeting; or
 - 35.1.2 at least fourteen days' notice of a general meeting in any other case.
- 35.2 The notice must—
 - 35.2.1 specify the date, time and place of the meeting; and
 - 35.2.2 indicate the general nature of each item of business to be considered at the meeting; and
 - 35.2.3 if a special resolution is to be proposed—
 - 35.2.3.1 state in full the proposed resolution; and
 - 35.2.3.2 state the intention to propose the resolution as a special resolution.
- 35.3 This rule does not apply to a disciplinary appeal meeting.

36. Quorum at general meetings

- 36.1 No business may be conducted at a general meeting unless a quorum of members is present.
- 36.2 The quorum for a general meeting is the presence of 10% of the members entitled to vote.
- 36.3 If a quorum is not present within thirty minutes after the notified commencement time of a general meeting—
 - 36.3.1 in the case of a meeting convened by, or at the request of, members under rule 34, the meeting must be dissolved;
 - 36.3.2 in any other case—
 - 36.3.2.1 the meeting must be adjourned to a date not more than twenty-one days after the adjournment; and
 - 36.3.2.2 notice of the date, time and place to which the meeting is adjourned must be given at the meeting and confirmed by written notice given to all members as soon as practicable after the meeting.
- 36.4 If a quorum is not present within thirty minutes after the time to which a general meeting has been adjourned under subrule 36.3.2, the members present at the meeting (if not fewer than three) may proceed with the business of the meeting as if a quorum were present.

37. Adjournment of general meeting

- 37.1 The Chairperson of a general meeting at which a quorum is present may, with the consent of a majority of members present at the meeting, adjourn the meeting to another time at the same place or at another place.
- 37.2 Without limiting subrule 37.1, a meeting may be adjourned—
 - 37.2.1 if there is insufficient time to deal with the business at hand; or
 - 37.2.2 to give the members more time to consider an item of business.
- 37.3 No business may be conducted on the resumption of an adjourned meeting other than the business that remained unfinished when the meeting was adjourned.

37.4 Notice of the adjournment of a meeting under this rule is not required unless the meeting is adjourned for fourteen days or more, in which case notice of the meeting must be given in accordance with rule 35.

38. Voting at general meeting

38.1 On any question arising at a general meeting—

38.1.1 subject to subrule 38.3, each member who is entitled to vote has one vote;

38.1.2 all votes shall be given personally;

38.1.3 voting by proxy is not permitted;

38.1.4 except in the case of a special resolution, the question must be decided on a majority of votes.

38.2 If votes are divided equally on a question, the Chairperson of the meeting has a second or casting vote.

38.3 If the question is whether or not to confirm the minutes of a previous meeting, only members who were present at that meeting may vote.

38.4 This rule does not apply to a vote at a disciplinary appeal meeting conducted under rule 26.

39. Special resolutions

39.1 A special resolution is passed if not less than three-quarters of the members voting at a general meeting vote in favour of the resolution.

40. Determining whether resolution carried

40.1 Subject to subsection 40.2, the Chairperson of a general meeting may, on the basis of a show of hands, declare that a resolution has been—

40.1.1 carried; or

40.1.2 carried unanimously; or

40.1.3 carried by a particular majority; or

40.1.4 lost—

and an entry to that effect in the minutes of the meeting is conclusive proof of that fact.

40.2 If a poll (where votes are cast in writing) is demanded by three or more members on any question—

40.2.1 the poll must be taken at the meeting in the manner determined by the Chairperson of the meeting; and

40.2.2 the Chairperson must declare the result of the resolution on the basis of the poll.

40.3 A poll demanded on the election of the Chairperson or on a question of an adjournment must be taken immediately.

40.4 A poll demanded on any other question must be taken before the close of the meeting at a time determined by the Chairperson.

41. Minutes of general meeting

41.1 The Committee must ensure that minutes are taken and kept of each general meeting.

41.2 The minutes must record the business considered at the meeting, any resolution on which a vote is taken and the result of the vote.

41.3 In addition, the minutes of each annual general meeting must include—

41.3.1 the names of the members attending the meeting; and

- 41.3.2 the financial statements submitted to the members in accordance with rule 32.4.2.2; and
- 41.3.3 the certificate signed by two committee members certifying that the financial statements give a true and fair view of the financial position and performance of the Association; and
- 41.3.4 any audited accounts and auditor's report or report of a review accompanying the financial statements that are required under the Act.

PART 5—COMMITTEE

Division 1—Powers of Committee

42. Role and powers

- 42.1 The business of the Association must be managed by or under the direction of a Committee.
- 42.2 The Committee may exercise all the powers of the Association except those powers that these Rules or the Act require to be exercised by general meetings of the members of the Association.
- 42.3 The Committee may—
 - 42.3.1 appoint and remove staff;
 - 42.3.2 establish subcommittees consisting of members with terms of reference it considers appropriate; such subcommittees shall periodically report their proceedings to the Committee and shall conduct their business in accordance with the directions of the Committee.
 - 42.3.3 co-opt two extra members to the committee to provide experience and expertise as the committee deems necessary.

43. Delegation

- 43.1 The Committee may delegate to a member of the Committee, a subcommittee or staff, any of its powers and functions other than—
 - 43.1.1 this power of delegation; or
 - 43.1.2 a duty imposed on the Committee by the Act or any other law.
- 43.2 The delegation must be in writing and may be subject to the conditions and limitations the Committee considers appropriate.
- 43.3 The Committee may, in writing, revoke a delegation wholly or in part.

Division 2—Composition of Committee and duties of members

44. Composition of Committee

- 44.1 The Committee consists of—
 - 44.1.1 executive—
 - 44.1.1.1 a President; and
 - 44.1.1.2 a Senior Vice-President; and
 - 44.1.1.3 a Junior Vice-President; and

- 44.1.1.4 a Secretary; and
- 44.1.1.5 a Treasurer; and
- 44.1.2 10 ordinary members, provided that those ordinary members must consist of at least one representative from each sport encompassed by the Club.

45. General Duties

- 45.1 As soon as practicable after being elected or appointed to the Committee, each committee member must become familiar with these Rules and the Act.
- 45.2 The Committee is collectively responsible for ensuring that the Association complies with the Act and that individual members of the Committee comply with these Rules.
- 45.3 Committee members must exercise their powers and discharge their duties with reasonable care and diligence.
- 45.4 Committee members must exercise their powers and discharge their duties—
 - 45.4.1 in good faith in the best interests of the Association; and
 - 45.4.2 for a proper purpose.
- 45.5 Committee members and former committee members must not make improper use of—
 - 45.5.1 their position; or
 - 45.5.2 information acquired by virtue of holding their position—
so as to gain an advantage for themselves or any other person or to cause detriment to the Association.
- 45.6 In addition to any duties imposed by these Rules, a committee member must perform any other duties imposed from time to time by resolution at a general meeting.

46. President and Vice-President

- 46.1 Subject to subrule 46.2, the President or, in the President's absence, the Senior Vice-President is the Chairperson for any general meetings and for any committee meetings, or in the Senior Vice-President's absence, the Junior Vice-President is the Chairperson for any general meetings and for any committee meetings.
- 46.2 If any of the President, the Senior Vice-President, or the Junior Vice-President, are absent, or are unable to preside, the Chairperson of the meeting must be—
 - 46.2.1 in the case of a general meeting—a member elected by the other members present; or
 - 46.2.2 in the case of a committee meeting—a committee member elected by the other committee members present.

47. Secretary

- 47.1 The Secretary must perform any duty or function required under the Act to be performed by the secretary of an incorporated association.
- 47.2 The Secretary must—
 - 47.2.1 maintain the register of members in accordance with rule 18; and
 - 47.2.2 keep custody of the common seal (if any) of the Association and, except for the financial records referred to in rule 70.3, all books, documents and securities of the Association in accordance with rules 72 and 75; and
 - 47.2.3 subject to the Act and these Rules, provide members with access to the register of members, the minutes of general meetings and other books and documents; and

- 47.2.4 perform any other duty or function imposed on the Secretary by these Rules.
- 47.3 The Secretary must give to the Registrar notice of his or her appointment within fourteen days after the appointment.
- 48. Treasurer**
- 48.1 The Treasurer must—
- 48.1.1 receive all moneys paid to or received by the Association and issue receipts for those moneys in the name of the Association; and
- 48.1.2 ensure that all moneys received are paid into the account of the Association within five working days after receipt; and
- 48.1.3 make any payments authorised by the committee or by a general meeting of the Association from the Association's funds; and
- 48.1.4 ensure cheques are signed by at least two executive members.
- 48.2 The Treasurer must—
- 48.2.1 ensure that the financial records of the Association are kept in accordance with the Act; and
- 48.2.2 coordinate the preparation of the financial statements of the Association and their certification by the Committee prior to their submission to the annual general meeting of the Association.
- 48.3 The Treasurer must ensure that at least one other committee member has access to the accounts and financial records of the Association.

Division 3—Election of Committee members and tenure of office

49. Who is eligible to be a Committee member

- 49.1 A member is eligible to be elected or appointed as a committee member if the member—
- 49.1.1 is eighteen years or over; and
- 49.1.2 is entitled to vote at a general meeting.

50. Positions to be declared vacant

- 50.1 This rule applies to—
- 50.1.1 the first annual general meeting of the Association after its incorporation; or
- 50.1.2 any subsequent annual general meeting of the Association, after the annual report and financial statements of the Association have been received.
- 50.2 The Chairperson of the meeting must declare all positions on the Committee vacant and hold elections for those positions in accordance with rules 51 to 54.

51. Nominations

- 51.1 Nominations of candidates for election as executive or as ordinary members of the Committee:
- 51.1.1 shall be made in writing, signed by two members of the Association who are eligible to vote and accompanied by the written consent of the candidate (which may be endorsed on the form of nomination); and
- 51.1.2 shall be delivered to the secretary of the Association not less than seven days before the date fixed for the holding of the annual general meeting.

- 51.2 A member may nominate for more than one office at the same election provided that upon their election to any position all other nominations by them for other positions shall immediately lapse and shall be of no effect.
- 51.3 The names of persons proposed for election as members of the committee of the club shall be displayed in a conspicuous place in the club premises for not less than one week before the date of the election.
- 51.4 A member who is nominated for a position and fails to be elected to that position at the annual general meeting may be nominated for any other position for which an election is yet to be held if there are no other prior nominations for that position.

52. Election of executive

- 52.1 At the annual general meeting, separate elections must be held for each of the following positions—
- 52.1.1 President;
 - 52.1.2 Senior Vice-President;
 - 52.1.3 Junior Vice President;
 - 52.1.4 Secretary;
 - 52.1.5 Treasurer.
- 52.2 If only one member is nominated for the position, the Chairperson of the meeting must declare the member elected to the position.
- 52.3 If more than one member is nominated, a ballot must be held in accordance with rule 54.
- 52.4 On his or her election, the new President may take over as Chairperson of the meeting.

53. Election of ordinary members

- 53.1 A single election may be held to fill all of those positions.
- 53.2 If the number of members nominated for the position of ordinary committee member is equal to the number to be elected, the Chairperson of the meeting must declare each of those members to be elected to the position.
- 53.3 If the number of members nominated for the position of ordinary committee member is less than the number to be elected, the Chairperson of the meeting must declare each of those members to be elected to the position, and further nominations for any vacant positions shall be received at the annual general meeting.
- 53.4 If the number of members nominated exceeds the number to be elected, a ballot must be held in accordance with rule 54.

54. Ballot

- 54.1 If a ballot is required for the election for a position, the Chairperson of the meeting must appoint a member to act as returning officer to conduct the ballot.
- 54.2 The returning officer must not be a member nominated for the position.
- 54.3 Before the ballot is taken, each candidate may make a short speech in support of his or her election.
- 54.4 The election must be by secret ballot.
- 54.5 Voting by proxy is not permitted.
- 54.6 The returning officer must give a blank piece of paper to each member present in person.

- 54.7 If the ballot is for a single position, the voter must write on the ballot paper the name of the candidate for whom they wish to vote.
- 54.8 If the ballot is for more than one position—
- 54.8.1 the voter must write on the ballot paper the name of each candidate for whom they wish to vote;
- 54.8.2 the voter must not write the names of more candidates than the number to be elected.
- 54.9 Ballot papers that do not comply with subrule 54.8.2 are not to be counted.
- 54.10 Each ballot paper on which the name of a candidate has been written counts as one vote for that candidate.
- 54.11 The returning officer must declare elected the candidate or, in the case of an election for more than one position, the candidates who received the most votes.
- 54.12 If the returning officer is unable to declare the result of an election under subrule 54.11 because two or more candidates received the same number of votes, the returning officer must—
- 54.12.1 conduct a further election for the position in accordance with subrules 54.4 to 54.11 to decide which of those candidates is to be elected; or
- 54.12.2 with the agreement of those candidates, decide by lot which of them is to be elected.

55. Term of office

- 55.1 Subject to subrule 55.3 and rule 56, a committee member holds office until the positions of the Committee are declared vacant at the next annual general meeting.
- 55.2 A committee member may be re-elected.
- 55.3 A general meeting of the Association may—
- 55.3.1 by special resolution remove a committee member from office; and
- 55.3.2 elect an eligible member of the Association to fill the vacant position in accordance with this Division.
- 55.4 A member who is the subject of a proposed special resolution under subrule 55.3.1 may make representations in writing to the Secretary or President of the Association (not exceeding a reasonable length) and may request that the representations be provided to the members of the Association.
- 55.5 The Secretary or the President may give a copy of the representations to each member of the Association or, if they are not so given, the member may require that they be read out at the meeting at which the special resolution is to be proposed.

56. Vacation of office

- 56.1 A committee member may resign from the Committee by written notice addressed to the Committee.
- 56.2 A person ceases to be a committee member if he or she—
- 56.2.1 ceases to be a member of the Association; or
- 56.2.2 fails to attend three consecutive committee meetings (other than special or urgent committee meetings) without leave of absence under rule 67; or
- 56.2.3 otherwise ceases to be a committee member by operation of section 78 of the Act.

57. Filling casual vacancies

- 57.1 The Committee may appoint an eligible member of the Association to fill a position on the Committee that—
- 57.1.1 has become vacant under rule 56; or
- 57.1.2 was not filled by election at the last annual general meeting.
- 57.2 If the position of Secretary becomes vacant, the Committee must appoint a member to the position within fourteen days after the vacancy arises.
- 57.3 Rule 55 applies to any committee member appointed by the Committee under subrule 57.1 or 57.2.
- 57.4 The Committee may continue to act despite any vacancy in its membership.

Division 4—Meetings of Committee

58. Meetings of Committee

- 58.1 The Committee must meet once in every month at the dates, times and places determined by the Committee, and at such other times as the Committee may determine.
- 58.2 The date, time and place of the first committee meeting must be determined by the members of the Committee as soon as practicable after the annual general meeting of the Association at which the members of the Committee were elected.
- 58.3 Special committee meetings may be convened by the President or by any four members of the Committee.

59. Notice of meetings

- 59.1 Notice of each committee meeting must be given to each committee member no later than seven days before the date of the meeting.
- 59.2 Notice may be given of more than one committee meeting at the same time.
- 59.3 The notice must state the date, time and place of the meeting.
- 59.4 If a special committee meeting is convened, the notice must include the general nature of the business to be conducted.
- 59.5 The only business that may be conducted at the meeting is the business for which the meeting is convened. If time permits, other business may be conducted at the discretion of the Chairperson and a two-thirds majority of committee members present at the meeting.

60. Urgent meetings

- 60.1 In cases of urgency, a meeting can be held without notice being given in accordance with rule 59 provided that as much notice as practicable is given to each committee member by the quickest means practicable.
- 60.2 Any resolution made at the meeting must be passed by an absolute majority of the Committee.
- 60.3 The only business that may be conducted at an urgent meeting is the business for which the meeting is convened.

61. Procedure and order of business

- 61.1 The procedure to be followed at a meeting of a Committee must be determined from time to time by the Committee.

61.2 The order of business may be determined by the members present at the meeting.

62. Use of technology

62.1 A committee member who is not physically present at a committee meeting may participate in the meeting by the use of technology that allows that committee member and the committee members present at the meeting to clearly and simultaneously communicate with each other.

62.2 For the purposes of this Part, a committee member participating in a committee meeting as permitted under subrule 62.1 is taken to be present at the meeting and, if the member votes at the meeting, is taken to have voted in person.

63. Quorum

63.1 No business may be conducted at a Committee meeting unless a quorum is present.

63.2 The quorum for a committee meeting is the presence (in person or as allowed under rule 62) of a majority of the committee members holding office.

63.3 If a quorum is not present within 30 minutes after the notified commencement time of a committee meeting—

63.3.1 in the case of a special meeting—the meeting lapses;

63.3.2 in any other case—the meeting must be adjourned to a date no later than fourteen days after the adjournment and notice of the time, date and place to which the meeting is adjourned must be given in accordance with rule 59.

64. Voting

64.1 On any question arising at a committee meeting, each committee member present at the meeting has one vote.

64.2 A motion is carried if a majority of committee members present at the meeting vote in favour of the motion.

64.3 Subrule 64.2 does not apply to any motion or question which is required by these Rules to be passed by an absolute majority of the Committee.

64.4 If votes are divided equally on a question, the Chairperson of the meeting has a second or casting vote.

64.5 Voting by proxy is not permitted.

65. Conflict of interest

65.1 A committee member who has a material personal interest in a matter being considered at a committee meeting must disclose the nature and extent of that interest to the Committee.

65.2 The member—

65.2.1 must not be present while the matter is being considered at the meeting; and

65.2.2 must not vote on the matter.

65.3 This rule does not apply to a material personal interest—

65.3.1 that exists only because the member belongs to a class of persons for whose benefit the Association is established; or

65.3.2 that the member has in common with all, or a substantial proportion of, the members of the Association.

66. Minutes of meeting

66.1 The Committee must ensure that minutes are taken and kept of each committee meeting.

- 66.2 The minutes must record the following—
- 66.2.1 the names of the members in attendance at the meeting;
 - 66.2.2 the business considered at the meeting;
 - 66.2.3 any resolution on which a vote is taken and the result of the vote;
 - 66.2.4 any material personal interest disclosed under rule 65.

67. Leave of absence

- 67.1 The Committee may grant a committee member leave of absence from committee meetings for a period not exceeding three months.
- 67.2 The Committee must not grant leave of absence retrospectively unless it is satisfied that it was not feasible for the committee member to seek the leave in advance.

PART 6—FINANCIAL MATTERS

68. Source of funds

- 68.1 The funds of the Association may be derived from joining fees, annual subscriptions, donations, fund-raising activities, grants, interest and any other sources approved by the Committee.

69. Management of funds

- 69.1 The Association must open an account with a financial institution from which all expenditure of the Association is made and into which all of the Association's revenue is deposited.
- 69.2 Subject to any restrictions imposed by a general meeting of the Association, the Committee may approve expenditure on behalf of the Association.
- 69.3 The Committee may authorise the Treasurer to expend funds on behalf of the Association (including by electronic funds transfer) up to a specified limit and to nominated preferred suppliers without requiring approval from the Committee for each item on which the funds are expended.
- 69.4 All cheques, drafts, bills of exchange, promissory notes and other negotiable instruments must be signed by two executive members.
- 69.5 All funds of the Association must be deposited into the financial account of the Association no later than five working days after receipt.
- 69.6 With the approval of the Committee, the Treasurer may maintain a cash float provided that all money paid from or paid into the float is accurately recorded at the time of the transaction.

70. Financial records

- 70.1 The Association must keep financial records that—
 - 70.1.1 correctly record and explain its transactions, financial position and performance; and
 - 70.1.2 enable financial statements to be prepared as required by the Act.
- 70.2 The Association must retain the financial records for seven years after the transactions covered by the records are completed.
- 70.3 The Treasurer must keep in his or her custody, or under his or her control—
 - 70.3.1 the financial records for the current financial year; and
 - 70.3.2 any other financial records as authorised by the Committee.

71. Financial statements

- 71.1 For each financial year, the Committee must ensure that the requirements under the Act relating to the financial statements of the Association are met.
- 71.2 Without limiting subrule 71.1, those requirements include—
- 71.2.1 the preparation of the financial statements;
 - 71.2.2 if required, the review or auditing of the financial statements;
 - 71.2.3 the certification of the financial statements by the Committee;
 - 71.2.4 the submission of the financial statements to the annual general meeting of the Association;
 - 71.2.5 the lodgement with the Registrar of the financial statements and accompanying reports, certificates, statements and fee.

PART 7—GENERAL MATTERS

72. Common seal

- 72.1 The Association may have a common seal.
- 72.2 If the Association has a common seal—
- 72.2.1 the name of the Association must appear in legible characters on the common seal;
 - 72.2.2 a document may only be sealed with the common seal by the authority of the Committee and the sealing must be witnessed by the signatures of two committee members;
 - 72.2.3 the common seal must be kept in the custody of the Secretary.

73. Registered address

- 73.1 The registered address of the Association is—
- 73.1.1 the address determined from time to time by resolution of the Committee; or
 - 73.1.2 if the Committee has not determined an address to be the registered address—the postal address of the Secretary.

74. Notice requirements

- 74.1 Any notice required to be given to a member or a committee member under these Rules may be given—
- 74.1.1 by handing the notice to the member personally; or
 - 74.1.2 by sending it by post to the member at the address recorded for the member on the register of members; or
 - 74.1.3 by email or facsimile transmission.
- 74.2 Subrule 74.1 does not apply to notice given under rule 60.
- 74.3 Any notice required to be given to the Association or the Committee may be given—
- 74.3.1 by handing the notice to a member of the Committee; or
 - 74.3.2 by sending the notice by post to the registered address; or
 - 74.3.3 by leaving the notice at the registered address; or

- 74.3.4 if the Committee determines that it is appropriate in the circumstances—
- 74.3.4.1 by email to the email address of the Association or the Secretary; or
- 74.3.4.1 by facsimile transmission to the facsimile number of the Association.

75. Custody and inspection of books and records

- 75.1 Members may on request inspect free of charge—
 - 75.1.1 the register of members;
 - 75.1.2 the minutes of general meetings;
 - 75.1.3 subject to subrule 75.2, the financial records, books, securities and any other relevant document of the Association, including minutes of Committee meetings.
- 75.2 The Committee may refuse to permit a member to inspect records of the Association that relate to confidential, personal, employment, commercial or legal matters or where to do so may be prejudicial to the interests of the Association.
- 75.3 The Committee must on request make copies of these rules available to members and applicants for membership free of charge.
- 75.4 Subject to subrule 75.2, a member may make a copy of any of the other records of the Association referred to in this rule and the Association may charge a reasonable fee for provision of a copy of such a record.
- 75.5 For purposes of this rule—

relevant documents means the records and other documents, however compiled, recorded or stored, that relate to the incorporation and management of the Association and includes the following—

 - a) its membership records;
 - b) its financial statements;
 - c) its financial records;
 - d) records and documents relating to transactions, dealings, business or property of the Association.

76. Sale of liquor

- 76.1 No liquor shall be sold or supplied to any person under the age of eighteen years.
- 76.2 Liquor shall only be sold to members who have been issued with a current numbered membership ticket and to honorary members in accordance with rule 19 and to visitors in accordance to subrule 76.5.
- 76.3 A visitors book shall be provided and maintained within the entrance to the Licensed Premises. The visitors book shall be produced for inspection upon demand by a member of police or any person authorised by the Liquor Control Reform Act.
- 76.4 No person under the age of eighteen years shall serve behind the bar.
- 76.5 A visitor shall not be admitted to the Association's licensed premises unless such visitor is a guest in the company of a member of the club over the age of eighteen years and shall have been introduced by that member and such visitors name appears in the Association's visitors' book opposite the members own name (written legibly) and club membership number (when applicable) on the day applicable.

- 76.6 These rules preclude the payment or part payment of any Secretary, Manager, or other officer or servant of the Association by way of commission or allowance from or upon the receipts of the Club for liquor supplied.
- 76.7 The supply of liquor to the Association shall be under the control of the Committee. The Committee shall have the power and it shall be its duty to take such action as may be necessary to enforce and secure compliance by the members and all other persons coming upon the Association's premises with the Rules of the Association, and with conformity with the provisions of the Liquor Control Reform Act.
- 76.8 No liquor shall be sold or disposed of or consumed on the Association's premises except between the hours provided by any licence issued under the provisions of the Liquor Control Reform Act.

77. Winding up and cancellation

- 77.1 The Association may be wound up voluntarily by special resolution.
- 77.2 In the event of the winding up or the cancellation of the incorporation of the Association, the surplus assets of the Association must not be distributed to any members or former members of the Association.
- 77.3 Subject to the Act and any court order made under section 133 of the Act, the surplus assets must be given to a body that has similar purposes to the Association and which is not carried on for the profit or gain of its individual members.
- 77.4 The body to which the surplus assets are to be given must be decided by special resolution.

78. Alteration of Rules

- 78.1 These Rules may only be altered by special resolution of a general meeting of the Association.
