

2017 Financial Statements

- Audited Financial Statements sent to PGAs 30 April 2018
- 3rd annual audit under company Pacific Games Council Ltd
- Incorporated in Cook Islands 20 January 2015 following resolutions of the 2014 General Assembly in Port Moresby
- Recognises each PGA has been issued with a \$20 limited liability share, paid up share capital equates to \$440
- Pacific Games Council Limited assumed all assets and liabilities of former entity, Pacific Games Council

Auditors Report for 2017 Rapport D 'Audit

- Scope of Audit
- "We have audited the accompanying financial statements of Pacific Games Council Limited which comprise the statement of financial position as at 31 December 2017, and the statement of comprehensive income, statement of changes in equity and statement of cash flows for the year then ended, and a summary of significant accounting policies and other explanatory notes"

- > 2017 Income \$460,846
 - \$237,175 in 2016
 - All VAN2017 payments made in 2017
- 2017 Expenditure \$240,274
 - \$257,693 in 2016
 - Lower AGM cost in 2017 (Games year)
- 2017 Surplus \$253,975
 - \$14,533 in 2016
- 2017 Equity \$1,470,665
 - > \$1,216,690 in 2016
 - Cash & cash equivalents of \$1,574, 953

Budget 2018-2022

- Executive Board maintains a five year forward budget
 - Cash Flows revised twice each year by Executive Board
- Income/Expenditure 2018-2022
 - Locked into four year revenue streams for Pacific (& Mini) Games
 - Maintaining low overhead expenditure base with Secretariat
 - For 2018 on target to achieve balanced budget





RESERVES

- Council Reserves
 - Constitutional Recognition of Reserves in 2014 Article 16.2.n
 - Required to set Reserve if less than 4 years expenditures (\$1,253,865 total, from 2014 - 2017)
 - 2014 General Assembly Agreed to a \$600,000 Reserve (53%)
 2015 Increased to \$700,000
 - 2016 Increased to \$740,000
 - 2017 Increased to \$784,000 (61%)



Reserve to be increased to \$984,000 in 2018 based on Council's strong surplus achieved in 2017 (78% of target)



Protocol 7 Penalty Fees: 2015

- \$153,000 in 2015 Pacific Games penalties were levied and payable by 19 PGAs
- \$60,000 paid by 13 PGAs & transferred to POM2015 GOC
- \$93,000 remains outstanding from 6 PGAs who in 2016 signed acknowledgement letters with recovery options
- PGAs agreed to settle no later than 2019 Pacific Games
- PGAs bidding to host Games must pay their penalty fees

CHARTER AMENDMENT PROPOSALS



- Circulated 15 March 2018
 - 1. Associate & Life Membership : Articles 3, 5, 13
 - Creates an Associate Membership category (Executive Board confers)



- Creates a Life Membership category (2/3 majority General Assembly)
- Fiji PGA amendment re Associate Membership: "that any such decision by the Executive Board should be ratified at the next General Assembly"
- Executive Board endorsed Fiji PGA amendment

CHARTER AMENDMENT PROPOSALS



- Circulated 15 March 2018
- 2. Technical Appeals: Article 29 Dispute Resolution
 - Remove Technical (Field of Play) Appeals to Disputes Tribunal, as they are best the jurisdiction of the IFs



- In line with IOC and CGF practice, but reserving right of Executive Board to intervene as necessary
- Fiji PGA amendment: 'the rulings and decisions of the IFs on technical matters must be immediately communicated to the Executive Board with all supporting documentation"
- Executive Board endorsed Fiji PGA amendment

CHARTER AMENDMENT PROPOSALS

3. New Proposal from Executive Board



- Submission from Rugby League International Federation
- Addition of Women's Event to Article 23.2
- Last sport in the Charter offered only for Men
- Pacific teams at 2017 Rugby League Women's World Cup
- 90 days notice not provided so as per Article 30.2 requires2/3 majority to allow motion to be considered
