

## **Diamond Valley Netball Club Inc Registration and Player Fees Policy**

### **1. Registration**

1.1 Players must pay the registration fees set by Netball Victoria via the [mynetball.com.au](http://mynetball.com.au) website at the start of each calendar year before they are eligible to play any Competition Games.

1.2 Competition Games includes, but is not limited to:

- (a) Tuesday, Thursday and Saturday competitions operated by the Banyule & Districts Netball Association (**BDNA**); and
- (b) any representative netball games, including but not limited to, BDNA.

### **2. Player Fees**

2.1 Players are required to pay the fees set by Diamond Valley Netball Club Inc (**DVNC**) by the due date.

2.2 All players will be charged fees at the rates set by the DVNC Committee each season for the following items:

- (a) court hire for training
- (b) match fees
- (c) team registration fee
- (d) coaching fee
- (e) equipment/administration charge
- (f) team insurance (Thursday evening Open competition only)

2.3 Players will be advised of their fees and the due date for payment by email or sms.

2.4 Players will be required to log on to [mynetball.com.au](http://mynetball.com.au) to pay their fees by credit card. If any player does not have a credit card or is unable to process their fees via the [mynetball.com.au](http://mynetball.com.au) website, they must make contact with the DVNC Treasurer via email ([diamondvalleync@gmail.com](mailto:diamondvalleync@gmail.com)) to agree on alternative payment arrangements.

2.5 In the event of significant injury or illness, if a player is absent from playing matches and training, the player may make a written request to DVNC for their fees to be pro rated for the absence at the end of the season. It is at the discretion of the Committee whether to pro rata the fees and provide a refund to the player. The Committee will not consider pro rating fees because a player withdraws from playing or training part way through a season. The Committee may also request a medical certificate to support the request.

2.6 Teams that make finals (13U and above) will be required to pay BDNA separately for their finals match fees. It is the responsibility of the team manager to collect the cash and pay the office prior to the match being played.

### **3. Payment Plans**

3.1 If a player is unable to pay their fees by the due date, they must contact the DVNC Treasurer to arrange a payment plan no later than 7 days before the due date.

### **4. Consequences for non-payment of fees**

4.1 If a player has not paid their fees or entered into a payment plan with the DVNC by the due date the fees were payable, the player and their coach will be advised that the player will not be eligible to play any matches until they have either paid their fees or entered into to a payment plan with DVNC.

4.2 If a player enters into a payment plan and then fails to make the payments by the date/s agreed, the player will be notified that the player will not be eligible to play any matches until they have paid the outstanding fees in accordance with the payment plan.

4.3 To be eligible to play finals, all players (including those who have entered into a payment plan) must have paid their fees in full by the end of the ordinary season rounds. A player who has not paid all player fees by this time will not be permitted to play finals.

4.4 DVNC reserves the right to refuse to:

- (a) process any player transfers;
  - (b) enrol any player in a team;
  - (c) permit a player to play finals; or
  - (d) permit the player to participate in the end-of-season function;
- until all outstanding fees have been paid in full.
