## CONTRACT TO PARTICIPATE IN MOTORCYCLE SPORTING EVENTS AND /OR/ACTIVITY:

### **ACKNOWLEDGEMENT OF RISKS, DANGERS AND OBLIGATIONS:**

I **ACKNOWLEDGE** that the sport of motorcycling is dangerous and that by engaging in the sport and participating in the race meeting I understand that I am exposed to certain risks and dangers and I am under certain obligations to follow:

- That I may be injured physically, mentally and/or even death.
- That my machinery or equipment may be damaged, lost or destroyed.
- That, other competitors may ride dangerously or with lack of skill.
- That the track or event conditions may be hazardous and may vary without warning or predictability.
- That the organisers, officials, landowners, track operators and any agent or any representatives of those in charge of the race meeting are frequently obliged to make decisions under pressure of time and/or events.
- That any policy of insurance of or in respect of my life or physical or mental health may be voided.
- That there may be limited first aid treatment and transport for me if I am injured.
- That I have an obligation to myself and to others to compete safely and within the rules of competition.
