## **CONTRACT TO PARTICIPATE IN MOTORCYCLE SPORTING EVENTS AND /OR/ACTIVITY:**

HEREBY AGREE with the persons, organisations and bodies corporate whose names appear in schedule 1 (hereinafter collectively called "the organisers") that I am by this agreement entitled to participate in the motorcycle meetings listed in schedule 2 (hereinafter called "the meeting") at the venue listed in schedule 3 (hereinafter called "the meeting") on terms and conditions set out in this document.

#### **ACKNOWLEDGEMENT OF RISKS, DANGERS AND OBLIGATIONS:**

I **ACKNOWLEDGE** that the sport of motorcycling is dangerous and that by engaging in the sport and participating in the race meeting I understand that I am exposed to certain risks and dangers and I am under certain obligations to follow:

- That I may be injured physically, mentally and/or even death.
- That my machinery or equipment may be damaged, lost or destroyed.
- That, other competitors may ride dangerously or with lack of skill.
- That the track or event conditions may be hazardous and may vary without warning or predictability.
- That the organisers, officials, landowners, track operators and any agent or any representatives of those in charge of the race meeting are frequently obliged to make decisions under pressure of time and/or events.
- That any policy of insurance of or in respect of my life or physical or mental health may be voided
- That there may be limited first aid treatment and transport for me if I am injured.
- That I have an obligation to myself and to others to compete safely and within the rules of competition.

### **INDEMNITY GIVEN TO ORGANISERS**

In **CONSIDERATION** of the acceptance of me into the race meeting I AGREE TO INDEMNIFY the organisers and each of the following manner:

- That I participate in the race meeting at my sole risk and responsibility.
- That I accept the venue as it stands with all and any defect or hazard, hidden or exposed.
- That I indemnify and hold harmless the organisers, their respective servants, agents or
  officials against any actions or claims which may be made by me or on my behalf or by other
  parties for or in respect of or arising out of my injury or death, loss or damage caused to me

or to my machine or equipment whether caused by negligence, breach of contract or in any manner whatsoever.
