This policy seeks to prescribe a process in providing accommodation for players and officials whilst representing the League away from its District. (eg: Mortlock Shield)

### 1.0 PLAYER AND OFFICIAL ACCOMODATION POLICY

#### 1.1 Purpose of this Policy

The purpose of this policy is to prescribe coverage for accommodation whilst players and/or officials travel away representing the League

#### 1.2 Who this Policy Applies to

League Executive, League Officials, Players and Invitees as determined by the League

#### 1.3 Away Match Accommodation

MWFL will pre-book accommodation based on 1 bed per player / official. The configuration of these beds may consist of single, double, queen or king size depending on what is available. The traveling party normally consists of:

- 25 x players
- 1 x coach
- 2 x selectors
- 1 x runner
- 4 x trainers
- 1 x team manager
- 1 x league president
- 1 x league secretary
- 1 x umpire

#### 1.4 Partners Accommodation

Players and officials have the opportunity to nominate that their partners and / or children will accompany them. Such nomination will be on the provision that they will require accommodation for the full weekend – (ie. No provision will be made for those requiring extra accommodation for only a part of the weekend).

Where possible the MWFL will try and meet the accommodation needs of all players, officials and their guests, however availability of rooms may restrict this ability. In this instance extra guest room and bed allocations will be made on the following basis

- 1st Players and Coach wives or defacto partners
- 2<sup>nd</sup> Officials and trainers wives or defacto partners
- 3<sup>rd</sup> Players and Coach partners / girlfriends
- 4<sup>th</sup> Officials and trainers partners / girlfriends
- 5<sup>th</sup> Children of players and officials

#### 1.5 Partners Costs Coverage

The guests of all players and officials will be required to pay half of the bed rate for the whole weekend. If a player or official nominates that they will bringing a guest – the player or official will bear this cost even if the guest does not take up the accommodation – no change in accommodation arrangements will be made after the Wednesday prior to the event

#### 1.6 Damage and Breakage

Any damage in a room will be the responsibility of all in that room. All damages must be reported to the League officials.

#### 1.7 Other Costs Accrued

All cost other that the accommodation tariff are the responsibility of the player or official. Any costs not recouped from players or officials will be billed back to that person's relevant club.
