

## AFL Western District – Major to District League Area Permit Agreement – HFNL to WDFNL Type 1 Permit



Area Permits, whereby an interchange of players between the abovementioned Leagues / Regions may take place without clearance and is subject to any provisions contained within this agreement.

Any junior player who is registered with a Hampden Football Netball League club and wishes to play football within the Warrnambool & District Football Netball League on this Area Permit Agreement, must abide by the following. Please note players only need to complete this form once annually for it to be current for the entire season.

**Note** - It is the responsibility of the district league club seeking the permit to have the paperwork submitted correctly by the deadline. The completed form must be properly completed and submitted prior to 5.00pm on the Friday before the permit match played. Copies of the form, physical or electronic, are to be distributed as follows – one for each Club involved and one to each League involved with the permit. This condition must be strictly adhered to. Failure to do so could see the club penalised under AFL VC Rule 1.3 (ineligible players).

HFNL players who have participated in VLine or TAC Cup matches, been selected in a HFNL senior side or in an interleague side representing their registered club in the current or previous season are precluded from using this permit. This permit is designed for the use of players who are missing out on a weekly game with their registered HFNL club and should not be used to filter HFNL players out to neighbouring Leagues.

## Please Note:

**Players:** 

- may only compete in one match for one club per weekend under this agreement. Therefore, any player requesting an interchange to another club is forfeiting their right to play with their home club on that weekend.
- can only play a maximum number of three (3) games under this agreement is; clearances into a WDFNL club will be included in this count.
- playing on permit are **not** eligible for any league awards.

## Clubs:

- All club registered players must be selected before permit players can receive endorsement to play.
- must ensure they inform their opposition that they will be playing interchange players
- must clearly mark 'Area Permit' on the team sheet next to the name of the player in question.
- found guilty of breaching this agreement shall lose the right to use the agreement for the remainder of the calendar year and may be subject to further penalty as deemed appropriate by their League.
- found to have breached the Area Permit Agreement and its conditions will be subject to AFL VC Rule 1.3 (ineligible players).
- based on the club's own registered players, a club may only play the following number of players permitted to interchange, in any week and must not exceed this number:
  - o 14 players available on the team sheet : 4 permit players allowed
  - o 15 players available on the team sheet: 3 permit players allowed
  - o 16 players available on the team sheet: 2 permit players allowed
  - o 17 players available on the team sheet: 1 permit player allowed
  - o 18 players available on the team sheet: no permit players allowed
- If there are any issues with the submission of an area permit agreement form, the League Administrator will contact the player/club in question
- Both leagues will keep a record of all players who play in each match on this agreement.
- This agreement does not include finals matches. Under no circumstances can a player play in a final under this agreement.
