AREA PERMIT AGREEMENT 2019 - SENIORS & RESERVES PLAYERS ONLY

BETWEEN HAMPDEN FNL & WARRNAMBOOL & DISTRICT FNL

This Agreement is signed pursuant to the AFL Victoria Country rules and regulations pertaining to clearances and permits and in particular rule 2.10 Area Permits, whereby an interchange of players between two leagues may take place without clearance or permits and is subject to any provisions contained within this agreement.

PROVIDED HOWEVER

- 1. That this agreement is in place for the 2019 season only.
- 2. That the player(s) involved desire to play with the club in the other League on the day in question.
- 3. That the clubs involved are agreeable to the players playing on the day in question.
- 4. That the players are registered players within AFL Victoria Country.
- 5. That the players concerned are aware of the AFL Victoria Country regulations 2.1, 2.2 and 2.5 regarding permits to Major Leagues and eight (8) matches.
- 6. That prior to each match a player wishes to play on permit he must obtain written permission from his registered club by completing three (3) copies of the Area Permit Form as supplied by the League. The three forms are to be distributed as follows one for each League involved and one to be retained by the Secretary of the player's registered club. This condition must be strictly adhered to. Failure to do so could see the club penalised under AFL Victoria Country Rule 1.3 (ineligible players).
- 7. Permit players must be listed on the Team Sheet as Area Permit Players. Failure to do so could see the club penalised under AFL Victoria Country Rule 1.3 (ineligible players).
- 8. Players of any club having a 'BYE' <u>will not</u> be allowed to play with another club on that day unless he has previously played with that club in the current season under this Agreement.
- 9. The club playing the player from the other league must show his registered club and AFL Victoria Country registration number on the permit form under clause 6 of this agreement.
- 10. That any player shall not be permitted to play more than eight (8) matches with the other club under the provisions of this agreement.
- 11. That the number of players played by any club under this agreement on any one day be restricted to six (6) permit players only, limit of four (4) players for Reserves football and limit of two (2) players for Seniors football.
- 12. Under this agreement players must only play one match per day.
- 13. That any Hampden Football Netball League open age player wishing to make use of this agreement must have played at least one (1) Seniors or Reserves match in the current season. Once a player has played one (1) Hampden

Football Netball League Seniors match in the current season, he is deemed to be a Seniors player. As such he is ineligible to play with a Warrnambool & District League club under this agreement.

- 14. That a player having played the maximum number of eight (8) matches with a club under this agreement shall be required to obtain a full clearance if he wishes to continue to play with that club. Such clearances can be granted after 1st July provided the maximum number of games has been played.
- 15. Players may only interchange/permit to one HFNL or WDFNL club in any one season.
- 16. Finals qualification will be based on the local finals qualification By-Laws for each League.
- 17. All permits shall be transacted via the AFL Footyweb permit system using the match day permit option with the requested date only specified.

Reported Players

1. A player that is reported shall face the AFL Western District Independent Tribunal. Any penalty that is imposed shall apply for all competitions.
