

**AREA PERMIT AGREEMENT 2019**  
**BETWEEN MININERA & DISTRICT FOOTBALL LEAGUE &**  
**WIMMERA FOOTBALL LEAGUE**

An Area Agreement between the Mininera & District Football League and Wimmera Football League.

This agreement is signed pursuant to the AFL Victoria Country rules and regulations pertaining to clearances and permits and in particular the clause 2.10 – Area Permits, whereby an interchange of players between the abovementioned Leagues may take place without clearance or permits and is subject to any provisions contained within this agreement.

**PROVIDED HOWEVER**


1. That this agreement is in force for the 2019 season only.
2. That the players involved desire to play with the Club in either League on the day in question.
3. That the Clubs involved are agreeable to the players playing on the day in question.
4. That prior to each match played, the players shall obtain a signed permit to do so from his parent club. The permit shall be in triplicate and dispensed by the Club with which the player plays on the day as required under Regulation 2.1 of the AFL Victoria Country Rules and Regulations. Failure to ensure correct paperwork is obtained and signed (both club and parents of player involved) as directed will result in the permit being considered null and void. Any breach of this agreement will automatically cancel this agreement for the clubs concerned for the duration of the current season.
5. Open Age Players of any club having a “Bye”, split round, interleague, forfeits or Sunday games will not be allowed to play with another club on the day unless he has previously played with the Club in the current season under this agreement.
6. Under Age Players of any club having a “Bye”, split round, interleague, forfeits or Sunday games will be allowed to play in the underage competition with another club on the day. Provided that where an under age player of a WFL club having a bye, split round, interleague, forfeit or Sunday games wishes to play with a MDFL club in that day and has not previously played with that MDFL club under this agreement this season, permission shall first be obtained from the MDFL Board.
7. That any player shall not be permitted to play more than (8) eight matches with the other club under the provisions of this agreement.
8. That a player having played the maximum number of (8) eight matches with a club under this agreement shall obtain a full clearance before he is able to continue to play with that club. Such clearance may be granted after 1 July provided that the maximum number of games have been played.

9. That the number of players played by any club under this agreement be restricted to (5) five only on any one day.

For the MDFL Under 16.5 competition, the following rules apply:


- a. 14 players available on the team sheet: 5 permit players allowed.
  - b. 15 players available on the team sheet: 4 permit players allowed.
  - c. 16 players available on the team sheet: 3 permit players allowed.
  - d. 17 players available on the team sheet: 2 permit players allowed.
  - e. 18 players available on the team sheet: 1 permit players allowed.
  - f. 19 players available on the team sheet: no permit players allowed.
  - g. Only two permit players may be of the maximum age permitted in the competition, with the remaining players to be under 15 at the 1<sup>st</sup> of January of the current year.
10. That a player may play one game only on any day under this agreement.
11. That any WFL player wishing to make use of this agreement must have played at least one Reserves or Under 18's match in the current season and must not have played any Senior Grade matches.
12. Once a player has played one (1) WFL senior match in the current season, he is deemed to be a Senior Player. As such he is ineligible to play with a MDFL Club under this agreement.
13. That players using this agreement must meet with the specific qualifications of each league in relation to playing finals.


