



AFL Western District – District League to Major League JUNIOR AREA AGREEMENT – Type 2 Permit This agreement is for Under 18.5s and below

This Agreement is signed pursuant to the AFL Victoria Country Handbook rules and regulations pertaining to clearances and permits and in particular the clause 2.1 – between the HFNL, WDFNL and (potentially other Junior and District Leagues within AFL WDC).

This agreement is for the purpose of District League high performing junior players to play with the major league. Any Junior and District League players wanting to play with the major league under agreement must complete a Type 2 agreement prior to each game played.

Note: **A player may only compete in one match per club per weekend under this agreement.** Therefore, any player requesting to play on permit to a HFNL club is forfeiting their right play with their home club on that weekend. A player's registered home club has the option to authorise or refuse any permit application. A player from another league may play with more than one HFNL club under this agreement within a season but only one match per weekend.

THE FOLLOWING CONDITIONS APPLY:

That the Player:

- involved desires to play with the Club on the date(s) requested and is aware of the AFL Vic Country Rule 2.0.
- has played at least one game with their home Club in the current season.
- of any club having a "Bye", split round, inter-league or forfeits will not be allowed to play with a HFNL club on permit unless the player has previously played with the Club in the current season, **excepting in Round 1 of HFNL Competition only.**
- shall not be permitted to play more than (8) eight Home & Away matches with another club under the provisions of this agreement.
- Permit players will not be able to play finals.
- having played the maximum number of (8) eight matches with a club under this agreement shall need to obtain a full clearance before being able to continue to play with that club. Any clearance application of a player who has played the maximum number of permit games must be approved by the Regional Commission of the player's registered club and clearance regulations as outlined in the AFL Victoria Country handbook must apply.
- playing on permit are not eligible for any League Awards

Clubs:

- may only play a player on permit when both clubs have authorised the Type 2 permit for the day in question. Failure to do so will find the HFNL club to have played an ineligible player. A Type 2 permit must be completed on each occasion.
- playing the permitted player indicate the use of a permit as well as show the player's registered club on the match team sheet.
- the number of players played by any club under this agreement be restricted to (4) four only on any one day.
- If a club has the following number of their own registered players available of the correct age bracket, the following number of permit players will be the maximum allowed:
 - 14 players available on the team sheet : 4 permit players allowed
 - 15 players available on the team sheet: 3 permit players allowed
 - 16 players available on the team sheet: 2 permit players allowed
 - 17 players available on the team sheet: 1 permit player allowed
 - 18 players available on the team sheet: no permit players allowed

Note:

1. It is the responsibility of the major league club seeking the permit to have the paperwork submitted. The completed form must be properly completed and submitted **prior to 5.00pm on the Friday before the permit match played.** Copies of the form, physical or electronic, are to be distributed as follows – one for each Club involved and one to each League involved with the permit. This condition must be strictly adhered to. Failure to do so could see the club penalised under AFL VC Rule 1.3 (ineligible players).
2. All permits shall be transacted via Sports permit system using the Type 2 match day permit option with the requested date/s only specified. Signed paperwork must be completed prior to requesting the Footy Web permit and no player is to take the field until the on line permit has been approved by the players registered club. Any district (or junior) league club who does not wish to allow a Type 2 Permit to proceed will need to immediately make contact with their League Operations Manager or League Administrator who will follow it up with the necessary contacts.
3. Any club found to have breached this Agreement and its conditions will be subject to AFL VC Rule 1.3 (ineligible players).
4. Any player reported whilst on permit shall face the independent tribunal of the League in which the alleged offence was committed. Any penalty imposed will apply to all AFL VC competitions.

- Complete this form in Quadruplicate: One copy to be retained by EACH club and one copy to be forwarded to each League involved in the permit. **This form may be completed on Sports TG, where applicable and, provided there is manual sign off by the home club and that parental permission is obtained.**
- A player will not be able to take the field until this form has been correctly completed and submitted prior to 5.00pm on the Friday before the permit match played.
- The player shall obtain verbal and written permission to do so from the registered Club by completing four (4) copies of the Junior Area Agreement Form
- It is the responsibility of the club seeking the permit to have the paperwork properly completed and submitted.
- Signing is acknowledgement of all requirements and conditions of the AFL Western District – District League to Major League Junior Area Agreement
