7. Presidents Report

- Jay Williams On behalf of the Mid West Football League, provide a message of condolence to the Williams and Boylan families and Elliston football Club and Elliston community. Jay was a leader on and off the field and will be greatly missed. The good thing about our football and netball is that it brings us together and we all know each other well. We may play hard and compete hard on the field, but we walk off and leave all that on the field and have a beer with each other afterwards. That is what makes us such a good sporting community and that is what we enjoy about our community. That is also why we all feel the loss of Jay and Nick Paul, who were such important people not just for Elliston, but to our Mid-West League. Out of all the tragedy that the Elliston community has experienced, our football leaders, like Chad Fleming and others in the club have stepped up to provide leadership and I thank them for that. On behalf of the MWFL, we wish the Elliston Football Club all the best for the future.
- Mortlock Changes Six team comp Northern dropped out (difficulties getting best side together), EP Sharks players can be dispersed to clubs (Up to four League of Origin players)
- Meeting with Far-West is apparently still on. Yet to hear back from them to confirm anything. Will only be a courtesy and a very informal discussion of current state of play. Mid-West believe in a multi-lateral approach to football future through the EPFC. Ron Redford will probably continue to be disappointed that Far West players are continuing to opt to play in Mid-West League.
- On behaviour, there will be regular reminders during the season that poor behaviour from players and spectators will not be tolerated. This includes social media. As we get closer to finals, things get heated up and in recent years there have been a number of incidents that in all reality no one should accept. I ask all of you to take back to your clubs a reminder to players and spectators the expectation for good behaviour during the season and for all of you to provide leadership and an example to players and spectators so that we all win well and lose well. It's all about treating each other with respect. Poor behaviour needs to be called out and nipped in the bud so that things don't escalate into full blown incidents. We really don't want to have to appoint club marshalls to monitor and report upon bad behaviour. As with every other year, there will of course be on and off-field incidents and they will be treated accordingly by umpires and if serious enough, the tribunal.

- We have new rules, a new second round colts format, changes to B grade and a double-header weekend of first and second semi-finals that will require some time to get used to. I'm sure that there will be some glitches, but some patience and good-will from everyone would be appreciated as we implement these changes. We have made some significant changes to the Colts comp in the second round to see if we can improve our colts competitiveness. We may need to tweak a few things a bit to help improve how this all runs, but we need to give it some time as a trial.
- As there is no Inter-League match and a six team Mortlock comp, I would ask all delegates and officials to encourage players to make themselves available for Mortlock. We have reduced the length of programming and opportunities for players to have weeks off during the season. After last years very successful Mortlock campaign, we have another very good chance to do well again this year...even more so without the EP Sharks or Northern.

- 8.1 MWFL Meeting proposed dates. Next meeting July 2019.
- 8.2 MWFL 2019 Club contacts list. Brenda Tully asked that all clubs get those list to her asap.
- 8.3 MWFL Player registration 2019. All players need to be registered before the first game.
- 8.4 MWFL Players Payments/Salary Cap spread sheets. Send to Richard Murphy.
- 8.5 JLT Insurance. Please make sure all clubs have registered with JLT and print off your certificate of currency.
- 8.6 Mental Health Round June 22nd 2019. Breakthrough Mental Health Research Foundation Football Round. For a very good cause and mental health and suicide touches all our communities.
- 8.7 Mail Medal Count. Suggested that have on the Saturday, second Semi, instead of the Sunday when probably less people hang around. This would result in Warramboo hosting the count instead of Wirrulla. Wirrulla would need to receive the count in the normal rotation in coming years.
- 8.8 Coaches on line course. Coach accreditation Coaches are required to renew their coaching accreditation annually through CoachAFL. In 2019, clubs will need to select a head coach from a drop-down list in the team sheet in order to save, submit and print. This marks the first year that there will be complete reporting and monitoring of accredited coaches on match day. It is therefore essential that coaches have joined CoachAFL in 2019 and have selected their club in their Coaching Profile. As a fall-back, if clubs do not have their coach/s accredited by match day they will be able to select the 'no official' option in order to save and submit their team sheet. This can then be reported on and will be expected to be followed up by State, Region and/or League staff.
- 8.9 Defibrillators Check that everyone has them, where they are kept and ensure batteries are checked.

SUGGESTED ACTION: Remind clubs and reissue list as to locations to all clubs

8.10 EP Football Council Forum - The Eyre Peninsula Football Council invites Sponsors, Eyre Peninsula Leagues, individual Eyre Peninsula Clubs, Umpires and Netball Association executive representatives to attend the forum. It is critically important for the region to work together in a collaborative way to make our football and netball sustainable. We need to better understand how football and netball affect community development within the broader context of sustainability, then, must be willing to embrace and navigate these complexities that currently face many clubs through a declining population among other things. I look forward to your attendance at this forum. Tony Irvine.

As MWFL we can be dragged kicking into discussions about making our football and netball sustainable or we can get on the front foot and be pro-active about our future. Encourage clubs to be involved, so that we aren't dictated to.

Recommendations:

- That each member league and individual Clubs respond to the draft report in writing addressing their position on the recommendations. (Deadline 31 May 2019)
- That the Forum supports the formation of a working group of one representative from each League and three members of the EPFC (one of who will represent netball) to consider the individual League and club responses and to finalise a set of recommendations for implementation.
- Further the individual leagues will be kept informed of the progress through their representatives on the working group.
- Umpires future actions required for EP regional & State approach.
- Regional Tribunal system & how it will work
- Points systems, salary cap, compliance & integrity matters & other SANFL matters of importance to region
- Norwood Football Club session NFC Zone and other matters of interest
- Individual Football Leagues and Netball Associations each to report on issues etc. (including netball) Leagues/ Associations to submit topics for discussion prior to agenda being forwarded.
- 8.11 Umpires pre-season forum Present and discuss new rules of the game that are adopted by Mid-West (and in-line with other Leagues in our zone and the state).

SUGGESTED ACTION: Organise a get-together of panel and club umpires to learn and understand the new rule changes. Maybe have umpires coach or senior umpire to explain

8.12 Colts Forum prior to the Second Round Format – Provide information and rules to parents, players, umpires and public prior to the Colts Modified Format in the 2nd Round to get everyone 'on the same page' and reduce confusion.

SUGGESTED ACTION: Organise a get-together of coaches, umpires and other officials to learn and understand the second round Colts modified format.

8.13 Ongoing public information and education – New rules, B grade, Colts round 2 format, Finals, spectator behavior, etc. Brenda Tully to send behavior reminders to all clubs and they put in their home game budgets. And we get notices up at all home games.

SUGGESTED ACTION: Prior to the start of the season and during the season, the new Laws of the game changes for 2019, B grade rules, Colts modified round, Finals, spectator behavior, etc., a public information/education program needs to be spread via the budget, MWFL website, Facebook and any other media sources. Club officials/delegates need to keep players and supporters informed.

SUGGESTED ACTION: Prior to the start of the second round Colts modified competition, an information program needs to go out to players, parents and supporters and we have a Colts Forum on 14th May 2019 at Minnipa Hotel. 7pm.

8.14 SportsTG / Footyweb / Player Points Spreadsheet Training
