## HOST BROADCAST

- 8 hours live coverage per day, with a 1-hour highlights package
- ABC (AUS), via Pacific Media Assistance Scheme, assisting production & commentary
- Signal sea-cable to Sydney, uplinked to satellite and onto the Olympic Channel

## 2018 Financial Statements

- Audited Financial Statements sent to PGAs 29 May 2019
- 4<sup>th</sup> annual audit under company Pacific Games Council Ltd
- Incorporated in Cook Islands 20 January 2015 following resolutions of the 2014 General Assembly in Port Moresby
- Recognises each PGA has been issued with a \$20 limited liability share, paid up share capital equates to \$440
- Pacific Games Council Limited assumed all assets and liabilities of former entity, Pacific Games Council

# Auditors Report for 2018 Rapport D 'Audit

### Scope of Audit

- "We have audited the accompanying financial statements of Pacific Games Council Limited which comprise the statement of financial position as at 31 December 2018, and the statement of comprehensive income, statement of changes in equity and statement of cash flows for the year then ended, and a summary of significant accounting policies and other explanatory notes"

# 2018 Financial Statements





- > 2018 Income \$287,500
  - \$460,846 in 2017
  - All VAN2017 payments made in 2017
- 2018 Expenditure \$360,735
  - \$240,274 in 2017
  - Higher AGM cost (non-Games year) & much stronger USD in 2018
- 2018 Deficit \$37,236
  - \$253,975 surplus in 2017
- 2018 Equity \$1,433,429
  - > \$1,470,665 in 2017
  - Cash & cash equivalents of \$1,455,338

# Budget 2019-2023

- Executive Board maintains a five year forward budget
  - Cash Flows revised twice each year by Executive Board
- Income/Expenditure 2019-2023
  - Locked into four year revenue streams for Pacific (& Mini) Games
  - Maintaining low overhead expenditure base with Secretariat
  - For 2019 on target to achieve balanced budget





# RESERVES

#### Council Reserves

- Constitutional Recognition of Reserves in 2014 Article 16.2.n
  - Required to set Reserve if less than 4 years expenditures (\$1,253,865 total, from 2014 - 2017)
  - 2014 General Assembly Agreed to a \$600,000 Reserve (53%)
     2015 Increased to \$700,000
  - 2016 Increased to \$740,000
  - 2017 Increased to \$784,000
  - 2018 Increased to \$984,000 (78%)
  - Reserve to be increased to \$1,000,000 in 2019 (81% of target)

    Audit & Finance Committee will review the whole policy in 2020

### ASSOCIATE MEMBERSHIP





Associate Membership: Article 3 (2018)

- "Associate membership of the Council may be granted by the Executive Board to other countries and territories in Oceania, who may then participate in editions of the Pacific Games...on terms and conditions at the Executive Board's discretion. No other membership rights, including voting rights...shall be conferred...Any such decision by the Executive Board shall be ratified at the next General Assembly"
- Candidacies for ratification (by majority vote) after Executive Board decision in March 2019:
  - AOC (Australia)
  - NZOC (New Zealand)
- Preliminary inquiries and further work required
  - Easter Island & Pitcairn Island


## LIFE MEMBERSHIP



- Article 3: "Life membership of the Council may be granted, by two-thirds majority, to individuals (maximum of 3 at any one time), as nominated by the Executive Board, who have demonstrated outstanding service to the Council"

## 2021 PACIFIC MINI GAMES

CNMI won unopposed in 2014 (Port Moresby AGM)



Super Typhoon Yutu: October 2018

Governor withdrew in March: cannot deliver the bid

Council visit and negotiations: April-June

Agreement to a reduced \$3 million budget

One Village (school) as second one destroyed

6 sports retained from original 12 in bid

PGC – NMI PGA joint decision

Athletics Beach Volleyball Badminton
Baseball (Men) Golf Triathlon

- Special Envoy Rep. Marco Peter (met Tuesday)
- Outstanding hosting fee paid (Thursday)
- Possibility of adding sports back if more funds

# 2025 PACIFIC MINI GAMES



- 2017 AGM in Port Vila Expressions of Interest
   American Samoa and Niue
- 2018 two bids lodged General Assembly Decision Commence a new process in 2019 as both bids were not compliant (no Government guarantees)
- Bids lodged 18 January American Samoa & Palau



- Evaluation Visit to Palau 8-9 April
  - Government financial underwrite received in the bid
  - Government Commitment to sign the Host Agreement
  - Met President Remengesau
  - Met Congressional Leadership
  - Met all National Federations on the bid program
  - Venues available and ready to host (Oceans 2020)
  - Bid complies with Charter
  - Palau evaluated as capable of hosting the Games

# 2025 PACIFIC MINI GAMES





- High Level Government support not included in bid
- Extended deadline to get Government guarantees to May
- President & CEO met Lieutenant Governor in Apia, 31 May on a Samoa 2019 visit: further 2-week extension 14 June
- Government financial underwrite only received 21 June after Evaluation Report issued (see below)
- Government not yet committed to signing Host Agreement
- Out of time to visit American Samoa and fully evaluate bid
