7. Presidents Report

Matthew Cook spoke of recent EP Forum and some of the proposals that were put to the meeting. There seems to be a request for all leagues to pay \$2500.00 per Football club to the EP Football Council. At the time of the EP Forum we as Mid West FL were not prepared to vote that this proposal be accepted. This was to be taken back to all leagues and discuss further. Matthew Cook welcomed Ned Luscombe to the meeting tonight so if we have any questions we may be able to get clarification or some idea. Ned Luscombe spoke of the structure of the EP Football Council and that they have had several meetings plus the recent EP Forum. There are many questions since the EP Forum and we need to direct them to the EP Football Council. The EP Football Council is a two year term. Remember as a league we have the right to ask questions. The role that Richard Murphy has is for 2 years and is being funded by local councils/government and leagues. This will be reviewed and we can have our say on the input he has had to our league. As a league we need to use him a lot more. Several clubs have been trying to contact Richard Murphy and haven't had a response. Brenda Tully has had several phone calls from several clubs in Mid West FL with queries and has helped them over the phone. This is something we as a league need to take up with SANFL/CFL.

Ned Luscombe spoke of the connection with the Norwood FC who are looking at doing a lot more on the EP. Making sure that they cover all parts of the EP and Leagues/Clubs. Several question were asked of the positions on the EP Football council especially those who are independent. Ned Luscombe asked that we direct those questions to the EP Football Council as he couldn't answer for the other members. He believed he was independent. Teagan Whitford asked that if we don't pay the money or do anything with the EP Football Council what happens to us as a league. We gain assistance for Umpiring, Administration, Finance, Grants, and Football in general. Matthew Cook will be collating information from clubs and will be reporting to the EP Football Council on behalf of the league. All clubs need to be talking about our league and what you all think. Remember your clubs own this league not the executives. Need to hear your voices. Clubs remaining sustainable for the future is the number one priority for all of us.
