## **Representative Team Selectors / Teams – As per TSA BY-Laws**

Representative teams will be selected by a Selection Committee. The selection committee is to consist of the nominated persons elected at the AGM plus the Coach and Assistant Coach of each Representative Team eg U15 Girls trials then the Coaches of the U15 girls also become selectors. A minimum of 3 selectors must be in attendance at the trials. This maybe 2 selectors and 1 coach or 1 selector and 2 coaches. Selections can take place with more then the said 3 persons if available.

**14.4 [a]** Selection criteria for Toowoomba Junior grades U15 players may be selected over an aged U17 player. Under 17 player may be selected over an aged U19 player.

**14.4 [b]** Selection criteria for Toowoomba Senior grades (Open teams) is OPEN to all that nominate including those younger players still in the U19 age group. Under 19 players may be selected over an OPEN aged player.

Toowoomba Softball aim to select the strongest team possible to compete at the State Titles.

## **UNDERAGE GUIDELINES as per QLD Softball Rules**

The age guidelines are as follows:

**a) Under 14 State Championships** Only players 11, 12 & 13 years of age, as at 31 December in year of Championship, are permitted to compete in the Under 14 Championships.

**b) Under 16 State Championships** Only players 13, 14 & 15 years of age, as at 31 December in year of Championship, are permitted to compete in the Under 16 Championships.

**c) Under 18 State Championships** Only players 15, 16, 17 years of age, as at 31 December in year of Championship, are permitted to compete in the Under 18 Championships

## **CHAMPIONSHIP RELEASE (As per QS & TSA guidelines)**

Players must have met the guidelines of the QLD Softball Championship Release. TSA will only grant verbal release until such time TSA does not require the player/s in a Toowoomba team in case of injury/withdrawal replacement. If no replacement player is required in the age groups, TSA is happy to help arrange for any player to be release to another DA to field a team to travel to the Championships. This rule is to be explained to the outside DA so they understand where TSA stands to committing to TSA teams first while trying to help them at the same time. The release form is to be sent to the DA for the team lists are due into QLD. This will help both TSA and the other DA's finale paperwork and teams. In the event that a replacement is required after the release has been granted the Toowoomba player must forfil the position in the Toowoomba team first. SCR (State Championship Release) rules relate to all TSA representative teams including all players and officials regardless of age.
