We have a number of functions coming up in the next few weeks starting with:


- Tonight: Trivial Pursuit in the clubrooms


Round 12: 5 June

Emerald demolished Seville to win by 114 points.


A seven goal to nil first quarter set the tone for the match. A further six gaols to two in the second quarter put the game beyond doubt.
