Confirmation of Minutes	
General Business	That the Minutes of the League Meeting held on 18 June 2020, as tabled, be accepted. Moved: Port Seconded: Central Augusta
	COVID-19 L Promnitz provided an update from the recent President/Secretaries Forum conducted by the SANFL. A Walk through of the current stages and Type 2 Permit process was provided. DRAFT FIXTURE
SGL	L Promnitz advised this is the best that we can get with not a lot of wriggle room. Common sense needs to prevail and we need a game in each town each weekend, which will require some small sacrifices during troublesome times to ensure a fair competition for all concerned. Umpiring numbers will be a concern. The SGL will pay for umpires and travel along with footballs for matches. It is likely that panel umpires will only be provided for 'A Grade' matches. Discussion ensued and clubs believe they should be able to provide umpires for other grades.
	Discussion took place regarding the 'B Grade' competition, general consensus is that

	most clubs should be able to field.
	L Promnitz advised that the SGL will program all grades. It was agreed that up to 24 players could be utilized for 'A Grade" matches, however this is optional. Agreement was reached to shorten 'B Grade" games to 15 minute quarters, same number of players on field, with a minimum of 14 per side. No changes to U18 and U15 quarters or players. This will be reviewed following the first five rounds.
	CHANGEROOMS/OVAL ACCESS
	Given the social distancing restrictions in relation to changerooms, no non-essential persons will be allowed into changerooms. It was also agreed that 'A Grade' teams would remain on the Oval during half time breaks.
	No spectators/non-essential persons are to enter the playing surface/team huddles during breaks and between matches. This is includes kids wanting to have a 'kick and catch'.
	COVID-SAFE PLANNING
	L Promnitz advised that the SGL has developed a COVID-Safe Plan for both venues, this will be forwarded through to clubs. Early discussions have commenced with both Councils in relation to facility use and Port Augusta clubs to make arrangements to discuss with Council on or after 30 June 2020
WEST AUGUSTA	Clarified that the fixture distributed is the final fixture
SOLOMONTOWN	Canteen issues, but these will be worked out by Solomontown and PropRisdon
CENTRAL AUGUSTA	Would have liked home and away games, but understand the need for games in each town. Also queried qualification for finals. Discussion ensued and will remain at 3.
SOUTH AUGUSTA	Sorry that we were here tonight after reversal of original decision
PORT	Would also have liked home games but understand reasoning and appreciate the efforts to have reached this point.
R GORDON	Reminder to all clubs regarding Budget requirements
G CONGDON	Admission prices for Season 2020. Discussion ensued and to remain the same. Some discussion required as part of negotiations with Councils.
