

BJFL 2019 Annual General Meeting Thursday 12th December, 7pm at The Bendigo Club

Minutes

Roll Call: Clubs absent without an apology – Dockers, Marong, North Bendigo, Sandhurst, Woorinen (\$25 fine to be issued under by-law 5.1)

Minutes 2018 Annual General Meeting:

Moved Ron Rutledge. Seconded David Mayes, that these minutes be accepted as written – Carried.

Correspondence: Secretary noted no items received in relation to this meeting.

Reports: Reports tabled as per AGM booklet.

- AFLCV Junior Ops: As provided in the 2019 Annual Report
- Secretary: As provided in the 2019 Annual Report, with a special mention to all clubs and AFLCV staff for their efforts during the season.
- AFLCV: As provided in the 2019 Annual Report

Financials:

- A very similar profit for 2019 as per 2018, with total revenue slightly down due to the BJFL providing free grand final vision for 2019 to families with over 5,000 views exceeded, plus complimentary drinks at the Annual Dinner for Club officials, plus a few less teams. Additionally, expenses were higher due to more Grand Final participants and also we had more clubs financially rewarded through the MDCA program.. However, there was an increase in revenue with a record gate and slightly more sponsorship than 2018 and less umpires supplied.

Even though the BJFL wish to remain cost neutral each year they were able to realise a small profit of \$11,194.00 (\$1992.00 higher than 2018).

- Ron Rutledge (KFNC) asked what the goal is for having \$180,000 in the bank. Norm acknowledged we had already reduced the operating account with Hub fees and outgoings but had deposited \$140,000 into a 3-month Term Deposit.

Norm repeated the League was more than happy to continue to forecast for a cost neutral year with the aim of keeping football the cheapest sport possible, but also acknowledging at the club reviews at seasons end the majority of clubs are in a very good financial position, and as a collective we all need to ensure the savings are passed on to the families in future.

Also, for 2020, AFL Vic Country have reduced affiliation fees for clubs significantly. We estimate our larger clubs could save in the vicinity of \$12,000- \$14,000, a mid-size club could reduce their fees from \$5700 - \$1068, saving over \$4500.00, and Primary school teams approx. saving of \$1500. Also, clubs will receive a further reduction for season 2020 with AFL Central Victoria removing the player welfare levy which clubs have been charged \$10 per player. Instead an administration fee per team will be charged, \$150 per competitive team and \$100 per non-competitive teams - include approx. savings for small, medium and large clubs. This will allow for AFLCV to continue to provide 1.5 resources to administer the BJFL. AFLCV will still provide welfare programs like SALT, Sports Chaplaincy, Bendigo Community Health Services and Everproof. This AFLCV admin fee will be invoiced in replace of the player levy and will be an additional saving of approximately \$90.00 per competitive team and \$60.00 per non-competitive team.

Moved Bonnie Roberts. Seconded Dave Mayes, that these reports be accepted – Carried.







General Business:

The General Business items were based from the Club Consultation, BJFL working group and Club End of Season meetings.

Academy:

AFL Central Victoria run the Academy which directly works with BJFL clubs.

Capping the number of players per club.

- The academy numbers per club in season 2020 will be capped at 6 players per club.

Under 12 Age Group

- Feedback received from some BJFL clubs were to remove the Under 12 Academy. At this stage the U12 age group will remain for 2020 with the decision being deferred. The impact of possible bylaw changes for 2020 was taken into consideration.

Notices of Motion:

Motion No 1: Where team numbers in divisions are an odd number, match ratio to be used CURRENT: 12.2 Ladders shall be calculated on firstly Premiership Points, secondly on percentage.

BE AMENDED TO: 12.3 Where team numbers in divisions are an odd number, match ratio to be used. Match ratio is when wins are divided by the matches played to determine a percentage. This removes the unevenness of byes in fixtures.

EXPLANATION: Match ratio removes outlying factors such as unevenness of byes in fixtures and gives a better reflection of the performance of teams.

CARRIED. White Hills voted against.

Motion No 2: A 50pt+ rule to be place in bylaws to assist in one sided games.

CURRENT: Not covered

ADDED TO: Game Rules Section

To be implemented to all competitive grades excluding U16 Boys and U18 Girls.

At half time or three quarter time, the field umpires to check the score via score board or goal umpires. If the score difference is greater than 50pts the following will be in place for the remainder of the game:

- 1. After a goal is kicked, by the winning team, the losing side shall be given a free kick (in the middle of the ground) to recommence the game, to replace the ball up.
- 2. The free kick is given to any player from the losing team.
- 3. 1 player to man the mark, the other 3 players (winning team) to be behind the kicker to decrease flooding opportunities. Back line players are not allowed to go forward of the kicker, prior to the kick being taken.

EXPLANATION: It gives the opportunity for the losing side to gain a possession and to go forward. To be used as a development opportunity rather than equality of games.

Not passed.

6 clubs voted for, 7 clubs voted against.

Motion No 3: To place a club sustainability policy for BJFL in the form of a basic points system.

CURRENT: 9.2 No more than three (3) junior players per age group will be permitted to be transferred from an affiliated BJFL club to another affiliated BJFL club per season unless both BJFL affiliated clubs' consent to this number being exceeded. Final approval to be granted by the BJFL. NOTE: This does not apply to clubs who do not have a team in the applicable age group (eg. St Kilian's - St Peter's players moving to Under 14's).

BE AMENDED TO: 9.2 Affiliated clubs must comply in accordance with the Rules for 'Junior Player Points System' set out in the 'Team Managers and Coaches Handbook', as applicable.







EXPLANATION: By changing the bylaw to the above wording, it gives flexibility for changes, if needed, within the 'Junior Player Points System' as a policy.

Junior Player Points System

2 points – This point value only applies to a transfer player (BJFL club to a BJFL club (not including clubs who cease participation after U12 teams).

4 points – Player selected for an AFLCV Academy program or inter-league games in the previous season or player selected for the Pioneers Representative Program in the previous season. This point only applies to a transfer player.

Maximum 10 points allocated to each team. Once the team lists are supplied, within relevant timeframes, the league will determine the relevant points and allocate to the club.

LESS THAN 18 PLAYERS REGISTERED

Clubs that have teams that have less than 18 registered players and have already reached their maximum of ten (10) transfer points can apply in writing to the league for dispensation to the maximum of ten (10) points for transfer players.

- Cannot take the team numbers past twenty (20) players
- Can only come from Category 2

MERGED TEAMS

Clubs that have teams that are low on numbers and are not able to field a team can apply to the league to merge their team with another Club's team that also has low numbers and not able to field their team. The club that is housing the merged team may apply in writing to the league to consider exceeding the maximum of ten (10) points for transfer players on any given match.

In submitting the application that club must provide;

- The reason why the two teams are required to merge
- A full list of players from both teams being considered for the merge When assessing the application, the league will consider all aspects of the merged team, taking into consideration the potential impact on the evenness of the competition if the application was approved.

FEMALE PATHWAY PLAYERS

Female players who have played in the mixed competition and have to transfer from their Club (as they don't field female only teams) to another Club (that does field female only teams) will not be allocated any transfer points.

SPECIAL TRANSFERS

Clubs may apply for exemptions for extenuating circumstances for a player transfer points to be reviewed.

• Moving house of residence, split families etc.

There is no limit to the number of special transfers that can be applied for and granted in any given year.

PENALTIES

Clubs that have teams that play more than the allowed ten (10) player points for any given match without receiving a written dispensation from the League will be deemed to be playing an ineligible player.

CARRIED.

The following by-law changes do not require voting:

By-Law Change: To align male and female age groups for 2020 (U12 / U14 / U16 / U18G)

CURRENT: 3.1 The age groups of the BJFL shall be determined at the AGM of 2019 and shall then apply for such time as determined at that AGM. The age divisions to apply until then as determined at the 2018 AGM are Under 9, Under 10, Under 12, Under 14, Under 16 & Females Under 11, 13, 15 & 18 Youth Girls.







BE AMENDED TO: 3.1 The age groups of the BJFL shall be determined at the AGM of 2020 and shall then apply for such time as determined at that AGM. The age divisions to apply until determined at the 2019 AGM are Under 9, Under 10, Under 12, Under 14, Under 16 & Females Under 12, Under 14, Under 16 and Under 18.

All age group wording within the bylaws to reflect the relevant age group changes. Under 12 age group to be non-competitive.

EXPLANATION: The break-up of existing player numbers show it is a perfect time to make the change and align with the boys structure.

By-Law Change: To remove percentage as a tie breaker on all BJFL ladders.

CURRENT: 12.2 Ladders shall be calculated on firstly Premiership Points, secondly on percentage. BE AMENDED TO: 12.2 Ladders shall be calculated on Premiership Points, if positions are tied then

head to head criteria is used. Head to head criteria:

Two (2) teams tied:

- 1. Win-Loss record of head-to-head competition between the two teams.
- 2. Points difference in head to head games between the two teams. Eg Team A won by 1pt and Team B won by 12pts, Team B will place higher.
- 3. Win-Loss record against highest common opponent (proceeding downwards if necessary).
- 4. Average points against.

Three (3+) or more teams tied:

- 1. Best winning percentage of games played among the tied teams.
- 2. Points against in head to head games between the tied teams.
- 3. Record against highest common opponent (proceeding downwards if necessary). 4. Average points against.

EXPLANATION: Avoiding the necessity of increased margins in games due to percentage building wins. It saves the bottom sides being exploited for ladder position purposes.

By-Law Change: Add the word 'club' for the purpose and intent of rule 10.3.2.

CURRENT: 10.3.2 Players within the same Age Group (except under 12) may "move" up or down from Division 1, Division 2 or Division 3 throughout the season, but may only move to the next lower division.

BE AMENDED TO: 10.3.2 Players within the same Age Group (except under 12) may "move" up or down from Division 1, Division 2 or Division 3 throughout the season, but may only move to the next lower division in which their club participates.

EXPLANATION: The intent of the rule is for players to play in the next available team for the club. Not all clubs have teams in consecutive divisions, if kept the rule would be hinder more than help.

By-Law Change: Add a bylaw for policy and process around spectator behaviour.

CURRENT: Not covered

ADDED: 19.4.1 'BJFL Conditions of Entry' shall be enforced as per the policy provided in the 'Team

Managers and Coaches Handbook'.

BJFL Conditions of Entry

Any club member, supporter or spectator attending an event under the auspices of the BJFL who:

- 1. Pushes, hits or strikes an Umpire, Coach, Team/Club Official, League Official, Spectator or Player.
- 2. Causes any act of misconduct that is detrimental to the best interest of BJFL.







- 3. Uses offensive language or abuse (malicious and/or threatening) any Coach, Team Official, Player, Umpire, Match Day Official or Spectator.
- 4. Acts in conflict of Liquor Licensing and Council regulations before, during or after a match.
- 5. Makes a public nuisance of oneself before, during or after a scheduled event.

Shall be subjected to the BJFL Condition of Entry process as outlined in this policy.

How the Conditions of Entry will be enforced

Offence: person commits breach of these conditions of entry.

- 1. Complaint Lodged: Security, BJFL Official or member of a club executive are advised of, or witness, a breach of the code of conduct. Such person, to whom a complaint is lodged, shall approach the person who has committed the breach of code and may issue a warning to the person or depending upon the severity of the breach of code, require the person to leave the venue. This enforcement is not reliant on the receipt of a complaint.
- 2. Eviction: In the event of Security, BJFL Official or member of a club executive determining that the person should leave the fixture or venue such person shall be asked to leave and in the event of a refusal an eviction from the venue by security or police.
- 3. Penalty Imposed: BJFL may issue a letter to the person and/or club stating the offence committed and request for the person and/or club to show cause why a proposed penalty should not be imposed. The person and/or club must respond within 72 hours of the letter being forwarded by BJFL, or the penalty imposed by the BJFL will stand.
- 4. Commission Hearing: If AFLCV believes in good faith that the person and/or club has breached the Rules, Regulations and/or By-Laws of the league, the Competition Manager may order the person and/or club to appear before a Match or Disciplinary hearing with the AFL Central Victoria commission.

Minimum Penalties

Violation of Code 1 in bylaw

1. First Offence: Dismissal from all AFLCV events for up to (1) year. 2. Second Offence: Permanent dismissal from all AFLCV events.

Violation of Codes 2, 3, 4, 5 in bylaw 14.4.3.1

- 1. First Offence: Dismissal from all AFLCV events for three (3) weeks.
- 2. Second Offence: Dismissal from all AFLCV events for up to one (1) year. 3. Third Offence: Permanent dismissal from all AFLCV events.

The AFLCV Commission reserve the right to decrease or increase any penalty at its discretion.

Appeal Process

If a party wishes to challenge the league verdict, they may do so under AFL Victoria rule 7.3.1c. The matter can be referred to the League's independent tribunal for Hearing and determination.

EXPLANATION: Currently there is no process through the BJFL or AFLCV if clubs have experienced unacceptable spectator behaviour. By adding this by-law it gives a clear process to follow.


Discussion of Auditor 2019/20:

Norm advised clubs that synthetic footballs are much cheaper than leathers and the league tries to keep costs down for clubs where possible, but are happy to take feedback from clubs if they wish to use leathers.





It certainly has been a whirl wind of a year! Looking back to the start of the year, the Bendigo Bank Junior Football League (BJFL) were preparing for a full season and aiming to have more teams on the grounds than previous years. No one could ever predict the impact of Covid-19.

AFL CENTRAL VIC REPORT

Well what a year it was! Thank you to all the people who attempted to provide some football and netball, whether it was planning and preparing but never quite starting, to training, or to the few games we managed to get underway. Your tireless efforts were appreciated, and we all missed the connection to our community and clubs.

The year started with great promise.

Essendon visited Bendigo as part of the AFL Community Camp Program. The camp began with a 'Welcome to Country' followed by training at the QEO attended by schools and supporters. Mayor, Marg O'Rourke, then welcomed the team to Bendigo at a Civic Reception. AFL CV Academy players participated in a training session with the players, while AFL CV Region coaches were provided an opportunity to attend a session with the Essendon coaches. The first day finished with a supporters' dinner. The final day of the camp began with a breakfast with the Essendon Leadership Group for our loyal partners, followed by the players visiting many of the partners' businesses including the Bendigo Bank, Champions IGA, Bendigo Club, La Trobe University, Bendigo Community Health and Fosterville Gold Mine. The camp concluded with school and hospital visits.

We were fortunate to host an AFLW game in Bendigo featuring Richmond and Geelong. The great Bendigo weather and excellent football drew a crowd of approximately 5,000 to enjoy the players' skills.

Once again, we brought our AFL Central Victoria clubs together and began the year with our annual Expo. The Expo included presentations on social media and policy updates as well as a netball coaches conference with Sue Hawkins, former Australian player, and England Coach.

The Bendigo Bank have continued to support community football with referrals of new business bringing \$25,000 into our region this year. We thank the bank for their sponsorship of our leagues and encourage all clubs to promote the referral program.

To maintain engagement, we increased our social media presence during the year. Whether it was selecting fan teams, playing previous grand finals, or developing flashback videos, we aimed to keep our community connected and engaged.

Thanks to the State Government for their support of Clubs and Leagues through the Community Sport Sector Short Term Survival grants and the Commission through the business support grants.

Congratulations to all concerned in both State and Local Governments and all clubs for driving facility development within the region.

The following developments have been completed:

- Birchip Watchem oval resurfacing
- Eaglehawk have new lights and spectators' shelter
- Ewing Park oval upgrade
- Kangaroo Flat have new netball courts







The Birchip Watchem Netball Club will have two courts converted into acrylic surfaces as part of the Local Sports Infrastructure Fund – Female Friendly Facilities Program.

Thanks to the funding boost from the Victorian Government's Community Sports Infrastructure Stimulus Program the following projects received funding:

- The Wycheproof Recreation Reserve project which will include the installation of lighting for the oval, tennis courts and hockey pitch.
- The Charlton Park Oval project which will see installation of lighting for the hockey pitch, tennis courts and oval.

Thanks to WorkSafe who continue to support country football. From grants received in 2019, in 2020 Mt Pleasant unveiled their new electronic scoreboard in the BJFL COVID-19 Competition U/18 match versus Marong and Bears Lagoon Serpentine have behind the goal netting installed and ready to go. Bridgewater received a grant in 2020 from the WorkSafe Club Safety Fund for installation of security lighting.

In 2020 Eaglehawk and Woorineen were both successful in receiving a grant to provide their female footballers with jumpers through the Toyota Good for Footy Gear Grants Program.

South Bendigo and Strathfieldsaye both received a grant through the AFL Victoria Energy Safe funding to purchase new equipment to improve the safety of their canteens.

South Bendigo also won the TAC prize for our region with the most respondents to the survey conducted by the TAC.

Prior to COVID-19, our Development Managers, Daniel Reid and Jake McLean, worked hard to promote our game across the region. They provided many promotional activities, sporting school programs and clinics both in schools and at clubs. Auskick was launched at Eaglehawk with a clinic for 150 students from surrounding schools. The AFL stood down most of their workforce, including the Football Development Managers, from April to October as part of the pandemic.

The academy structures in Bendigo were interrupted but were still able to provide many of our footballers and netballers with development programs. This program is only possible with the support of our volunteer coaches and generous sponsors.

The BUA took the opportunity to mentor boundary umpires into central umpires in U/12 games for the few weeks that the BJFL were able to conduct their competition.

We organised an umpires' education session with the support of Fosterville Goldmine.

AFL Central Victoria believe it has an important role in developing sport administrators/managers and have continued to host students from La Trobe University to support their development and provide industry experience.

Finally, we wish to recognise all staff at the Hub who have supported leagues and clubs through this year. In addition, a big thanks to Amy Kenyon who finished in April after five years with AFL CV for all her efforts to administer our sports, we wish her all the best for the future.

Thank you once again for your contribution to the game through this difficult year and your continued support of the Central Victoria Australian Football Commission. We look forward to working with you to meet the challenges ahead and hope for a better 2021.



Note 1. Summary of significant accounting policies

Financial reporting framework

The financial statements are special purpose financial statements prepared in order to satisfy the financial reporting requirements of the Associations Incorporation Reform Act 2012. The committee has determined that the association is not a reporting entity as there are no users who are dependent on the association's general purpose financial statements.

Statement of compliance

The financial report has been prepared in accordance with the Associations Incorporation Reform Act 2012, the basis of accounting specified by all Australian Accounting Standards and Interpretations, and the disclosure requirements of Accounting Standards AASB 9: Financial Instruments, AASB 15: Revenue from Contracts with Customers, AASB 101: Presentation of Financial Statements, AASB 107: Cash Flow Statements, AASB 108: Accounting Policies, Changes in Accounting Estimates and Errors, AASB 1031: Materiality, AASB 1054: Australian Additional Disclosures and AASB 1058: Income of Not-for-Profit Entities.

Basis of preparation

The financial statements have been prepared on an accruals basis and are based on historic costs and do not take into account changing money values or, except where stated specifically, current valuations of non-current assets.

The following significant accounting policies, which are consistent with the previous period unless stated otherwise, have been adopted in the preparation of these financial statements.

Going Concern

Although the 31 October 2020 financial year has presented the association with many financial challenges, which was attributable to a disrupted 2020 season due to the spread of COVID-19, the committee continue to prepare the financial statements on the going concern basis as the committee believe the association has sufficient resources to pay its debts as and when they fall due for the foreseeable future.

Accounting policies

(a) Revenue and other income

The association has applied AASB 15: Revenue from Contracts with Customers (AASB 15) and AASB 1058: Income of Not-for-Profit Entities (AASB 1058) retrospectively. This was because transitioning to AASB 15 and AASB 1058 had no material impact on the association's financial statement.

When the association receives funds, it assesses whether the transaction gives rise to a contract that has enforceable and sufficiently specific performance obligations.

When both conditions are satisfied, the association:

- identifies each performance obligation
- recognises a liability for its obligation
- recognises revenue as it satisfies its performance obligation.

When a transaction does not contain enforceable and sufficiently specific obligations, revenue is recognised immediately in profit or loss in accordance with AASB 1058.

Note 1. Summary of significant accounting policies (continued)

(a) Revenue and other income (continued)

This accounting policy applies to each of the association's significant revenue streams as follows:

Entry fees

Entry fees are charged to customers who attend Bendigo Junior Football League football games. The association's performance obligation is to provide such customers with entry to games throughout the season, with revenue recognised at a point in time when entry is provided.

Membership revenue

Membership fees are charged to members of the association. The association's performance obligation is to provide benefits to members throughout the football season, with revenue recognised over time throughout the relevant membership period.

Sponsorship revenue

Sponsorship revenue relates to services provided to customers and business partners. The association's performance obligation is to provide benefits to customers and business partners in accordance with each respective sponsorship agreement. Revenue is recognised over time throughout the relevant sponsorship period.

Fundraising activities

Fundraising activities include donations and contributions provided to the association by members of the community. Fundraising activities do not typically contain sufficiently specific and enforceable performance obligations and therefore such revenue is immediately recognised in profit or loss.

Apparel revenue

Apparel revenue include the sale of goods and services to members of the association. Apparel sales contain sufficiently specific performance obligations, with revenue recognised at a point in time once the promised good or service is transferred to the customer.

(b) Goods and Services Tax (GST)


Revenues, expenses and assets are recognised net of the amount of GST, except where the amount of GST incurred is not recoverable from the Australian Taxation Office (ATO). Receivables and payables are stated inclusive of the amount of GST receivable or payable. The net amount of GST recoverable from, or payable to, the ATO is included with other receivables or payables in the Assets and Liabilities statement.

(c) Income tax

No provision for income tax has been raised as the entity is exempt from income tax under Div. 50 of the Income Tax Assessment Act 1997.

(d) Cash and cash equivalents

Cash and cash equivalents includes cash on hand, deposits held at call with banks, and other short-term highly liquid investments with original maturities of three months or less.

Note 1. Summary of significant accounting policies (continued)

(e) Accounts receivable and other debtors

Accounts receivable and other debtors include amounts due from members as well as amounts receivable from sponsors. Receivables expected to be collected within 12 months of the end of the reporting period are classified as current assets. All other receivables are classified as non-current assets.

(f) Financial instruments

The association's financial instruments consist mainly of deposits with banks, receivables and payables.

Recognition, initial measurement and derecognition

Financial assets and financial liabilities are recognised when the association becomes a party to the contractual provisions of the financial instrument, and are measured initially at fair value adjusted by transactions costs, except for those carried at fair value through profit or loss, which are measured initially at fair value. Subsequent measurement of financial assets and financial liabilities are described below.

Financial assets are derecognised when the contractual rights to the cash flows from the financial asset expire, or when the financial asset and all substantial risks and rewards are transferred. A financial liability is derecognised when it is extinguished, discharged, cancelled or expires.

Classification and subsequent measurement of financial assets

All financial assets are initially measured at fair value adjusted for transaction costs (where applicable). For the purpose of subsequent measurement, financial assets are classified into amortised costs. The association does not utilise hedging instruments.

Classifications are determined by both:

- the association's business model for managing the financial asset
- the contractual cash flow characteristics of the financial asset.

All income and expenses relating to financial assets that are recognised in profit or loss are presented within finance costs, finance income or other financial items, except for impairment of trade receivables, which is presented within other expenses.

Financial assets are measured at amortised cost if the assets meet the following conditions:

- they are held within a business model whose objective is to hold the financial assets and collect its contractual cash
- the contractual terms of the financial assets give rise to cash flows that are solely payments of principal and interest on the principal amount outstanding.

After initial recognition, these are measured at amortised cost using the effective interest method. Discounting is omitted where the effect of discounting is immaterial. The association's cash and cash equivalents and trade and other receivables fall into this category of financial instruments.

Impairment of financial assets

The association makes use of a simplified approach in accounting for trade and other receivables and records the loss allowance at the amount equal to the expected lifetime credit losses. The association uses its historical experience, external indicators and forward-looking information to calculate the expected credit losses.

(f) Financial instruments (continued)

Classification and measurement of financial liabilities

The association's financial liabilities include trade and other payables. Financial liabilities are initially measured at fair value, and, where applicable, adjusted for transaction costs unless the association designated a financial liability at fair value through profit or loss.

Subsequently, financial liabilities are measured at amortised cost using the effective interest method except for financial liabilities designated at fair value through profit or loss, which are carried subsequently at fair value with gains or losses recognised in profit or loss. The association does not utilise derivative financial instruments.

All interest-related charges and, if applicable, changes in an instrument's fair value that are reported in profit or loss are included within finance costs or finance income.

(g) Accounts payable and other payables

Accounts payable and other payables represent the liability outstanding at the end of the reporting period for goods and services received by the association during the reporting period that remain unpaid. The balance is recognised as a current liability with the amounts normally paid within 30 days of recognition of the liability.

(h) Provisions

Provisions are recognised when the association has a legal or constructive obligation, as a result of past events, for which it is probable that an outflow of economic benefits will result and that outflow can be reliably measured. Provisions are measured using the best estimate of the amounts required to settle the obligation at the end of the reporting period.

(i) Comparative figures

Where required by Accounting Standards comparative figures have been adjusted to conform with changes in presentation for the current financial year.

When an entity applies an accounting policy retrospectively, makes a retrospective restatement or reclassifies items in its financial statements, a statement of financial position as at the beginning of the earliest comparative period must be disclosed.

(j) Key estimates

Impairment

The association makes use of a simplified approach in accounting for trade and other receivables as well as contract assets and records the loss allowance at the amount equal to the expected lifetime credit losses. The association uses its historical experience, external indicators and forward-looking information to calculate the expected credit losses using a provision matrix.

The association assesses impairment of trade receivables on a collective basis as they possess credit risk characteristics based on the days past due. At 31 October 2020, the provision for expected credit losses had not been recorded as it was not considered material to the financial statements (2019: nil).


