## **SECTION 1: INTRODUCTION**

This document outlines the Community Football Rules & Regulations for all Junior and Youth competitions conducted by the West Australian Football Commission (WAFC). These competitions shall be played according to the AFL Laws of Australian Football and any modified form of Australian Football as amended by the Australian Football League (AFL) or the WAFC.

#### 1. SPIRIT OF JUNIOR FOOTBALL

Every participant understands that Football in Western Australia is delivered to the Community with the Spirit of the Game in mind.

#### It is incumbent on every participant irrespective of their place in the game, to ensure that they will;

- 1.1. <u>Not focus on winning at all costs</u> and understand that the role of Junior & Youth Football is to foster the development of players, volunteers, umpires, coaches and officials. Learning to win and lose is part of the developmental journey of a participant but must remain secondary to the primary focus of player development.
- 1.2 Maximise the enjoyment and development of Junior & Youth footballers.
- 1.3 Provide our children with a game environment that is safe, fun and fair.
- 1.4 Ensure that the values which add to the spirit of our game, which include fairness, equality, respect and teamwork are encouraged and celebrated.
- 1.5 Uphold, promote and protect the Rules, Laws, Codes, Policies and Spirit of the game.
- 1.6 Not accept poor behaviours around our game and deter practices that undermine our games environments (coaching, playing, volunteering, spectating and umpiring).
- 1.7 Adhere to any directive issued by the games controlling bodies in the best interests of achieving the above.
- 1.8 Coaches should adopt an athlete centred coaching philosophy.

A Person must not engage in conduct which is unbecoming or likely to prejudice the interests or reputation of Junior Football or to bring the game of football into disrepute.

## 2. SUPPORTING UMPIRES OF JUNIOR FOOTBALL

Umpires play a key role in the successful delivery of Community Football. Coaches, officials, players and parents play a vital role in developing the highest quality umpires.

2.1 All team players, officials, parents and spectators are expected to adhere to the following; WA Football has a **ZERO TOLERANCE** stance against any form of umpire or official abuse, verbal dissent, intimidation or disputing of decisions.



- 2.2 Players, officials, parents and spectators are not permitted to comment about an umpire or the performance of an umpire in any way other than in writing to the Umpires Coach via the Club President.
- 2.3 Only the Captain or Team Manager from either team can approach an umpire during the breaks in a match. The Captain or Team Manager cannot question decisions, interpretations or question the free kick count.

## 3. INTERPRETATION & DEFINITIONS

All Committees, Coaches, Players and Parents should request interpretations, clarifications and explanations of the Competition Policies, Rules and Regulations via the Club President or Club Secretary.

## **SECTION 2: COMPETITION GOVERNANCE**

#### 4. COMPETITIONS

- 4.1 The WAFC shall arrange inter-club football competitions in specific year groups for players registered with affiliated junior clubs.
- 4.2 The WAFC may divide the area within its jurisdiction into sub-districts. It is recommended that all players residing within an allocated area play for the aligned club. The WAFC may alter, vary or add to the boundaries of its sub-districts as it sees fit.

#### **5. SCRATCH MATCHES**

Clubs may arrange scratch/practice matches outside of WAFC fixtured competitions. For insurance purposes:

- 5.1 All scratch matches must be played within the WAFC Policies and Rules & Regulations
- 5.2 All players must be registered through the WAFC approved registration system or fall within the four-week prospective members clause.
- 5.3 All scratch matches with official umpires are bound by the Laws of the Game, including penalties for reportable offences.

#### 6. RULES & REGULATIONS, POLICIES & CODES OF CONDUCT

All clubs, players, parents, spectators and officials are bound by the WAFC's Junior & Youth Football Policies and True Sport Codes of Conduct and are subject to penalties at the discretion of the WAFC for any breach.

Penalties handed down for breaches of these Rules & Regulations, Policies and Codes of Conduct can only be applied to and served in competitions within the scope of these rules.

## 7. DISPUTES & APPEALS – COMPETITION POLICIES, RULES AND REGULATIONS

Should any dispute or objection arise as to the meaning or interpretation of any of these Rules & Regulations, the WAFC shall settle such dispute or objection.

Clubs are entitled to appeal penalties and or decisions for any breach of the WAFC's Junior and Youth Football Rules & Regulations or Policies on the grounds that the penalty provided meets one of the following criteria:

- An error in the application of a rule has occurred.
- The decision of the Competition is so unreasonable that no Competition acting reasonably could have come to that decision having regard to the evidence before it.
- The sanction imposed by the Tribunal was manifestly excessive or inadequate.

The appeal will be heard by the relevant independent body as appointed by the WAFC.

#### Request to Appeal:

- 7.1 E-Points cannot be appealed if aligned to a Red or Yellow Card infringement.
- 7.2 A club shall submit a written communication addressed to the WAFC requesting to appeal a penalty within 48 hours of receiving notification of the penalty, accompanied by a non-refundable \$250 fee. Within the written request to appeal the club will outline on what basis the penalty meets the above appeal criteria.



#### **Appeal Panel:**

- 7.3 The Chair of the Appeal Panel may determine whether the case meets the Appeal Criteria prior to the panel sitting and has the power to determine that a case should not be heard on the basis that it does not meet the appeal criteria.
- 7.4 The Appeal Panel will determine whether the penalty fits within one of the appeal criteria based on the evidence provided and any new additional evidence provided by the club.
- 7.5 All members of the Appeal Panel must be independent to the case.

## **Appeal Hearing:**

- 7.6 If circumstances prevail whereby a hearing must be heard prior to the clubs next match, the WAFC will make a reasonable attempt for this to occur.
- 7.7 The Appeal Panel may use its full discretion to gather and take into account any relevant evidence in making its determination.
- 7.8 A club attending an appeal hearing may be represented by an advocate. An advocate may not be a legal practitioner.
- 7.9 The club will have the opportunity to present its case to the Appeal Panel.

#### **Appeal Decision:**

- 7.10 The Appeal Panel shall not dismiss any case on grounds of technicality.
- 7.11 The Appeal Panel will make a determination as to whether the penalty handed down by the WAFC is in breach of one of the appeal criteria.
- 7.12 The Appeal Panel will make recommendations as to what they believe the appropriate penalty should be.
- 7.13 The WAFC has discretion as to whether to implement the recommended penalty.
- 7.14 The WAFC will communicate the decision of the Appeal Panel back to the club within a reasonable period of time after the decision has been made.

#### 8. ALTERATION OF RULES & REGULATIONS

Should any situation arise which is not covered in these Rules & Regulations, then the WAFC Policies and Codes of Conduct shall apply.

- 8.1 The WAFC may elect to resolve any matter, which is not provided for in these Rules & Regulations and any such resolution shall immediately become an amendment to the Rules & Regulations and shall automatically be included herein.
- 8.2 Any variation (exemptions) to these Rules & Regulations must be approved by the WAFC prior to implementation.

## **SECTION 3: SEASON ADMINISTRATION**

#### 9. YEAR GROUPS

- 9.1 Any player who is repeating Year 12 at school is not eligible to play in the Year 11-12 competition and should be encouraged to join a senior community competition.
- 9.2 On application to the WAFC, a player may be eligible to play up a MAXIMUM of one year group only. In a combined age group, only the senior aged players can apply to go up to the next age bracket.
- 9.3 A player who does not meet the Physical Development Criteria or the Disability criteria for a play down must apply to the WAFC in writing for approval.
- 9.4 With reference to combined year groups, the WAFC or controlling body will make the final determination regarding play up applications. It is generally considered that only top aged players are eligible to play up a year group.



- 9.5 The granting of any such request shall apply only to the current season and can be subject to review by the WAFC during the current season.
- 9.6 A player who is playing down due to their current school year group, must supply a letter from the school confirming that they are attending school in the year group in which they are playing.

#### **Physical Development Criteria**

Players must apply to the WAFC for permission to play down a year group during the current season.

- 9.7 Approval will only be granted if the player submits written authority by a sports physician or doctor along with their application to play down a year group. The written authority should specify that the participant falls below the fifth percentile for height or weight.
- 9.8 A player granted permission to play down a year group will be eligible for the fairest and best votes for the grade in which they have received permission to play.
- 9.9 The granting of any such request shall apply to the current season only.

#### **Disability – Physical and Intellectual**

A player with a disability that limits their ability to play, may apply to the WAFC for permission to play down one or more year groups during the current season.

- 9.10 Approval will only be granted if the player submits written authority by a sports physician or registered medical practitioner along with their application to play down a year group.
- 9.11 A player granted permission to play down a year group will be eligible for the fairest and best votes for the grade in which they have received permission to play.
- 9.12 The granting of any such request shall apply to the current season only.

#### **Gender Diversity**

9.13 The WAFC is committed to inclusion and will utilise the AFL's Gender Diversity Policy in instances where Trans, Non-Binary or other Gender Identity is raised.

#### 10. CLUB OFFICIALS

Each Club shall elect Club administrators and officials who will be responsible for the effective and efficient operation of the Club. These officials may include:

- 10.1 President, Committees, Delegates to the RDC and other required officials who will be elected as per each club's constitution.
- 10.2 Each Club shall elect or appoint a Registrar who shall be responsible for the registration of players for that Club and shall keep a record of the achievements of those players as may be required. The Club Registrar shall be responsible for managing any changes to the personal details of any players registered with that Club in accordance with the WAFC approved registration system.
- 10.3 All District and Club volunteers may be subject to a Working with Children Check as per legislative requirements.
- 10.4 Clubs are to have in place a policy on 'Duty of Care' relevant to Club and Team officials. When adults have responsibility of care for children, Clubs must ensure the safety, health and protection of children. Clubs are responsible for the behaviour of its Club and Team officials in line with WA Football Policies.



#### 11. REGISTRATION

No player shall be eligible to take part in any match under the control of the WAFC until an online registration form is completed and approved through the WAFC approved Registration System.

- 11.1 Players must not alter their name or date of birth to register via the Registration System.
- 11.2 Players are not permitted to be registered and play in more than one Team, Club and/or District/Region which is playing in a single Junior Competition.
- 11.3 A Club Official must witness the birth registration number, State or country of birth or other authentication of birth date prior to playing a match.

## **SECTION 4: TRIBUNAL GUIDELINES**

#### 12. INTRODUCTION & SCOPE

The Tribunal Guidelines are adopted by WAFC and Country Junior Competitions to provide clubs, players and officials with clear guidelines for those who commit reportable offences.

The span of the Tribunal Guidelines is outlined below:

- Team Officials Year 3 to Year 12
- Players Year 7 to Year 12

#### 13. PROCESS

#### **Report**

The Junior Match Committee will assess all reports and potential Reportable Offences. Reportable Offences can be reported by the following groups:

- Umpire
- Umpire Coach
- Competition Official
- WAFC Staff Member

All Notice of Reports are to be received by 12pm Monday after the match is played.

The Junior Match Committee will gather the required information relevant to making a decision on whether a charge is made.

## Determination of type of offence and appropriate charge

Following the review of each report or referral, the Junior Match Committee will determine whether the charge is appropriate and alter the charge if required. There are three types of Reportable Offences:

- A low-level offence
- A classifiable offence
- A direct to tribunal offence (referred directly to the community football tribunal)

The Junior Match Committee will inform the player or official and their club president whether or not a reported or referred player/official has been charged and the corresponding base sanction for that charge by **5pm Monday** after the match is played.



#### Options available to the player or official charged with a reportable offence:

A player or official charged with a Reportable Offence may:

- Submit an early guilty plea, in which case the relevant sanction for the Reportable Offence
  will apply subject to a reduction available as a result of the early guilty plea as per grading
  table.
- Contest a charge at the Community Football Tribunal using evidence to show they are not guilty of the classifiable offence or guilty of a lesser charge.

The player or official charged must submit their Option by 12pm Tuesday after the match is played.

Timelines may be adjusted at the discretion of the WAFC under exceptional circumstances.

#### **Tribunal Hearing**

The tribunal will hear a charge for which a Player or Official has pleaded not guilty or has pleaded guilty to a lesser charge. The tribunal may find the Player or Official guilty of the original charge, a lesser charge or not guilty of any charge. The tribunal will determine the appropriate sanction within the Standard Range of Penalties for the Reportable Offence if it finds the player guilty of a Reportable Offence.

Unless requested for attendance by the Tribunal Chairman, Umpires or Victims may provide evidence prior to the Tribunal hearings however must be available to be contacted by the Tribunal Chairman during the hearing period if required.

Players, Officials and Umpires are permitted to be accompanied by an advocate however this advocate may not be a legal practitioner and is only to act in the role of providing support. An advocate will not be asked to provide evidence.

The Community Football Tribunal will operate within the Community Football Tribunal Guidelines.

#### **Appeal Hearing**

A player or official may decide to appeal the decision of the Tribunal to the Community Football Appeal Board based on one of the following criteria being applied:

- An error of law has occurred;
- The decision of the Tribunal is so unreasonable that no Tribunal acting reasonably could have come to that decision having regard to the evidence before it;
- The classification of the offence by the Tribunal was manifestly excessive or inadequate; or
- The sanction imposed by the Tribunal was manifestly excessive or inadequate.

All appeal lodgements must occur within 48 hours of notification of the Tribunal decision, accompanied by a \$250 non-refundable fee and articulate how the decision fits into one of the above stated appeal criteria.

Competition Management also reserves the right to appeal decisions of the Tribunal to the Community Football Appeal Board based on the above stated appeal criteria.

The Community Football Appeals Board will operate within the Community Football Tribunal Guidelines.



#### **14. REPORTABLE OFFENCES**

A reportable offence occurs where a Player or Official commits any of the offences set out in Law 22.2.2 of the Laws of Australian Football. Broadly speaking there are three categories of Reportable Offences - Low Level, Classifiable, and Direct to Tribunal Offences.

Any Offence defined in the AFL Laws of the Game but not specified in these Tribunal Guidelines will be categorised as Direct to Tribunal Offences.

#### **Low Level Offences**

## List of Low Level Offences

The following are low-level offences which do not require classification however may be addressed by the Junior Match Committee through the issuing of a Yellow or Red Card. In the case of a Red Card, the player will receive an automatic 1 match suspension.

If relevant and appropriate evidence is present, the Competition Officials have the powers to:

- Issue Yellow & Red Cards
- Upgrade a Yellow Card to a Red Card
- Downgrade a Red Card

Low Level Offences cannot be taken to the Community Football Tribunal:

- Attempting to strike, kick or trip another person whether by hand, arm, foot or leg.
- Careless contact with an umpire
- Spitting at another player.
- Engaging in a Melee, except where a Player's sole intention is to remove a Player from the same Team from the incident. \*
- Engaging in an act of staging.
- Making unreasonable or unnecessary contact with an injured Player.
- Using abusive, insulting, or obscene language.
- Engaging in Time Wasting.
- Throwing or pushing a Player after that Player has taken a mark, disposed of the ball or after the ball is out of play.

- Wrestling another person.
- Use of an obscene gesture.
- Disputing a decision of an Umpire.
- Pinching another person.
- Interfering with a Player Kicking for Goal.
- Failing to leave the Playing Surface when directed to do so by an Umpire.
- Intentionally shaking a goal or behind post when another Player is preparing to Kick or is Kicking for Goal or after the Player has kicked for Goal and the football is in transit.
- Wearing boots, jewellery and equipment prohibited under Law 9.
- Any other act of low-level misconduct which is not a Classifiable Offence or Direct Tribunal Offence.

<sup>\*</sup>Penalties may be applied to Teams who engage in a melee at the discretion of the WAFC.



#### **Classifiable Offences**

#### List of Classifiable Offences

The following offences are Reportable Offences that are graded by the Junior Match Committee to determine an appropriate base sanction:

- Striking another person.
- Kicking another person.
- Kneeing another person.
- Stomping on another person.
- Charging another person.
- Engaging in rough conduct against an opponent which in the circumstance is unreasonable.
- Bumping or making forceful contact to an opponent from front-on when that Player has their head down over the football.
- Behaving in an abusive, insulting, threatening or obscene manner towards or in relation to an umpire.

- Head-butting an opponent or making contact to an opponent using the head.
- Eye-gouging an opponent or making unreasonable or unnecessary contact to the eye region of an opponent.
- Making unreasonable or unnecessary contact to the face of an opponent.
- Scratching another person.
- Tripping another person whether by hand, arm, foot or leg.
- Using abusive, insulting or obscene language towards or in relation to an Umpire.

**Note:** WAFC or Competition Officials may use their discretion to establish an appropriate prescribed penalty for Behaving in an abusive, insulting, threatening or obscene manner towards or in relation to an umpire.

As indicated in the table above, the determination of a base sanction for a Classifiable Offence will be made based on an assessment of whether:

- 1. The conduct is Intentional or Careless,
- 2. The impact is Severe, High, Medium or Low; and
- 3. The Contact with the other Player/Official is High/Groin or to the Body

All penalties (Base Sanction and Early Guilty Plea) will be doubled if the player or official has been found guilty of a reportable offence within the past 12 months.

## Reduction in base sanction for early guilty plea

The base sanction for Classifiable Offences will be subsequently decreased where a player submits an early guilty plea.



#### **Direct to Tribunal Offences**

#### List of Direct to Tribunal Offences

The following offences are Reportable Offences that are sent directly to the Community Football Tribunal to determine an appropriate penalty within the Standard Range of Penalties:

- Intentionally making contact with, or striking, an Umpire.
- Attempting to make contact with, or strike, an Umpire.
- Carelessly making contact with an Umpire.
- Spitting at or on an Umpire.
- Spitting on another person.
- Instigating a Melee.
- Any classifiable offence which attracts a base sanction that the Junior Match Committee finds inappropriate.
- Any other act of serious misconduct which the Junior Match Committee considers appropriate to send to the Community Football Tribunal.

The Community Football Tribunal will determine the appropriate sanction for a Direct to Tribunal offence within the Standard Range of Penalties.

#### **16. SUSPENSIONS**

- Any player, Official, Club Member or Spectator suspended by either a tribunal or prescribed penalty in a WAFC affiliated competition will not be permitted to play, coach or participate in any capacity, in any WAFC affiliated competition including schools, senior metropolitan community football or regional football, for the duration of the penalty unless otherwise stated by the WAFC.
- Any player, Official, Club Member or Spectator reported or in receipt of a prescribed penalty notice, is not to play or act in any official capacity in a WAFC affiliated competition until such time as the charge has been dealt with.
- Any player, Official, Club Member or Spectator who chooses to contest a Red Card, Report or Prescribed Penalty is deemed suspended until such time as the charge or report is dealt with to the satisfaction of the WAFC.
- A player, Official, Club Member or Spectator found guilty of an offence who has been given a suspension, fine or any other sanction by the Community Football Tribunal, shall not be permitted to enter the Arena on Match Days while the penalty remains unserved.

#### **POLICY BACKGROUND**

Member protection is a term used by the Australian sports industry to describe the practices and procedures that protect an organisation's members - both individual members such as players, coaches and officials, and the member organisations such as clubs and other affiliated organisations. It involves:

- protecting members from harassment, abuse, discrimination and other forms of inappropriate behaviour
- adopting appropriate measures to ensure the right people are involved in an organisation, particularly in relation to those involved within junior sport
- providing education
- promoting and modelling positive behaviour

## **WAFC POL.02: Communications Policy**

#### **PUBLIC STATEMENT**

All media enquiries should be directed through the West Australian Football Commission. District, Club and Team representatives should not make public statements about WAFC managed competitions.

#### **SOCIAL MEDIA**

The WAFC has an obligation to ensure that affiliated clubs maintain a safe physical and emotional environment for its members and this includes cyber safety and the safe and responsible use of Internet and Information & Communication Technologies (ICT). Individual members also have a responsibility to use ICT in a safe and responsible way, and not bring the game into disrepute.

This policy outlines the expectations of all Community Football stakeholders in ensuring we create a cybersafe environment

By way of affiliation the AFL National Social Media Engagement Policy applies to all clubs.

#### **ACCOUNTABILITIES**

All Community Football stakeholders, including clubs and their members will create a cybersafe environment by:

- Using the WAFC/Community Football Club's name, motto, crest and/or logo only in an appropriate way in line with the organisation's guidelines,
- Using the WAFC/Community Football Club's websites to provide information about competitions, committees, policies, rules, social events or other important sport related issues,
- Using SMS and/or email by officials, managers, coaches etc. to communicate organisation business and organisation sanctioned social events (via parents in the case of juniors),
- Using the WAFC/Community Football Club's social network pages to promote positive organisation news and events (with permission obtained from featured individual(s) and via parents for juniors),
- Ensuring content of posts or electronic communication doesn't breach any WAFC/Community Football Club policies or codes of conduct,
- Ensuring content of posts or electronic communication doesn't breach state or commonwealth
  law. This includes not engaging in 'sexting' where a member sends or is in possession of an
  inappropriate sexualised image of a person under the age of 18 years this is a criminal offence
  in WA and the Police will be informed immediately,
- Not engaging in cyber bullying, including but not limited to:
  - o harassing, teasing, intimidating or threatening another person via electronic means,
  - sending or posting inappropriate digital pictures or images, email/instant/phone/text messages, or website postings (including social network sites i.e. Facebook or blogs) and is irrespective of whether the page could be viewed by the wider public or not,





 Members will remain responsible for and be vigilant of the content and security of their individual accounts such as email, social networking (i.e., Facebook), micro blogging (i.e., Twitter), video sharing (i.e., YouTube), picture sharing (i.e., Instagram) and mobile phones.

#### **PENALTIES**

Any breach of this policy will be investigated by the WAFC and penalties may be issued at the absolute discretion of the Competition Team. Penalties include but are not limited to suspension, fines, loss of E-Points and/or sanctions.

Any cyber-bullying or threats to participants including officials and umpires via social media will not be tolerated and may attract significant penalties.

#### **POLICY BACKGROUND**

The West Australian Football Commission will ensure that equal opportunities for participation in football are made available to all children, regardless of ability, size, shape, gender, age, disability or ethnic origin.

#### **RULES**

#### 1. FEMALE PARTICIPATION

Single sex (all boy/all girl) competitions are preferred if teams can be arranged within the schools or junior districts and/or country regions.

**1a** Females can participate with males until and including Year 9.

#### 2. PLAYER ROTATION

It's the role of the coach to ensure all players, regardless of their age, size, gender, ability or the competition they are playing in, are given an equal opportunity to play in a variety of positions on the field. This is important in allowing players to gain experience and learn and develop the skills of each position. Adhering to this policy and its intent ensures all players and parents feel they are getting a fair go and are a part of the team, enhancing overall participation in Junior & Youth Football.

- Every player in a team must play at least half (50%) of a game. This only applies to the first game a player plays in a weekend, e.g. if a player has completed a match with their team and then plays up for another team who is short of players, that player is not required to play 50% game time in the second match.
- **2b** All players must play equal game time across the season.
- **2c** Each team is required to track player game time utilising an app or program prescribed by the competition.

## 3. MAXIMISE PARTICIPATION OPPORTUNITIES

Coaches are required to utilise all available players up to the maximum allowable on the bench.

Coaches must utilise all places in the team for each match and play the maximum number of players available to them. This includes finals but only refers to players that are qualified to play in the final.

#### **POLICY BACKGROUND**

Sports Medicine Australia has developed guidelines entitled "Participation of the Pregnant Athlete in Contact and Collision Sports".

The guidelines are intended to provide recommendations to the pregnant athlete and sporting organisations on safe participation in contact and collision sports during pregnancy.

#### **SUMMARY OF GUIDELINES**

Football is classified as an unlimited contact and collision sport;

- Contact or collision is frequent and maybe quite forcible,
- A high risk of falls, blows to the abdomen and contact with a projectile exists,
- In a normal pregnancy, participation can only be recommended during the first trimester.

#### **RECOMMENDATIONS**

- Display a copy of the summary of the statement issued by the Medicine and Science for Women in Sport committee of the Australian Sports Medicine Federation on club notice board so that players can make an informed decision about playing,
- Encourage any player that is pregnant to seek the advice of a medical professional,
- Provide a safe environment for all footballers.

#### **INSURANCE & THE PREGNANT PLAYER**

The pregnant player is provided with the same personal accident policy that is provided for all registered members of the football leagues. However, the player is not covered if the resultant injury is found to be due to the pregnancy. NO cover is provided for the unborn baby.

#### **POLICY BACKGROUND**

Environmental factors regularly affect the playing of Australian Football. While environmental factors will not usually influence whether an Australian Football Match should commence or continue to be played, occasionally extremely adverse weather conditions may give rise to a need to assess whether players and/or officials are in environmental danger. This policy sets out the approach that the Football Body should adopt when assessing extreme weather conditions.

As an affiliated state body of the AFL, the West Australian Football Commission subscribes to the AFL Extreme Weather Policy which can be found at <a href="https://www.afl.com.au/policies">www.afl.com.au/policies</a>.

#### **RESULTS**

If a game is abandoned due to weather conditions, the WAFC shall decide if the fixture is to be rescheduled or determine a result according to the progress score and point of the game at which the game was abandoned.

For all final round matches all decisions pertaining to the above rules will be controlled by the WAFC or their appointed officials as per the following guidelines:

- Games abandoned <u>prior</u> to half time, the Match Day Official will contact the Match Day Management Committee (Conference CDM & Team Leader) for guidance on how to proceed.
- Games abandoned <u>after</u> half time will have the team with the higher score deemed to be the winner.

#### **RESPONSIBILITY**

All clubs competing in a competition administered by a Football Body should monitor environmental factors. Umpires in consultation with the a WAFC competition official are responsible for the ongoing assessment of suitability to play in line with the respective AFL policies.

## **WAFC POL.08: Protective Equipment Policy**



#### **GENERAL INFORMATION**

#### **POLICY BACKGROUND**

The West Australian Football Commission understands that due to the nature of Australian Football, parents and players may want to take certain safety measures to ensure they are protected while participating in training and matches. In doing this, the WAFC must ensure that any protective equipment is suitable for football and that the safety of all participants is considered.

#### **RULES**

#### 1. MOUTH GUARDS

1a The WAFC strongly recommends that all players wear a mouth guard when either at training or playing football.

#### 2. PROTECTIVE HEAD GEAR

- 2a A player who desires to wear protective headgear during a match must wear Sports Physician or Doctor approved headgear that is suitable for football.
- The necessary headgear approval form, signed by a competition official, must be available to the umpire to view at each match. The umpire is authorised to forbid the player from participating in the game or ask the player to remove the helmet if the form of approval is not shown.

#### Players suffering from disabilities or medical conditions:

A player who has a disability or medical condition which could potentially result in injury is required to have a certificate from a medical practitioner certifying that the player will (in the view of the medical practitioner) receive adequate protection from the protective headgear. The necessary forms are available from the WAFC.

## 3. SPECTACLES

To minimise the risk of injury, players wishing to wear spectacles during matches and training must wear spectacles with plastic frames and plastic lenses. Spectacles must be held on securely by a band.

#### 4. OTHER PROTECTIVE GEAR

- 4a Players are not permitted to wear a Plaster Cast during a game.
- **4b** Players are not permitted to wear jewellery including wrist bracelets.
- 4c Medical bracelets are permitted however they must be taped and marked 'MEDIC'.
- 4d All other protective gear must be approved by the WAFC. This includes but is not limited to shin guards, diabetic pumps and kidney guards.

The West Australian Football Commission takes an extremely firm stance on eliminating this type of behaviour from the game.

## WAFC POL.10A Competitions Policy: Team Selection & Nominations Rooms

#### **GENERAL INFORMATION**

#### **POLICY BACKGROUND**

The West Australian Football Commission is committed to forming fair, even and competitive competitions that enable young players of all abilities to have fun, actively participate and improve their knowledge and skills of the game. The intent of this policy is to:

- a) clearly outline the team nomination process.
- b) provide guidance on how clubs can allocate players to teams in instances where there is more than one team in a year group.

#### **TEAM NOMINATIONS**

The West Australian Football Commission will establish a date each year where clubs will submit team nominations for year groups in which they wish to field teams for the upcoming season. The WAFC shall consider all nominations and where possible shall include teams in competitions as nominated.

#### **RULES**

1a

#### 1. TEAM NOMINATION REQUIREMENTS

Each team nomination should include the name and other relevant details of the following people:

i. An accredited coach capable of teaching players the laws and skills of Australian Football in line with the Spirit of the Game and the WAFC's True Sport Codes of Conduct

ii. A manager capable of assisting the coach by carrying out clerical and other duties relating to the efficient functioning of the team.

#### 2. ENTERING MULTIPLE TEAMS IN A DIVISION/YEAR GROUP

If a club enters more than one team in a single division in any year group or has multiple teams in a year group, then the following is to apply.

- Each team nominated by the respective club must be done so in such a way that each team is competitive within its nominated division.
- **2b** If a club has two teams in one division, it must be done so in such a way that each team is competitive within that division.
- If the teams are viewed to be uncompetitive by the WAFC within the first five rounds as per Rule 4 of this document, the WAFC has the power to direct the club to re-allocate players.
- 2d If the club is directed to re-nominate the teams, the club will resubmit the teams and will be subject to further review by the WAFC.
- Specific competition rules regarding entering multiple teams in a division/year group can be found in the individual Competition Rules documents.

#### 3. TEAM WITHDRAWALS

A Club which withdraws a team or teams from any competition without a reason acceptable to the WAFC, may be liable to a penalty. If a team is withdrawn from a competition after the commencement of a season, the WAFC shall determine how the fixtures will be re-organised and for which games premiership points will be awarded.



## WAFC POL.10A Competitions Policy: Team Selection & Nominations FOOT

#### **UNCOMPETITIVE TEAMS PROCESS**

This process provides clubs a clear and transparent process for determining whether a team is uncompetitive under Rule 2 of this document, and how the WAFC will work with a club to rectify this.

#### **RULES**

<b>4</b> a	Prior to the season, the WAFC will formally notify any clubs if they believe a team may be deemed uncompetitive based on the previous year's results which will include a recommendation to reallocate players across teams prior to the season beginning		
4b	At any point across the first five rounds of the season, the WAFC may formally notify clubs if they believe a team may be deemed uncompetitive and provide a recommendation to re-allocate players across teams.		
4c	<ul> <li>For a team to be deemed uncompetitive they must meet the following criteria as a minimum.</li> <li>i. Must have lost a minimum of three matches by 60 points or more across the first five matches.</li> <li>ii. A Competition Official must have attended two matches across the first five matches and have made an assessment that the team is uncompetitive within the context of the match at both matches.</li> </ul>		
4d	If a team is deemed uncompetitive at the conclusion of Round 5, they will be requested to provide evidence to the competition that they have taken steps to improve the competitiveness of the team, including re-allocating players between teams within the club.		
4e	If a team is deemed uncompetitive and the club refuses to re-allocate players after the completion of Round 5, that team will not be eligible to play for premiership points for the remainder of the season.		

#### **TEAM ALLOCATION**

There are various methods a club may choose to adopt when allocating players among two or more teams in a year group. The WAFC suggests that Clubs consider each of the below methods.

- Even Teams: Ensuring each team is of equal strength.
- Friendship Groups: Ensuring players are able to play with their close friends.
- School Groups: Ensuring players are able to play with their school friends.
- Annual Rotation: Ensuring players are able to experience playing with different players and are prepared for older year groups when there is an increased likelihood that teams will merge.

The below table is designed to assist clubs in managing multiple teams in a year group. It outlines when and how to split players across multiple teams to ensure all teams are competitive within their division and that players are provided with the best opportunity to enjoy playing, learning and developing the skills of Australian Football.

## WAFC POL.10A Competitions Policy: Team Selection & Nominations

#### 5. ADOPT A CLUB MENTALITY OVER A TEAM MENTALITY

Clubs are encouraged to adopt a club mentality rather than an individual team mentality. This will encourage long-term friendships that extend beyond school groups and past teammates and minimises the impact of players having to move or merge teams during their Junior Football career.

The WAFC encourages teams from the same club, in the same year group to train together as one. The benefits of doing this include:

- Building a strong club culture
- Encouraging strong friendships between a larger group of players and parents making any regrade or reallocation of players less daunting for players and their families.
- Ability to run more effective training sessions with larger numbers at training, implementing a hub training model which keeps players engaged and exposes them to a variety of coaches and coaching styles.
- Sharing of resources green space, coaches, equipment etc.

## 6. WHEN SHOULD CLUBS MERGE OR SPLIT TEAMS?

With a focus on participation, the WAFC looks to maximise the number of opportunities for as many young players as possible to play the game. As such, denying registrations and turning players away is discouraged, however the WAFC understands the complications involved when deciding whether to enter one or more teams in a year group. The below table will act as a guide to assist clubs in working through these decisions.

Year Group	1 Team	Requires Action	2 Teams	3 Teams
12-a-side Competitions	9 – 18 players	19 – 22 players	23 – 34 players	35+ players
15-a-side Competitions	12 – 23 players	24 – 28 players	29 – 46 players	47+ players

#### **Action Required**

If a club sits within the above 'Requires Action' column for any of their year groups, the below options are available and should be considered:

#### 1. Recruitment:

Work together with WAFC district staff to recruit additional numbers in order to enter a second team.

#### 2. Utilising current WAFC Policies, Rules & Regulations:

Enter a second team and utilise current Junior Football Policies, Rules & Regulations to ensure sufficient numbers for a match, which includes:

- Play Ups see 9.2 of the WAFC Community Football Junior Rules & Regulations.
- Even Up see WAFC POL.15D Game Day Even Up

#### 3. Player Permitting:

The WAFC has developed a WAFC.POL21 Rotating Player Permit Policy, which enables teams with excess players to temporarily permit their players to a nearby club to assist with teams who are low on numbers. This is a great way of ensuring players get maximum playing time and more opportunities to touch the football and further develop their skills rather than not playing or sitting on the bench.

#### 4. Team Mergers:

Work together with neighbouring clubs who may also be low on numbers in the same year group, to enter a merged team.

## Considerations

The below considerations must be made, particularly when numbers sit within the 'Requires Action' column in the above table:

## WAFC POL.10A Competitions Policy: Team Selection & Nominations Policy: Team Selection & Nominations



- Entering one team with too many players results in excessive interchange sizes, reduced game time and fewer coaches per player.
- Entering a second team with too few players increases the number of coaches and volunteers required.
- Priority should be given to returning and new players over players transferring in from other clubs.

#### 7. WHO SHOULD SPLIT PLAYERS BETWEEN TWO OR MORE TEAMS?

The Club President and/or the Club Coaching Coordinator in consultation with the head coaches within a year group should make the decision on when and how players should be split into multiple teams.

## 8. HOW SHOULD PLAYERS BE SPLIT BETWEEN TWO OR MORE TEAMS?

The WAFC suggests that clubs should endeavour to make their teams as even as possible, splitting players based on their skills, size, speed and overall ability. The method below has been employed by several Junior Clubs in the past with great success.

**Step 1:** Assign each player a rating from 1 through to 5 (1 being the strongest).

**Step 6:** Assess the two teams and consider how they would compare in a match. Fine tune the teams by making any necessary changes to ensure teams are as even as possible in terms of players' physical size and speed and overall team balance. Once again only swap players of the same value.

**Step 7**: As teams have been split evenly, they should be nominated in the same competition during the Team Nomination process. Please discuss with your WAFC Competition staff who will provide guidance as to the most suitable division for your teams.

#### Considerations

Please consider the below when following the above procedure:

- For clubs affected by PSA boarders, please ensure there are an equal number of boarders spread across the two teams.
- Upon request to the WAFC, Clubs will have the ability to make changes over the first two rounds of the Home & Away season, providing flexibility to get team balance right.
- After teams have been split, they are still encouraged to train together as per Rule 5 above.
- The WAFC encourages clubs to follow this process and reallocate players to a new team each season.
  The idea behind this is to promote players' individual development and allows them to experience
  the game playing with different teammates. It also promotes a club over team mentality where
  players are exposed to different coaches and coaching styles and encourages new friendships in both
  the player and parent groups.

#### **POLICY BACKGROUND**

All West Australian Football Commission competitions adhere to the AFL National Player Transfer Regulations. In addition to the national regulations, the below transfer and permit rules apply to all Junior & Youth Competitions under the control of the WAFC.

#### **LOCAL TRANSFER RULES**

At the full discretion of the WAFC Competitions Team, any one team with five or more WAFL Development Squad players can be penalised for transferring or permitting in any additional Development Squad players. Penalties include but are not limited to Premiership Points and can be reviewed and applied at any stage of the regular season.

#### PRIMARY REGISTRATION OF YOUTH PLAYERS

With the exclusion of WAFL Club listed participants, registered players who turn 18 on or after July 1 of the given year should hold their Primary Registration with a Junior Club or a club that have teams registered in a Junior competition. Players can Type-2 permit to Senior Community Clubs within partnership agreements.

Any players who turn 18 on or after July 1 who requests a transfer to a senior club are subject to approval by the WAFC.

#### **PREMIERSHIP POINTS**

Premiership Points are awarded in all West Australian Football Commission run competitions in Year 7 and above.

#### **E-POINTS**

The purpose of the E-Point system is to weight game day behaviour with the same importance as winning a match and reward teams for displaying positive game day behaviour. The system deters players, coaches and parents from engaging in negative game day behaviour prior to it taking place. The E-Point model is applied to all competitions from Year 7 and above.

#### **RULES**

2a	A maximum of four E-Points will be awarded per team per game for each completed regular season match. The team's behaviour (including that of players, team officials, support staff or spectators) will determine if any of these E-Points will be deducted.
2b	One E-Point will be deducted for every Yellow Card received by each participating team on game day and the penalised club may be liable for a financial fine.
2c	Two E-Points will be deducted for every Red Card received by each participating team on game day and the penalised club may be liable for a financial fine.
2d	Two E-Points will be deducted from a team who has a player, parent/spectator or official who is issued a prescribed penalty with a base sanction of one match or more.
2e	Up to four E-points may be deducted from a team for any code of conduct, policy or bylaw breach relating to inappropriate game day behaviour. This is at the sole discretion of the WAFC.
2f	If any breach occurs during a break of play or after the final siren, the number of E-points deducted will be doubled as the umpire does not have the ability to award a free kick.
<b>2</b> g	During Finals, the WAFC can substitute financial fines in the place of E-Point penalties.

#### **POLICY BACKGROUND**

The West Australian Football Commission is committed to the health and safety of all people who play the game of Australian Football in WA. Concussion is a brain injury that occurs from impact to a player's head, either through collision with another player (which includes whiplash from body contact) or with the ground. Whilst the skull is in place to protect the brain, in a high impact collision, the brain can move back and forward within the skull causing temporary dysfunction.

#### **GUIDELINES**

Head impacts can be associated with serious and potentially fatal brain injuries. In the early stages of injury, it is often not clear whether you are dealing with a concussion or there is a more severe underlying structural head injury. For this reason, the most important steps in initial management include:

- 1. Recognising a suspected concussion;
- 2. Removing the player from the game;
- 3. Referring the player to a medical doctor for assessment.

Any player who has suffered a concussion or is suspected of having a concussion must be medically assessed as soon as possible after the injury and **must NOT** be allowed to return to play in the same game/practice session. There should be an accredited first aider at every game and the basic rules of first aid should be used when dealing with any player who is unconscious or injured.

The App also assists Parents/Guardians in managing their child's recovery program based on the symptoms displayed as well as guide the Parents/Guardians on their child's safe return to school, training and games.

#### **POLICY BACKGROUND**

The West Australian Football Commission has negotiated in conjunction with the AFL, an Australian national insurance program with Insurance Brokers Marsh (formerly JLT). The program covers four critical areas of insurance:

- Player and Volunteer Personal Accident,
- Public Liability,
- Asset protection (theft and/or damage), and
- Associations (Directors and Officers Liability)

The national scheme covers each junior club from November 1 to October 31 at the base bronze level for Personal Accident. Upgrades to higher levels and therefore higher returns on claims are available after contacting Marsh direct.

#### **TYPE OF COVER**

All clubs are insured at a basic Bronze level coverage and should investigate upgrading their level of cover.

Within the AFL National Risk Protection Programme, Marsh covers all players who are registered to play with a club to the level of cover taken out by that club. In acknowledging that some players train to assess whether they want to register and play the full season, there is scope within the policy whereby 'prospective members' are covered for up to 4 weeks after their initial engagement with the club. If the player or member doesn't register within 4 weeks of their initial engagement with the club, they won't be covered

#### **POLICY BACKGROUND**

The West Australian Football Commission has developed a new Umpire fee structure with a clear focus on improving the match day environment by increasing attraction and retention rates and building a strong pathway for Community Football Umpires.

All Junior Umpire Fees will be reviewed annually as the WAFC continues to look at ways to reduce and clearly define payment levels. This will hopefully remove some of the barriers allowing for greater flexibility for Umpires to be appointed games across various levels of Community Football. From a Club and League volunteer perspective, the simplification of Umpire fees will also reduce confusion and administrative workload around Umpire payments.

The WAFC shall fix the maximum fee for umpires annually prior to the commencement of the season.

#### **PAYMENT**

Electronic Funds Transfer (EFT) is the preferred payment method with 50% paid by each team. This process was successfully implemented in 2020 across most Metro Junior competitions with the intention of having every junior District adhere to this process.

In the event of a forfeit less than 24 hours prior to a game, Umpires will still be required to be remunerated, with the entire cost being paid by the team forfeiting.

The WAFC recommends that where possible, clubs use the lower range of the above ground sizes to improve player development.

Field sizes are reduced in younger age groups, female competitions, and 15-a-side competitions to suit players' skill level and ability and to cater for the reduced number of players.

Reduced field sizes allow for 'cross-field' matches in Year 7 - 8 and allow for more matches to be played in the same timeslot, reducing the impact on volunteers and increasing ground availability.

The above ranges have been purposefully overlapped to allow for less ground configurations on match day.

Ground configuration examples have been outlined in **Figure 2** of the **Ground Preparation Diagrams** section.




This document outlines the duration of Junior & Youth matches controlled by the WAFC, including the length of time between quarters and any rules surrounding time on/extra time.

#### **RULES**

#### 1. MATCH DURATION

As per the WAFC Competition Rules, the length of match duration for all Junior & Youth Matches controlled by the WAFC shall be as follows:

1a Year 3 – Year 6: 4x 15-minute quarters

Year 7 - Year 8: 4x 15-minute quarters

Female Year 9 – Year 11: 4x 15-minute quarters

Male Year 9 - Year 12: 4x 20-minute quarters

#### 2. TIME ON/EXTRA TIME

No time on may be added to any game, except:

- i. If the field umpire suspends play (by blowing their whistle and indicating to the Time Keeper with both hands above their head in the shape of a "T") due to a player sustaining an injury that requires the use of a stretcher or that the Umpire considers serious.
- ii. If the field umpire suspends play in the event of any Order Off offence committed by a player or official.
- iii. If a Captain approaches the field umpire to request a head count.
- iv. If in the opinion of the field umpire, exceptional circumstances are warranted.

#### 3. INTERVALS

2a

The maximum times allowed for intervals between quarters in all age groups are:

- i. First quarter interval shall be not more than five minutes.
- ii. Half time interval shall be not more than ten minutes.
- iii. Three quarter time intervals shall be not more than five minutes.
- iv. Upon a second warning from the umpire, if a team has not made an acceptable effort to take the field, the umpire shall award a free kick to the opposing team. Should both teams be offending the umpire will pay a free kick to the 1st returning team.
- v. In addition, if any team is deemed by the Umpire to be in breach this rule, the coach(s) of the offending team(s) shall be reported for engaging in time wasting.

#### 4. FINALS

3a

Should the final scores of both teams in any final round match, including the Grand Final, be equal at the end of the time allocated for the match, such match shall be extended by two additional periods of five minutes with no time on, in which the teams shall change ends and kick to either end of the ground alternatively.

Should the scores still be tied at the end of these addition periods the team captains will decide which team will kick to which end of the ground by the toss of a coin and play will then resume until one team scores and that team shall be declared the winner.

This document outlines the Send Off Rule that is to be applied in all Junior & Youth Football matches controlled by the WAFC. The Send Off Rule is in place in order to positively address the Game Day Environment in Junior Football

#### **RULES**

#### 1. GENERAL

**1a** Umpires can issue Yellow and Red Cards to any player, official or spectator as deemed necessary.

#### 2. YELLOW CARDS

- 2a An offender ordered off for a Yellow Card offence can be replaced immediately but is prohibited from taking the field for 15 minutes playing time.
- **2b** In the event that a Player or Official:
  - i. Is issued with two Yellow Cards on the day of the match, then the offender shall take no further part in the game and cannot be replaced for 15 minutes and receives an automatic 1-week suspension.
  - ii. Is ordered off for a Yellow Card offence and fails to leave the field immediately when directed by the field umpire, then the offender shall be reported for misconduct and consequently be deemed to have committed a Red Card offence.
  - iii. Is issued with three Yellow Cards over the duration of a season, then the third and every yellow card received thereafter shall be upgraded to a Red Card at the conclusion of the match, resulting in an automatic one-week suspension.

#### 3. RED CARDS

- An offender ordered off for a red card offence cannot be replaced for 15 minutes playing time. The offending player may not return to the field for the remainder of the match.
- **3b** The offending player will be penalised in line with the Junior Football Tribunal Guidelines.
- A player, club/team official or spectator who fails to leave the arena immediately when directed by the umpire shall be reported for misconduct, the match shall be terminated, and the offending person's team will forfeit the match.
- **3d** Any official who receives a red card (which is upheld) will also have the details of the incident entered on the WAFC Red Flag system.
- **3e** Once the leaving the playing arena, the participant's club should assist the person receiving the red card to remove themselves from the venue as soon as practically possible.

#### 4. SWEARING

As per the AFL Laws of Australian Football, if a player swears during a game (and is overheard by an umpire) then a free kick, 50 metre penalty or a red/yellow card can be paid against the player as a means of positively addressing the game day environment with Junior Football.

GROU	GROUND ENCROACHMENT			
1	In the event of an encroachment of the area of play by unauthorised persons, or that play is prevented by any other means, the field umpire shall seek the assistance of fellow umpires and/or any member of the WAFC to clear the playing arena so that the match may be resumed. If the field umpire is unable to do this within a reasonable time, they shall terminate play at that time and report all circumstances to the WAFC. This body may award the result or declare the match abandoned, forfeited or call a replay at its discretion or in line with AFL Laws of the Game.			
2	Any Club whose officials, players and club spectators are found to be responsible for the unauthorised encroachment of any playing arena (and any official, player and club spectators so responsible) shall be liable for penalty.  Penalties can include but are not limited to, yellow or red cards, fines, e-points, match suspensions and deregistration.			
3	The home club (or the team mentioned first in the fixture) is responsible for ground security on the match day.

#### **POLICY BACKGROUND**

As per WAFC POL.15A – Ground Preparation, a stretcher is required at all Junior and Youth matches under the control of the WAFC, including finals.

#### **RULES**

1. CA	1. CALLING FOR A STRETCHER		
1a	Any player who in the opinion of the injured player's team officials requires the assistance of a stretcher shall be attended to by a suitably trained and certified medical officer trained in the use of a stretcher prior to removal of that player.		
1b	Only authorised persons are permitted to enter the field of play and no team meetings or coaching is permitted during this time. Players must remain in their positions ready for recommencement of play.		
1c	Should a coach enter the field of play during a stretcher call and in the opinion of the umpire was doing so to provide instruction, a free kick will be awarded to the opposing side in front of goal at the end of the 10-metre square. (This rule will not apply if the 10 minutes or quarter break becomes enforced).		
1d	Should both teams' coaches enter the field of play for the purpose of giving instruction, play will resume as would be the case under the rules of the game and both teams will have a fine imposed at the discretion of the WAFC.		
1e	Umpires will report all stretcher call outs and the outcomes on the match documentation.		
2. REI	MOVAL OF A PLAYER		
<b>2</b> a	If the stretcher has been called for by an authorised person, then the player will be removed from the playing field via the most direct route for play to recommence and the injured player may be replaced through the interchange.		
2b	If a player is removed from the field on a stretcher then that player will not take any further part in the game whatsoever.		
2c	If a field umpire or team medical officer is of the opinion that a player cannot be moved from the field of play due to the severity of an injury, then play may be abandoned for the game at the discretion of a meeting between the two Team Managers and the Field Umpire and/or any league appointed official (i.e., match day steward). The WAFC shall be advised of any such abandonment for the purpose of either rescheduling the fixture or determining a result according to the progress score and point of the game at which the game was abandoned. For all final round matches all decisions pertaining to the above rules will be controlled by the WAFC or their appointed officials.		
3. TIN	MEKEEPING		
3a	The timekeeper shall stop the clock once the field umpire has called time after a stretcher has entered the field of play, and shall restart the clock at the time the field umpire recommences play and calls time.		
3b	The timekeeper shall record the time out and the time of the quarter at which point the clock was stopped.		
3c	If the time taken to attend to the injured player exceeds 10 minutes from the time out the following will apply:

- If the quarter would have ended during the delay time will be called for the quarter and play will recommence for the next quarter after the standard break.
- If the final quarter is in progress and the stretcher is called for, the remaining time will be played out once play recommences.

# **WAFC POL.J Match Operations Policy: Blood Rule**

#### **POLICY BACKGROUND**

This document outlines the rules relating to player bleeding during matches and is in place to ensure the safety of participants with a purpose of minimising the risk of spreading blood born infections.

#### **RULES**

1. BLC	OOD RULE
1a	No Club shall allow any player to participate in any match or continue to participate in any match for so long as such player:  i. is bleeding ii. has blood on any part of their person or uniform.  If an Umpire observes a player who is bleeding or has blood on any part of their person or uniform, the Umpire shall act as follows: i. On observing that a player is bleeding or where any item of uniform or any part of the player is covered in blood, the field umpire shall direct such player to leave the field immediately after a break in play arises (i.e. score, free kick, mark, field bounce, boundary throw in). ii. When a boundary, goal or emergency umpire observes the need for this rule to be implemented, at the first possible break in play they will alert the field umpire. iii. Only the field umpires can direct a player to leave the playing field, thereby ensuring the team is not disadvantaged by playing one team member short for any period of time. iv. Any player directed to leave the field can seek medical attention at any point off the field, however his replacement must enter through the interchange area. v. Field Umpire in control of play shall give the replacement player reasonable time to take up their position prior to play recommencing. vi. When the injured player wishes to resume playing, he must enter through the interchange area (i.e. their playing number may have changed). vii. A player, who refuses to promptly obey a direction of an umpire given in accordance with this policy, shall be reported by the umpire for misconduct in that they refused to leave the field.
<b>1</b> c	Where an umpire is of the opinion that the player is bleeding or has blood on any part of them, the player shall immediately leave the field of play upon direction of the umpire. The player shall not return to take any further part in any match until and unless:  i. The cause of any such bleeding has been abated.  ii. The injury is securely covered to the extent that no blood is visible.  iii. Any bloodstained article of uniform has been removed and replaced.  iv. Any blood on any part of a player's person has been thoroughly cleansed and removed.

#### **POLICY BACKGROUND**

The West Australian Football Commission acknowledges its role in dealing with the issue of infectious diseases in Australian Football. Being in an environment where players are regularly in close contact with others can increase the risk of contracting common illnesses. The WAFC recommends following the below guidelines to prevent the transmission of infectious diseases.

#### **ACCOUNTABILITIES**

1. HYGIENE		
<b>1</b> a	Each club or team must ensure that players do not urinate (other than in a toilet) in or about any dressing rooms or on the Playing Surface prior to, during or immediately following the completion of any match.	
1b	Each club or team must ensure that each of its players observe a high standard of personal hygiene, avoid spitting and wash hands regularly.	
<b>1</b> c	Each club or team must ensure that each of its players avoid sharing personal drink bottles.	

#### 2. BLEEDING & BLOOD BORN INFECTIONS

Please refer to WAFC POL.15J Blood Rule which outline the rules specific to bleeding and blood born infections during matches.

#### 3. CHANGEROOMS

Each club or team must ensure that all change rooms and other areas occupied by the team prior to, during or immediately following the completion of any match are kept clean and that no blood remains on any surface, equipment, hand basin, toilet, shower, bath or other area.

All such surfaces, equipment and areas must be cleansed and disinfected immediately after contact with blood.

Community Football clubs are expected to create and maintain safe environments that are fit for purpose, provide positive experiences and ensure the safety of children.

If a parent, guardian or club official needs to discuss images being recorded due to privacy concerns, the team managers must immediately meet and discuss to ensure the privacy and safety of all participants. Respect should be afforded to all requests to not publish any photos or videos on social media platforms.

Protecting and enhancing our Game Environment will always be a strategic focus for Community Football with ongoing enhancement of a Game Environment Filter (RED FLAG). This will assist in monitoring all football segments, and the standard of the environment and the spirit in which they are played. To this end an online filter has been developed whereby key football stakeholders are able to identify and bring to the attention of governing bodies any undesirable behaviours and actions that may breach any of the True Sport Codes of Conduct or Rule 1 "The Spirit of Junior Football".

#### **RULES**

#### 1. RED FLAG NOTIFICATION

The Red Flag notification is completed online with confidentiality assured within the process. Issues that are flagged that require official intervention will be overseen by the WAFC in consultation with the specific League Officials and WAFC District/Regional Staff. The Red Flag filter will apply to everyone involved in Football from coaches, spectators, and players to volunteers and club administrators.

#### 2. RED FLAG ACCESS

Club Presidents, District Officials, Umpires and WAFC Game Development Staff will have authority to access the filter via a special password and link. Please contact the WAFC to secure your access.

#### **POLICY BACKGROUND**

This policy has been created by the West Australian Football Commission with the aim of providing more players with the opportunity to participate and develop their skills of the game. In a situation where a club has a team with a large squad, excess players may be permitted to another club on a weekly roster to assist teams with limited numbers and increase overall game time for our junior footballers. This policy is only to be applied if a club wishes to share players with other teams to maximise the number of games played throughout the year.

#### **RULES**

1. EST.	ABLISHING A PERMIT ROSTER
	Prior to fixtures being published, the source club must assign each player a rating between 1 - 4
	(1 being the strongest) based on their size, speed and overall ability.  As a guide:
1a	1 – Player who is a member of WAFL Colts, Development Squad or Rogers Cup.
	2 – Player with above average size, speed and/or skill.
	3 – Player with average size, speed and/or skill.
	4 – Player with below average size, speed and/or skill.
1b	Players are to be listed in a cycle of 1 through 4 (i.e. 1, 2, 3, 4, 1, 2, 3, 4 etc) to evenly distribute
10	players among the proposed Type 2 Permit roster based on their rating.
<b>1</b> c	Players to be Type 2 Permitted are to be rotated through the list as per Fig 1.
1d	The proposed roster must be endorsed by both the source and destination club and submitted to the WAFC by the Thursday before Round 1 of the season.
1e	In the case of injuries, illness or absence, the roster will require amendment to ensure each
	player is rotated through the permit process.
2. SUE	MITTING PERMITS
	Only players in excess of the maximum players allowed for the competition, including the
2a	bench, may be permitted to an opposing club. The source club should always have the advantage of a full bench.
2b	Players will be Type 2 Permitted on a Type 2 Local Interchange Permit as per WAFC POL.10D Transfers & Permits.
2c	The Type 2 Permit must be lodged online via Footyweb by the destination club three days prior to match day.
2d	The end date for the Type 2 permit but not go beyond the Monday after the match in which the
	player is rostered to play for the destination club.
3. RES	TRICTIONS
<b>3</b> a	If the destination club has 5 or more WAFL Colts/Development Squad or Rogers Cup players, then no further WAFL Colts/Development Squad or Rogers Cup players will be permitted.
3b	Players are only allowed to play finals matches for their primary club and are prohibited from permitting to opposition clubs under this model.
3c	Players must not be Type 2 Permitted to teams within the same club under this model.

Please note that where mixed year group competitions are played, the competition rules of the lower year group shall be applied.

	<b>iii.</b> The team medical officer/sports trainer must be able to prove, upon request by league officials, suitable proof of qualifications to assess and remove injured players on a stretcher.
	iv. Should a team fail to provide a qualified medical officer/sports trainer, then the opposing teams suitably trained medical
	officer/sports trainer may assume control of injured players for both teams.
	Coaches Box
	v. Only one Medical Officer/Trainer is permitted inside the coaches box.
7f. General	i. A team official under suspension for a breach of the Laws of the Game or the WAFC Rules & Regulations may not play or officiate in any game of Australian Football during the period of suspension. This includes any affiliated senior, junior, WAFL, Country, School or Interstate competition.
	ii. Team Officials are not permitted to make intentional contact with opposition players under any circumstances.
