



## AREA AGREEMENT – PDFNL / GVL

### An agreement between the PICOLA DFNL and GVL

This agreement is signed pursuant to AFL Victoria Country Rules and Regulations pertaining to clearances and permits and in particular clause 2.10 – Area Permits, whereby an interchange of players between clubs of the abovementioned leagues may take place without clearance or permits and is subject to any provisions contact within this agreement.

### PROVIDED HOWEVER:

- (i) That this Agreement is in force for the current season only.
- (ii) That the player(s) concerned are acquainted with AFL Victoria Country regulations 2.1 and 2.5 regarding one day permits to Major Leagues and eight (8) matches.
- (iii) That prior to each match played, the player shall obtain written permission to do so from his parent club. The permit shall be in triplicate similar to a one day permit form and dispersed as required under Regulation 2.1 of the AFL Victoria Country Rules and Regulations.
- (iv) That this agreement cannot be altered unless agreed to by the Area Manager.

### LOCAL CONDITIONS:

#### **1. INTERCHANGE OF PLAYERS**

**PDFNL players are permitted 6 permits to play GVL.**

- Player must **NOT** have previously played Senior, Reserve Grade Football.
- PDFNL players are not permitted to play on a BYE
- PDFNL players are not permitted to play Senior, Reserve or Under 18 grade football.
- PDFNL players are not permitted to play shall more than 20 players, including permit players, appear on the club team-sheet
- Club players must be selected before permit players can receive endorsement to play

**GVL players are permitted 6 permits to play in the PDFNL, H&A THIRDS (U17) and FOURS (U14) grade provided:**

- Player must **NOT** have previously played Senior, Reserve Grade Football
- GVL Players are not permitted to play on a BYE
- GVL Players are not permitted to play shall more than 20 players, including permit players, appear on the PDFNL club team-sheet.
- Club players must be selected before permit players can receive endorsement to play.

#### **2. FINALS PERMITS & ELIGIBILITY**

**NO permits are issued to play finals in either League.**

#### **3. GAMES PER DAY/WEEKEND**

**Players are not permitted to play more than 1 game per week / weekend.**

#### 4. NUMBER OF PERMITS / SUPPLY OF PLAYER LIST

PDFNL Teams are only permitted a TOTAL 4 permit players in any one match.

GVL Teams are only permitted a TOTAL 4 permit players in any one match.

PDFNL shall supply, within 7 days, to GVL a list of GVL players who have played within the PDFNL under this agreement.

GVL shall supply within 7 days, to PDFNL, a list of PDFNL players who have played within the GVL under this agreement.

#### 5. 6 PERMITS AND CLEARANCES

No clearances are permitted if lodged after July 1st.

#### 6. REPORTED PLAYERS

A player playing on permit that is reported shall face the Tribunal of the League of which the offence was committed. Any penalty that is imposed shall apply in all competitions.

#### 7. PERMIT BREACHES

Any breach of Permit arrangements and agreements will be referred to the AFL Victoria Country Rule 1.3 – Penalty for playing ineligible or unregistered players.

**BYE :** Shall the club not be playing on a given weekend, it shall be deemed a bye. This shall include prior or post H&A season, Club fixtured bye or League General bye .

This agreement is valid and will remain current unless endorsed by an AFL Victoria Country Football Development Manager.
