Discussion ensued, It was raised that local games could be played on a Friday nights and Port Augusta Colts also keen to play Under 13's as a curtain raiser. This is to be discussed by PA Colts Committee next week. Port Pirie clubs would also be keen to play Under 15 local matches on a Friday night. Clubs then advised of approximate numbers for respective teams in the competition.

Issues highlighted in Port Pirie were multiple competing sports which has caused issues with player availability. Discussion ensued re actual playing numbers and agreed in principle to a minimum of 14 on needs basis.
