<b>SGL</b>	<p>L Promnitz welcomed all and advised this meeting had been called due to some changes and at the requests of Clubs to revisit Saturday discussion. In reality not a lot has changed. SA Health are not sure as yet what will happen with resumption of play this coming weekend, but presently Clubs can train following existing COVID-Safe protocols.</p> <p>The Board need to address the finals system in conjunction with Clubs and Executive. The existing motion would need to be rescinded.</p> <p>Discussion ensued. West Augusta are not supportive of Grand Final clashing with the AFL Grand Final. South Augusta advised a number of people had expressed concern with the decision. Central Augusta advised decisions by delegates were club based – opportunities for some clubs, while others could loose out.</p> <p>L Promnitz advised that modification to the finals series would be required to maintain the current Grand Final date</p> <p>Solomontown requested to rescind their motion.
