

## LIFE MEMBERSHIPS INFORMATION

- Life members of the Association may be elected at the Annual General Meeting by a 2/3 majority of eligible votes, (Constitution, Refers - Part 12. Patron and Life Members), provided that written notice of nomination for such election shall have been given to the Administrator of the Association at least 1 month prior to the meeting, where the Board to deliberate if nomination successfully meets the criteria prior to the AGM.
  - a) The Board shall present a written report to the Annual General Meeting on the services of any nominee together with its recommendations as to the suitability for the honour.
  - b) Life members shall be granted the privileges of free admission to all functions held by the association and the right to attend and vote at the Annual General Meeting.
  - c) Life members shall be awarded a badge of appropriate design.
- 2) Life Membership nominations shall be restricted to those whose service to Alice Springs Basketball Association has been worthy of the Highest honour, who has rendered <u>outstanding distinctive voluntary service</u>, has <u>demonstrated significant</u>, <u>sustained service</u> of the highest quality. The emphasis should be on the quality of the service and active membership a period of full 10 years active membership is an indicator of a long term commitment and contribution to the Association to the degree that a nominee will have evidenced contribution and involvement for a significant time.

## The following criteria determines "Outstanding Distinctive service" for Life membership Nomination

## Overview

The ASBA Board determines the selection criteria for all Alice Springs Basketball Association Awards. The key criterion for Life Membership is an **outstanding sustained contribution to the development of the sport of basketball** in Alice Springs for the Alice Springs Basketball Association.

## The following Criteria applies:

- Significant contributions while holding positions on the Association Board Member minimum of 3 terms as a Board Representative. (Which represent 60% of Criteria)
- Demonstrated period minimum 10 years active membership. (Which represent 10% of Criteria)
- Volunteer Referee Coordinator, Technical Officials Development Coach, Media, Sports Medicine, volunteer Administrators (Which represent 10% of Criteria)
- ASBA representation as State, Regional, Coach, Manager, Referee and Player (Which represent 10% of Criteria)
- Making significant contributions to the Association the nominee should have actively contributed to the core goals and values of the Association as a member volunteer unpaid. /or as a volunteer role with such service in either role being taken concurrently. (Which represent 10% of Criteria).
- **Note:** Mere long term service or involvement in a basketball club by a nominee without having satisfied the criteria, or having demonstrated outstanding achievement arising from personal initiative or innovation, is not sufficient justification for nomination,. Life Members Hall of Fame is not recognition for service in its own right, or limited achievements, but outstanding achievement for the Alice Springs Basketball Association. Volunteer work with your local club is not sufficient justification for selection.
