**INSTRUCTIONS**

1. There will be 2 lines 15 metres apart, marked across the boundary line at which players can be interchanged. The Steward will be stationed near to the fence between the 2 marked lines which will be situated in a central position of each ground.
2. Each competing team is to provide the Steward with a completed Team Sheet prior to the start of the match and nominate a person or persons who can request a change of reserves.
3. Players eligible to interchange throughout the match must cross the boundary line at the same place within the marked lines, player off first, player on second.
4. Players leaving the arena other than through the marked lines if replaced cannot take further part in the match (see below). In the event of any further player entering the arena other than through the marked lines his club will incur a \$50 fine.
5. If a player become ineligible to further participate in the remainder of a match both stewards are to note the time, circumstances and the player's team and [playing number on the control sheet either in the special comments or in the infringement section. Stewards are to advise the relative Club Official/s and note the time and name of the Official who has been advised on the Stewards Control Sheet. If the ineligible player returns to the playing arena after all the above requirements have been completed, then By-Law 4.2 of the Peel Football and Netball League Inc. Constitution, Rules and Regulations states:  
***Any team that includes an ineligible player, shall automatically lose any match points gained by winning or drawing the game in which such player or players participates. Irrespective of scores in such game the opposing team shall be declared the winner and shall be credited with four (4) premiership points and the offending team shall lose all points scored by it in such game. The team receiving the forfeit shall be debited and credited with the official scores.***
6. Players who are carried from the arena through the marked lines provided the replacement player does not go onto the field until the injured player is over the boundary can participate later if desired. Players who are not returning to participate in the remainder of a match must have their player's numbers recorded with the steward.
7. If a player is badly injured and his team wishes him replaced prior to his being removed from the playing arena, the steward must be notified. The injured player is not permitted to take any further part in the match.
8. Should the steward observe the teams being lined up for the purpose of a count (By-Law 12.2 applies) he should attend to assist the Field Umpire if required.
9. Breaches of any of these Instructions must be noted in the Special Comments sections on the control sheet.
10. **After the match the Steward is to lodge the control sheet with the Field umpire in the umpire's room for dispatch to the Peel Football and Netball League Inc. Office.**
