The first two pages of this 1930s document are, we believe, the summary of the period by Life Member Arthur Charteris.

On the third page is a hand written "table" identifying office holders from the early 1950s, possibly beginning in 1949.

After that follow the original committee documents- commencing in 1939 and ending with the public meeting in February 1934 to reform the Olinda Club.

Of particular interest is the 1938-39 period when Olinda and Monbulk amalgamated.
