6. Correspondence

6.1. WCH – Letter received re APPS

Letter sent to Andrew Buckham asking why the league isn't following the point system. Clubs were asked to provide their position on the APPS rules, only Western Districts and Elliston responded, both responded that they would like for the league to seek exemption from the SACFL from the APPS.

Delegates to take back to clubs to reach a consensus to address the APPS system for next season. Item to be included in AGM agenda.

6.2. MWNA – June meeting minutes

2016 draft program distributed to clubs for feedback.

6.3. SACFL – Match day permits

Memo received SACFL are aware some leagues and clubs using Type 2 Local Interchange permits as a means of creating an alternative to a Type 1 Match Day permit. Type 1 permit is contrary to SACFL regulations and subject to penalties.

6.4. SACFL – Player Payments Regulation 31

Clubs to ensure they read the email and draft regulations. If clubs pay players they need to have a contract.

6.5. SACFL – Information

SACFL Licensed suppliers: Request for tender has closed, evaluations and interviews will occur, successful applicants will be advised by 21 August. Leagues and clubs will be notified after this date. At this stage, leagues and clubs must not negotiate with existing suppliers for any new on field apparel for next year.

Rules & regulations: Steps for seeking decisions on regulations - Clubs must seek clarification from our league first, if additional clarification required, league contacts Regional Football Coordinator (RFC), RFC then speaks with SACFL office.

Regulation 31 Total Player Payments: SACFL providing new regulation information to be provided at league delegate meetings if possible. New regulation comes into effect on 1 November 2015.

Footyweb: Any queries go through HELP line as provided by Footyweb.
