## **AFLNT Conditions of Entry**

- 1. In accordance with the AFL Member Protection Policy (Section 5.2 (b)), the Football Body is responsible for making amendments to By-Laws to ensure that the Member Protection Policy is enforceable.
- 2. These Conditions of Entry set out AFLNT's expectations for any person entering any venue to attend an AFLNT scheduled and/or sanctioned event and should be read in conjunction with the AFL Member Protection Policy. Any person entering any venue to attend an AFLNT scheduled and/or sanctioned event must abide by the following Conditions of Entry:

## 2.1 Category 1 Offence

a. Must not push, hit, strike or threaten another person.

## 2.2 Category 2 Offence

- a. Must not act in a manner that is likely to be prejudicial to the interest of or likely bring disrepute to any of the following;
  - i. Australian Football,
  - ii. The AFL,
- iii. AFLNT, or
- iv. Any Community Football Body affiliated to AFLNT.
- b. Must not verbally abuse or intimidate another person;
- c. Must not create a hostile environment;
- d. Must not act in conflict of Liquor Licensing and/or City Council regulations whilst attending any of the above mentioned venues;
- e. Must not enter the above mentioned venues without paying the required entrance fee.
- Any person found to have breached one or more of the Conditions of Entry may be subject to the following sanctions:
  - 3.1 Breach of Category 1 Offence
    - a. First Offence; Suspended from attending all AFLNT scheduled and/or sanctioned events for a period of fifteen (15) weeks; and
    - b. Second Offence; Permanently suspended from attending all AFLNT scheduled and/or sanctioned events.

## 3.2 Breach of Category 2 Offence

- a. First Offence; Suspended from attending all AFLNT scheduled and/or sanctioned events for a period of three (3) weeks;
- b. Second Offence; Suspended from attending all AFLNT scheduled and/or sanctioned events for a period of fifteen (15) week;
- c. Third Offence; Permanently suspended from attending all AFLNT scheduled and/or sanctioned events.
- The above sanctions are the minimum penalties and the Community Football Body reserves the right to increase any penalty at its absolute discretion.
- Any player or official who incurs a sanction that results in his/her tribunal history exceeding fifteen (15) matches will face deregistration in accordance with the Australian Football Player & Official National Deregistration Policy.
- Any person alleged to have breached one or more of the Conditions of Entry, at the discretion of the Competition Manager, may be:

- 6.1 Subject to a formal investigation in accordance with the National Complaint & Investigation Guidelines; and/or
- 6.2 Formally asked to show cause as to why the above sanctions should not be applied, in which case the person must show cause in writing within 72 hours of notification of the alleged breach or the sanction will be automatically applied; and/or
- 6.3 Issued with a notice to appear before a match or disciplinary tribunal in accordance with the appropriate National Tribunal Guidelines.
- 7 It is not a condition that a complaint be made prior to this document being enforceable.
